BEEKEEPERS ACT 1963**BEEKEEPERS AMENDMENT REGULATIONS (No. 2) 1997**

Made by the Governor in Executive Council.

Citation

1. These regulations may be cited as the *Beekeepers Amendment Regulations (No. 2) 1997*.

Principal regulations

2. In these regulations the *Beekeepers Regulations 1963** are referred to as the principal regulations.

For amendments to 8 October 1997 see 1996 Index to Legislation of Western Australia, Table 4, p. 22, and Gazette 19 August 1997.]

Regulation 10 repealed and a regulation substituted

3. Regulation 10 of the principal regulations is repealed and the following regulation is substituted —

“

Notification by person who ceases to be a beekeeper

10. (1) A person shall, on ceasing to be a beekeeper, notify the Director General that he is no longer a beekeeper and forfeit the brand issued to him.

(2) Notification that a person has ceased to be a beekeeper shall be made in the form of Form 4A in the Second Schedule.

”

1. A person who owns, or has the charge, care or possession of, bees or any hive that contains, or has contained, bees is a "beekeeper", and is required, within 14 days after becoming a "beekeeper", to apply to be registered as such (*Beekeepers Act 1963*, section 8).

2. This form should be completed and sent with the appropriate application/renewal fee to AGRICULTURE WESTERN AUSTRALIA, BARON-HAY COURT, SOUTH PERTH, 6151.

3. On receipt of this completed form and the appropriate application/renewal fee you will be issued with —

- (a) a Certificate of Registration as a beekeeper (if this is an initial registration); or

CONSERVATION AND LAND MANAGEMENT ACT 1984

Conservation and Land Management (appointments of Members to the Lands and Forest Commission) Instrument

Made by His Excellency the Governor in Executive Council.

PART I—Preliminary

Citation

1. This instrument may be cited as the Conservation and Land Management (appointments of members to the Lands and Forest Commission) Instrument.

Definitions

2. In this instrument—

“the Act” means the Conservation and Land Management Act 1984 as amended;

“the Commission” means the Lands and Forest Commission.

PART II—Lands and Forest Commission**Appointment of Members to the Commission**

3. The following persons are appointed on the nomination of the Minister, to be members of the Commission under Section 20(1)(a) of the Act—

(a) Mr Leon Harold Watt of 9 Greenpark Rise, Bibra Lake; and

(b) Mr Patrick John McNamara of 5 College Road, Gooseberry Hill.

Terms of Office

4. The members of the Commission, appointed under Clause 3 of this instrument, shall hold office for a period expiring on 31 October 1999:

Appointment of Chairman and Deputy Chairman

5. Under Section 20(2) of the Act, on the nomination of the Minister—

(a) Leon Harold Watt is appointed chairman of the Commission; and

(b) Patrick John McNamara is appointed deputy chairman of the Commission.

ED401**EDITH COWAN UNIVERSITY ACT 1984****EDITH COWAN UNIVERSITY****Amending Statute No. 2 of 1997**

The following University Statutes are amended:

Statute No. 15 Western Australian Academy of Performing Arts

1 Section 1 is amended by—

(a) deleting, in the definitions of “Board”, “Chairperson”, “Deputy Chairperson”, and “meeting” the words “of Management”.

(b) deleting the definition “ “School” means any one of the School of Dramatic Arts, the Conservatorium of Music, or the School of Visual Arts.”

(c) inserting in the appropriate alphabetical order the definition “ “Director” means the Director of the Western Australian Academy of Performing Arts who shall be appointed in accord with policy prescribed by the Council from time to time.”

(d) inserting in the appropriate alphabetical order the definition “ “Professors” means professors of the University appointed in accord with policy prescribed by the Council from time to time.”

2 Section 4 is amended by deleting the words “of Management” and “the management of”.

3 Section 5 is amended by—

(a) deleting in sub-section (a)(iii) the words “advise the” and inserting in their place the words “make recommendations to the”, and after the word “Academy” inserting the words “and the overall development of the Academy generally”.

(b) deleting in sub-section (a)(iv) the words “, manage”.

(c) replacing the wording in sub-section (b)(i) with the following—

“recruit, select and appoint persons as members of the staff of the Academy, other than the Director and Professors, in accordance with policy as prescribed by the Council from time to time.”

4 Section 6 is amended by replacing the present wording with the following—

“Constitution of the Board

The Board shall consist of—

(a) 1 person, not being an employee of the University, appointed by the Council following consultation with the Board, who shall be the Chairperson.

(b) 3 persons, not being employees of the University, appointed by the Council following consultation with the Chairperson, with experience in the teaching, administration or practice of the performing and visual arts.

(c) 3 persons, not being employees of the University, appointed by the Council, following consultation with the Chairperson, being persons with experience in education, the professions, industry or commerce and such other persons who are representative of the community.

- (d) the Vice-Chancellor.
 - (e) 1 person, being an executive member of the University administration appointed by the Vice-Chancellor.
 - (f) the Director.
 - (g) 1 member of the full time staff of the Academy elected by members of that staff, the manner of election to be in accordance with Statute No. 16 of the Statutes of the University.
 - (h) 1 enrolled student of the Academy elected by enrolled students of the Academy, the manner of election to be in accordance with Statute No. 16 of the Statutes of the University."
- 5 Deleting section 6A.
- 6 Section 7 is amended by replacing the word "may" with the word "shall".
- 7 Section 8 is amended by:
- (a) replacing the present sub-section (a) with the following—
 - "(a) Appointed Members
 - (i) An appointed member of the Board holds office for such period not exceeding 3 years as is specified in the instrument of their appointment.
 - (ii) The Chairperson shall notify the Chancellor of the occurrence of a casual vacancy or the impending expiry of the term of office of an appointed member."
 - (b) deleting sub-section (b).
 - (c) replacing the present sub-section (c) with the following—
 - "(b) Elected Members
 - (i) A member of the Board elected under section 6(g) of this Statute holds office until the 31st day of December of the fourth academic year after the date on which their election takes effect.
 - (ii) A member of the Board elected under section 6(h) of this Statute holds office until the 31st day of December of the academic year following the date on which their election takes effect.
 - (iii) A member referred to in section 6(h) of this Statute is not eligible for re-election more than once."
 - (d) replacing the present sub-section (d) with the following—
 - "(c) A member other than a member referred to in sections 6(a), 6(f) and 6(h) of this Statute is not eligible to be re-appointed on the expiry of a third successive term of office until 12 months have elapsed after such expiry."
 - (e) renumbering sub-section "(e)" sub-section "(d)" and in sub-section (ii) replacing the words "his or her" with "their".
 - (f) renumbering sub-section "(f)" sub-section "(e)"; in the preamble replacing "(b)" with "(d), 6(e), or 6(f)"; in sub-section (ii) replacing "his or her" with "their" and deleting "of the Council"; in sub-sections (iii), (iv), and (vii) replacing "his or her" with "their".
- 8 Section 9 is amended by—
- (a) in sub-section (d) deleting "of the Council".
 - (b) in sub-section (f) replacing "he or she has" with "they have" and replacing "his or her" with "their".
 - (c) in sub-section (g) replacing "his" where it first occurs with "that person's" and where it occurs for the second time with "the Chairperson's or Deputy Chairperson's, as the case may be,".
- 9 Section 10 is amended by, in sub-section (c) deleting "of the Academy".
- 10 Section 11 is deleted.
- Statute No. 16 Election of Academic and Salaried Staff and Enrolled Students to the Board of Management of the Western Australian Academy of Performing Arts*

FT403***FINANCE BROKERS CONTROL ACT 1975**

Section 44(1) and (2)

The Finance Brokers Supervisory Board has fixed the following schedule to be the maximum amounts of remuneration for services rendered by persons carrying on the business of a Finance Broker. The Schedule shall apply in the case of contracts made on or after the date of publication of this notice and replaces the schedule published in the *Government Gazette* on 25 July 1997.

Schedule

1. Application Fee—

- (i) For loans up to \$120 000:
\$135 non refundable for each loan. The application fee is a payment against the eventual brokerage charge.
- (ii) For loans over \$120 000:
Fee established by prior mutual agreement in writing between the client and broker.

2. Inspection Fees—

- (i) Initial Inspection:
Up to 30 Kilometres—\$125, with a maximum \$250 per half day or part thereof.
Over 30 Kilometres—\$250 with a maximum of \$250 per half day or part thereof or \$500 per day.
- (ii) Subsequent Inspections:
 - (a) For progress advances for properties within 30 Kilometres radius—\$125 per inspection with a maximum of \$250 per property.
 - (b) For progress advances for properties beyond 30 Kilometres radius and properties in the course of erection, by negotiation with the client.

3. Brokerage Fees—

Important Note: Conditions of Brokerage Charges:

- (a) Brokerage should NOT be charged by a selling agent where a Contract of Sale or Mortgage to Vendor is arranged. The agent broker may, however, charge on a time basis for consultations and work done (see miscellaneous charges).
- (b) Where the selling agent is also the broker a separate written Loan Application is also required before a charge may be made.
- (c) No brokerage or other fees shall be charged by a Broker in respect of a Building Society loan expressly for the purpose of financing the purchase of the borrower's principal place of residence.
 - (i) Local Money Loans:
 - (a) For loans up to \$25 000—\$500
 - (b) for loans over \$25 000 and not exceeding \$120 000—\$500 plus 2% per \$1000 in excess of \$25 000; and
 - (c) For loans over \$120 000—Fee established by prior mutual agreement in writing between the borrower and the broker.

4. Transfer of Mortgage between Investor Clients—

Brokerage fees as per item 3 plus out of pocket expenses, payable by the transferee.

5. Extension of Mortgages—

50% of brokerage fees as per item 3 inclusive of any reinspection, but revaluations, solicitors costs, stamp duty and registration should be in addition.

6. Finalisation Fee (discharges)—

Flat fee of \$110 to include all services required of a broker, in addition to legal costs, out of pocket expenses and settlement fees.

7. Commission on Interest Collections—**(a) Interest Collections only—**

6% of interest collections inclusive of postage, cheque duty and bank charges.

(b) Total Mortgage Management, including interest collections and supervision of mortgagor's compliance with all mortgage clauses—

8% of interest collections, inclusive of postage, cheque duty and bank charges except where the broker is acting as an agent for an insurance company in which case fee of 5% applies.

8. Miscellaneous Charges—**(a) Production of Title—\$110.****(b) Titles Office Searches—\$35 plus Titles Office fees.****(c) Additional Interest Statements as provided in the Finance Brokers Code of Conduct—\$25 for each statement issued.****(d) Bank cheques—\$15 including costs.****(e) Where no brokerage fees are payable, consultations, advice, investigations and negotiations on finance—\$125 per hour based on the actual time spent.****(f) Disbursements directly and reasonably incurred by the broker in the negotiations relating to a loan or a proposed loan and without limiting the generality of the foregoing would include search fees, production fees, telephone calls, facsimile fees, accommodation expenses, postages and courier service and relevant Government charges.**

The Broker shall at the request of the client produce to the client such evidence of disbursement that the client should reasonably require.

(g) Where a broker is appointed as an agent for the mortgagee under the terms of the mortgage—charge to be negotiated with the mortgagee but not to exceed \$125 per hour or as mutually agreed between the parties.
