All the waters bounded by a line commencing at the intersection of 19° 56.671' south latitude and 117° 20' east longitude and extending north to the intersection of 19° 37.3' south latitude and 117° 20' east longitude; thence in a north easterly direction to the intersection of 19° 18.25' south latitude and 118° 00' east longitude; thence south to intersection of 19° 40' south latitude and 118° 00' east longitude; thence in a south westerly direction to the intersection of 19° 50' south

latitude and 117° 45' east longitude; thence in a west south westerly direction to the commencement point. ”.

#### Commencement

2. This order shall commence operation on 1 January 1998.

#### Interpretation

3. In this order—

“demersal scalefish” means any fish of the Families—

Lutjanidae;  
Lethrinidae;  
Serranidae;  
Nemipteridae;  
Haemulidae;  
Labridae;

“licensed fishing boat” has the same meaning as in the *Fish Resources management Regulations 1995*.

#### Prohibition on fishing for demersal scalefish

4. A person must not fish for demersal scalefish from a licensed fishing boat at any time in the waters bounded by a line commencing at the intersection of 19° 56.671' south latitude and 117° 20' east longitude and extending north to the intersection of 19° 37.3' south latitude and 117° 20' east longitude; thence in a north easterly direction to the intersection of 19° 18.25' south latitude and 118° 00' east longitude; thence south to intersection of 19° 40' south latitude and 118° 00' east longitude; thence in a south westerly direction to the intersection of 19° 50' south latitude and 117° 45' east longitude; thence in a west south westerly direction to the commencement point.

  - (6) If there is any doubt as to whether any land presently proposed to be subdivided or developed is entitled to the concession in relation to public open space referred to in the preceding subclause, the onus of proving the elements of the entitlement to the satisfaction of the Council shall lie upon the person asserting it. If there is any difference or dispute between the Council and a landowner the issue shall be referred to the WA Planning Commission to make a final determination.'

### RIGHTS IN WATER AND IRRIGATION ACT 1914

#### RIGHTS IN WATER AND IRRIGATION EXEMPTION ORDER 1997

Made by the Governor in Executive Council under section 26C (2) of the Act.

#### Citation

1. This order may be cited as the *Rights in Water and Irrigation Exemption Order 1997*.

#### Commencement

2. This order comes into operation on the day of its publication in the *Government Gazette*.

**Exemption**

3. Subject to clause 4, it is declared that sections 26B (3) to 26B (6) of the Act do not apply in relation to any non-artesian well situated, or to be situated, in the areas declared by proclamation under section 26B of the Act and briefly described in the Table to this Order, if that well is used for, or is to be used for, the drawing of water for —

- (a) the domestic or ordinary use of the owner or occupier of the land on which the well is, or is to be, situated and of their respective families or servants; or
- (b) the watering of cattle or other stock,

but for no other purpose.

**Limitation on application of exemption**

4. The exemption in clause 3 only applies if, in respect of the land on which a well is situated, —

- (a) the draw of water is from the water table aquifer;
- (b) the combined total draw within property does not exceed 1 500 kilolitres per annum; and
- (c) the total area of irrigation (if any) does not exceed 0.2 hectares.
