Division 3—Teaching Scholarships

Teaching scholarships

- **307.** (1) The Minister may provide a scholarship to a person to pay for the cost of the person's tertiary study and qualification in -
 - (a) a teaching course of a kind approved by the Minister; or
 - (b) both -
 - (i) a non-teaching degree of a kind which fulfils the prerequisite requirements of admission into a graduate diploma of education course; and
 - (ii) a graduate diploma in education.
- (2) A person who wishes to apply for a teaching scholarship is to do so by completing a form approved for that purpose by the Minister.
- (3) No payment is to be made by the Minister in respect of a person's teaching scholarship unless the person has entered into a written agreement with the Minister in relation to the scholarship.

- 2. amending the Residential Density Code Scheme Map by extending the R30 density code on portion of Lot 2 Albany Highway and portion of Lot 269 Le Grande Avenue, Orana southward as delineated on the Scheme Amendment Map;
- 3. amending the Schedule of Special Sites contained in Appendix II of the Scheme by deleting Condition 1 and replacing it with the following—
 - "1. For that portion of the Special Site developed as a 'Park Home Park' development shall be exclusively for park homes in accordance with the Caravan Park and Camping Act 1995."
- 4. amending the Scheme Maps accordingly.
