## TOWN OF MOSMAN PARK

## Amendment to Parking Facilities Local Laws

The Council of the Town of Mosman Park records having made the following amendments to its local laws relating to parking at a meeting of the council held on February 24th, 1998.

- (1) In these Local Laws the Parking Facilities Local Laws published in the *Government Gazette* on 25th September 1970 as amended from time to time are referred to as the Principal Local Laws.
- (2) The Principal Local Laws are amended by the deletion of the definition "Commercial vehicle" in local law 2 and the insertion of the following definitions—
  - "commercial vehicle" means a vehicle that comes within the description of a motor wagon and an Omnibus as described in the First Schedule to the *Road Traffic Act 1974* provided the motor wagon is licensed to carry or is able to be licensed to carry a load exceeding three (3) tonnes, and an omnibus with a capacity to carry more than fifteen (15) passengers.
  - "heavy goods vehicle" means a vehicle that comes within the description of converter dolly trailer, trailer not attached to a towing vehicle, semi-trailer, tractor (prime-mover type), tractor (other than prime mover type), caravan and caravan (motor propelled), as described in the First Schedule to the *Road Traffic Act 1974*.
  - "industrial vehicle" means a vehicle that comes within the description of fork lift truck, mobile crane, plant trailer, tow motor, tractor plant and tow truck as described in the First Schedule to the *Road Traffic Act 1974*.
- (3) The Principal Local Laws are amended by adding new local laws 39D, 39E, 39F, and 39G as follows—
  - 39D A person shall not park an industrial or heavy goods vehicle on a street verge or road for more than two (2) hours consecutively;
  - 39E A person shall not park an industrial or heavy goods vehicle on a street or road within 20 metres of where that street meets or intersects any other street;
  - 39F A person shall not service or clean an industrial or heavy goods vehicle on a street verge or road;

39G An owner of a vehicle or premises may apply in writing to the Chief Executive Officer for an exemption from the requirements of local law 39A, 39D, 39E or 39F."

- (4) The Principal Local Laws are amended by deleting "to subsection (3) of section 231 of the Local Government Act 1960" in local law 19(1);
- (5) The Principal Local Laws are amended by deleting item number 22 in the Third Schedule and adding new items numbered 22, 23, 24 and 25 as follows—
