EXOTIC DISEASES OF ANIMALS ACT 1993
SECTION 29 — DECLARATION OF INFECTED AREA
INFECTED AREA ORDER

Made by the Minister for Primary Industry under section 29 of the *Exotic Diseases of Animals Act 1993*.

Infected area

As a consequence of an outbreak, or a suspected outbreak, of Chalkbrood disease (*Ascosphaera apis*) within the city of South Perth in the State of Western Australia, the following area of the State is declared to be an Infected Area —

Description of Area

The Apiary site and the Apiary building or buildings at South Perth, under the control of Agriculture Western Australia.

EXOTIC DISEASES OF ANIMALS ACT 1993
SECTION 34 — DECLARATION OF RESTRICTED AREA
RESTRICTED AREA ORDER

Made by the Minister for Primary Industry under section 34 of the *Exotic Diseases of Animals Act 1993*.

Restricted area

1. As a consequence of an outbreak, or a suspected outbreak, of Chalkbrood disease (*Ascosphaera apis*) within the city of South Perth in the State of Western Australia, the following area of the State is declared to be a Restricted Area —

Animals and products, equipment, etc., specified

2. Under section 34 (3) of the Act —
- (a) Honey Bees (species);
 - (b) honey bees (class of animals);
 - (c) honey, pollen and apiary products; and
 - (d) used beekeeping equipment,

are specified as animals and things to, and in relation to, which this order applies.

EXOTIC DISEASES OF ANIMALS ACT 1993
SECTION 40 — DECLARATION OF A CONTROLLED AREA
CONTROLLED AREA ORDER

Made by the Minister for Primary Industry under section 40 of the *Exotic Diseases of Animals Act 1993*.

Commencement

1. This order takes effect on publication in the *Gazette*.

Controlled area

2. The State of Western Australia is declared to be a Controlled Area as a consequence of an outbreak, or a suspected outbreak, of Chalkbrood disease (*Ascosphaera apis*) within the city of South Perth in the State of Western Australia.

Animals and products specified

3. Under section 40 (2) (a) of the Act —

- (a) Honey Bees; and
- (b) honey, pollen and apiary products,

are species of animals and animal products to, and in relation to, which a control order can be made.

Effective until revoked

4. This order continues to have effect until revoked by a notice published in the *Gazette*.

EXOTIC DISEASES OF ANIMALS ACT 1993
SECTION 41 — CERTIFICATION OF AN EXOTIC DISEASE OUTBREAK OR
SUSPECTED DISEASE OUTBREAK
DISEASE CONTROL ORDER

Made by the Minister for Primary Industry under section 41 of the *Exotic Diseases of Animals Act 1993*.

An outbreak, or a suspected outbreak, of Chalkbrood disease (*Ascosphaera apis*) has occurred within the city of South Perth in the State of Western Australia.

For the purposes of the Act, and pursuant to section 4 (2) of the Act, Chalkbrood disease (*Ascosphaera apis*) is declared to be an exotic disease to which the Act applies.
