#### LOCAL GOVERNMENT ACT 1995

#### **CITY OF ALBANY (CREATION) ORDER 1998**

Made by the Governor in Executive Council.

#### Citation

1. This order may be cited as the City of Albany (Creation) Order 1998.

#### Commencement

2. This order comes into operation on 1 July 1998.

#### Districts abolished

3. Under section 2.1 of the Act the districts of Albany (Town) and Albany (Shire) are abolished.

### **District declared**

- **4.** (1) Under section 2.1 of the Act the area described in Schedule 1 is declared to be a district.
- (2) Under sections 2.3 and 2.4 of the Act the district is named Albany and is designated a city.

## Polling day for inaugural election

**5.** Under sections 4.3 and 9.62 of the Act the poll for the inaugural election of members of the council of the City of Albany is to be held on 1 May 1999.

## Method of election of first mayor

**6.** Under section 2.11 of the Act the first mayor of the City of Albany is to be elected by electors of the district of Albany under Part 4 of the Act.

## Commissioners appointed

- **7.** (1) Under sections 2.6 (4) and 2.40 of the Act the following people are appointed to be commissioners of the City of Albany:
  - (a) Kenneth Comninos MICHAEL of 87 Strickland Street, South Perth;
  - (b) William McGOWAN of Brunton, Stirling School Road, South Stirling;
  - (c) Beverley Jean WINTERTON of Lot 21, Swallow Hill Court, Karnup;
  - (d) Reginald Frederick DAWSON of 109A Mary Street, Como; and
  - (e) George Rex EDMONDSON of Cameron Road, Jerramungup.
- (2) Under section 2.40 of the Act Kenneth Comninos MICHAEL is appointed to be the chairperson of the commissioners.
- (3) Under section 2.40 of the Act William McGOWAN is appointed to be the deputy chairperson of the commissioners.

# SCHEDULE 1 — DESCRIPTION OF DISTRICT OF ALBANY

[clause 4]

All that portion of land bounded by lines starting from the intersection of the Low Water Mark of Wilson Inlet with the left bank of the Hay River and extending generally northerly upwards along that bank to intersect with a line joining Survey Post FIV, as shown on Department of Land Administration Original Plan Hay 25, with the southwestern corner of Hay Location 72; thence northerly along that line to the prolongation westerly of the northernmost northern boundary of Location 677; thence easterly to and along that boundary and easterly along the northern boundary of Location 371 and onwards to a northwestern boundary of the western severance of Plantagenet Location 1899; thence generally northerly and easterly along boundaries of that severance and onwards to the northernmost northwestern corner of the eastern severance of the lastmentioned location; thence easterly and southerly along boundaries of that severance to the northern boundary of Location 5081 (Class A Reserve 19673); thence easterly along that boundary and easterly and southerly along boundaries of Location 3542 (Class A Reserve 19673) to a point situate west of the southwestern corner of Location 3361; thence east to that corner; thence northerly along the western boundary of the lastmentioned location and northerly, easterly and southerly along boundaries of Location 3669 to the prolongation easterly of the southern boundary of Location 3361; thence easterly along that prolongation to the western boundary of Location 765; thence northerly and easterly along boundaries of that location and easterly along the northern boundary of Location 2473 to the westernmost southwestern corner of the northwestern severance of Location 3513; thence northerly, easterly and southerly along boundaries of that severance and onwards to and along the eastern boundary of the southeastern severance of the lastmentioned location and again onwards to the northern boundary of Location 521; thence easterly along that boundary to the western boundary of the northern severance of Location 753; thence northerly and easterly along boundaries of that severance and easterly along the northern boundary of late Location 754, as shown on Department of Land Administration Diagram 1120, to its northeastern corner; thence easterly to the southwestern corner of late Location 3531, as shown on Department of Land Administration Diagram A1754; thence easterly along the southern boundary of that late

location and onwards to and along the southern boundary of Location 6751 and again onwards to the southwestern corner of Location 2671; thence easterly and northerly along boundaries of that location to the northwestern corner of Location 2783; thence easterly and southerly along boundaries of that location to the prolongation westerly of the northern boundary of Location 2347; thence easterly to and along that boundary to the westernmost northwestern corner of location 4934; thence southerly, easterly, northerly and again easterly along boundaries of that location to the southwestern corner of Location 4687; thence easterly, northerly and again easterly along boundaries of that location and easterly and northerly along boundaries of location 4461 to the northwestern corner of location 7193; thence easterly along the northern boundary of that location and easterly along the northern boundary of the northwestern severance of Location 5738 to the northernmost northwestern corner of Location 6963 (Reserve 38560); thence easterly along the northern boundary of that location and easterly along the northern boundary of the central severance of Location 5738 and onwards to and along the northern boundary of the southeastern severance of the lastmentioned location to a southwestern side of Albany Highway; thence southeasterly along that side to the prolongation southwesterly of the northwestern boundary of Location 5737; thence northesterly to and northeasterly, southerly and easterly along boundaries of that location and onwards to the southwestern corner of Location 5215; thence easterly along the southern boundary of that location and easterly and southerly along boundaries of Location 5743 to the prolongation westerly of the westernmost southern boundary of Location 6518; thence easterly to and easterly, northerly and again easterly along boundaries of that location and easterly along the southern boundaries of Locations 6519 and 6520 to the western corner of Location 6521; thence southerly, easterly and northerly along boundaries of that location and northerly along the eastern boundary of Location 3780 to its northeastern corner; thence northwesterly to the southwestern corner of Location 3705; thence northerly and northwesterly along sides of Yungup Road to the southern corner of Location 5856; thence northwesterly, generally northerly and easterly along the boundaries of that location to the northwestern corner of the western severance of Location 5855; thence easterly along the northern boundary of that severance and onwards to and along the northern boundary of the northeastern severance of the lastmentioned location to the southwestern corner of Location 5801; thence northerly along the western boundary of that location and northerly along the western boundary of Location 5798 and onwards to the southwestern corner of Location 5793; thence northerly along the western boundary of that location and northerly along the western boundary of Location 5791 to the southwestern corner of Location 5407; thence easterly along the southern boundary of that location and easterly and northerly along boundaries of Lot 21 of Location 5787, as shown on Office of Titles Diagram 91238 to the southwestern corner of Location 5786; thence northerly, easterly and southerly along boundaries of that location to the prolongation westerly of the northern boundary of Location 4725; thence easterly to and along that boundary to the westernmost western boundary of Location 7660 (Class A Reserve 18772); thence northerly along that boundary and northerly along the western boundary of Location 4185 and onwards to the easternmost southern boundary of Location 4870; thence easterly and northerly along the boundaries of that location and northerly along the eastern boundary of Location 4707 and onwards to the southern boundary of Location 2228; thence easterly and northerly along the boundaries of that location and northerly and westerly along boundaries of Location 1146 to the southeastern corner of the eastern severance of Location 6176 (Class A Reserve 1023); thence northerly along the eastern boundary of that severance to the southernmost southwestern corner of Location 5971; thence generally easterly along boundaries of that location to its easternmost southeastern corner, as surveyed on Department of Land Administration Original Plan 6084; thence east to a southeastern side of Takalarup Road; thence generally northeasterly along sides of that road to the southwestern corner of Location 5972; thence generally northeasterly along boundaries of that location, as surveyed on Department of Land Administration Original Plan 6084, to the westernmost northwestern corner of Location 4966; thence northeasterly and easterly along boundaries of that location to the southwestern corner of the southern severance of Location 5642; thence northerly along the western boundary of that severance and onwards to the southwestern corner of the northwestern severance of the lastmentioned location; thence northerly and easterly along boundaries of that severance and onwards to and along the northern boundary of Location 1610 and again onwards to the left bank of the Kalgan River; thence generally northeasterly upwards along that bank to the prolongation westerly of the westernmost southern boundary of the southern severance of location 5874; thence easterly to and easterly, southerly, again easterly and again southerly along boundaries of that severance to the northernmost northwestern corner of the western severance of location 5949; thence easterly and southerly along boundaries of that severance to the prolongation westerly of the northern boundary of Location 5950; thence easterly to and along that boundary and easterly along the northern boundary of Location 5951 and onwards to the southwestern corner of the southern severance of Location 5945; thence easterly and northerly along boundaries of that severance and onwards to the southern boundary of the northern severance of the lastmentioned location; thence easterly and generally northerly along boundaries of that severance and northerly along the eastern boundaries of Locations 5669 and 5667 and onwards to a northern side of Chillinup Road; thence easterly and generally northeasterly along sides of that road to the southwestern corner of Location 6548; thence northerly and easterly along boundaries of that location to the prolongation southerly of the northernmost eastern boundary of Location 5680; thence northerly along that prolongation to a southwestern corner of Class A Reserve 14792; thence easterly and generally northeasterly along boundaries of that reserve to the southwestern corner of Location 2585 (Class A Reserve 14792); thence easterly along the southern boundary

of that location and onwards to the western boundary of location 6241; thence northerly and northeasterly along boundaries of that location to the prolongation southerly of the eastern boundary of Location 7733 (Reserve 1090); thence northerly to and along that boundary to the northeastern corner of that location; thence northeasterly along a line joining the lastmentioned corner with the intersection of a line passing through Peak Barnett, Warrungup Hill and Ellen Peak and the prolongation southerly of the western boundary of Kent Location 713 to the western boundary of Plantagenet Location 6212; thence northerly along that boundary to the prolongation southeasterly of the southwestern boundary of Location 6210; thence northwesterly to and northwesterly and generally northeasterly along boundaries of that location and onwards to a northeastern side of Gnowellen Road; thence generally northwesterly along sides of that road to the southern boundary of Location 3347; thence easterly and northerly along boundaries of that location to the southwestern corner of the southern severance of Location 3346; thence northerly, easterly and again northerly along boundaries of that severance and onwards to and along the western boundary of the northern severance of the lastmentioned location and again onwards to the centreline of the Pallinup River; thence generally southeasterly downwards along that centreline to the southern boundary of Kent Location 2049 (Reserve 22353); thence westerly along that boundary to the right bank of the Pallinup River; thence generally southeasterly downwards along that bank to the low water mark of Beaufort Inlet; thence generally southeasterly along that low water mark to the low water mark of the Southern Ocean; thence generally southwesterly and generally westerly along that low water mark to the low water mark of Wilson Inlet and thence generally northeasterly along that low water mark to the starting point.

Including all islands adjacent.

Note: The land described is shown on Department of Land Administration Public Plans Denmark SE and NE (25), Redmond NW and NE (25), Oyster Harbour NW and NE (25), Porongurup SE (25), Noorubup SW, SE and NE (25), Green Range NW (25), Ellen Peak SW, SE and NE (25), Pallinup (50) and Mount Groper (50).
