"the waters of the Ashburton River" means the waters of the Ashburton River, the waters of all of its tributaries and the waters north of the state between 114° 54.54´ east longitude and 114° 55.50´ east longitude within 800 metres of the high water mark.

Prohibition on fishing by nets

- 3. (1) A person must not fish for a commercial purpose by means of a net in the waters of the Ashburton River.
- (2) A person must not fish for a non-commercial purpose by means of a net, other than a throw net or drop net, in the waters of the Ashburton River.
