1.0 PLAN OF SUBDIVISION

1.1 Subdivision of Special Rural Zone Area No. 17 shall be generally in accordance with the Subdivision Guide Plan endorsed by the Chief Executive Officer.

1.2 Council will not recommend lot sizes less than 2.0 hectares however Council may recommend that the Western Australian Planning Commission approve minor variations to the Subdivision Guide Plan.

2.0 OBJECTIVES OF THE ZONE

2.1 Within Special Rural Zone Area No. 17 the objective is to create functional hobby farm blocks in close proximity to urban services and facilities with appropriate controls so as to ensure any potential off site impacts are minimised and so as to ensure the small rural lot landscape of the area is maintained.

3.0 LAND USE

3.1 Within Special Rural Area No. 17 the following uses are permitted—

- Residential Dwelling House

3.2 The following uses may be permitted subject to the special approval of Council—

- Home Occupation
- Stables
- Public Utility
- Cottage Industry
- Rural Use—

for the purpose of Special Rural Zone Area No. 17, "Rural Use" means the use of land for any of the purposes set out hereunder, subject to Provisions 4.0, 5.0 & 6.0, and shall include such building normally associated therewith—

- The growing of vegetables, fruit, cut fresh flowers, cereals or food crops on a maximum cultivated area of 5 000m²;
- The rearing or agistment of goats, sheep, cattle or beasts of burden;
- The breeding and raising of freshwater fish and crustaceans (aquaculture);
- The outdoor growing of trees, plants, shrubs or flowers for replanting in domestic, commercial or individual gardens on a maximum cultivated area of 5 000m²;
- Free-range poultry farming;
- Low key tourist uses and accommodation with a maximum of three (3) chalets (except for lots 19, 20, 21, 22, 23 & 24 as shown on the Subdivision Guide Plan where this use is not permitted)
- The wholesale marketing of produce grown solely on the lot;

- The cultivation of wildflowers; and
- Firewood production.

Other incidental or non-defined activities considered appropriate by Council which are consistent with the objective of the zone.

4.0 KEEPING OF LIVESTOCK/ANIMALS, HORTICULTURE & RURAL USES

4.1 The keeping of livestock shall be restricted to fenced pastured areas of the lot. The owner shall be responsible for the maintenance of stock proof fencing to protect remnant vegetation and revegetation areas. Animal numbers shall not exceed the stocking rates recommended by Agriculture W.A. The keeping of animals shall not result in the removal or damage of vegetation and trees or result in soil degradation and dust nuisance.

4.2 Applications for Planning Scheme Consent for uses listed in section 3.2 above shall demonstrate that there will be no off site impact in relation to dust, noise, smell or pollution of waterways. Where appropriate, the approval of such uses shall have regard to the Codes of Practice prepared by the Department for Environmental Protection and/or Agriculture Western Australia.

4.3 Where in the opinion of Council the continued presence of animals or the continuation of a horticulture or rural use on any portion of land is likely to contribute, or is contributing to the destruction of remnant vegetation and/or revegetation, dust nuisance, soil degradation or water pollution, notice may be served on the owner of the land, requiring immediate removal of those animals or discontinuance of the rural use as specified in the notice.

4.4 Where notice has been served on a landowner in accordance with Provision 4.2, Council may also require the vegetation, land or water to be made good to Council's satisfaction within three (3) months of serving the notice.

4.5 In the event that such action is not undertaken, Council may carry out such works as are deemed necessary, with all costs being borne by the landowner.

5.0 LOCATION OF BUILDINGS AND STRUCTURES

5.1 Buildings, tanks and structures shall not be constructed within the Development Exclusion Area designated of the subdivision Guide Plan.

5.2 Buildings and structures shall be setback a minimum of 30 metres from the proposed 10 metre wide road widening requirement adjacent and parallel to Elizabeth Street and 10 metres from all other lot boundaries unless Council approves a lesser distance; that is, if Council is of the opinion that—

- (i) the topography or shape of the lot, or natural vegetation on it, makes it desirable to alter this provision; and
- (ii) that the location of the building or structure will not detract from the rural landscape quality of the area or from the amenity of existing or future residences on adjoining lots.

5.3 Buildings shall be sited to allow a "low fuel buffer" not less than twenty (20) metres wide, which does not encroach into tree/shrub planting designated on the Subdivision Guide Plan.

5.4 All dams require the approval of Council prior to construction. Dams shall be sited to avoid visual impact from Elizabeth Street and Chester Pass Road, to the satisfaction of Council.

6.0 BUILDING DESIGN, MATERIALS & COLOUR

6.1 Dwellings and outbuildings shall be designed and constructed of materials, which allow them to blend into the landscape of the site. Council will be supportive of walls and roofs with natural tonings in keeping with the amenity of the area, however Council shall refuse to approve walls and roofs constructed of reflective materials such as unpainted zincalume and off-white colours.

6.2 Dwelling houses shall not exceed 7.5 metres in height, which is measured vertically from the natural ground level. The maximum height of all outbuildings will be at the discretion of Council in order to minimise the visual impact of such buildings when viewed from Elizabeth Street and Chester Pass Road and from within the subdivision.

6.3 No boundary fencing shall be constructed of fibre cement, metal sheeting or wooden picket. Where boundary fencing is utilised, it shall be of rural construction such as post and strand to the satisfaction of Council.

6.4 Water tanks shall be coloured an appropriate natural shade of brown or green and/or suitably screened with vegetation in keeping with the amenity of the area to the satisfaction of Council.

7.0 VEGETATION, TREE/SHRUB PLANTING & REHABILITATION

7.1 No clearing of vegetation shall occur except for—

- (a) clearing to comply with the requirements of the Bush Fires Act 1954 (as amended);
- (b) clearing may reasonably be required to construct an approved building and curtilage;
- (c) trees that are dead, diseased or dangerous;
- (d) clearing to gain vehicular access to an approved dwelling or any other clearing which may be approved by the Council;
- (e) clearing required to establish a low fuel buffer; and
- (f) clearing cannot occur in designated Vegetation Protection Areas as delineated on the Subdivision Guide Plan.

7.2 Council will require tree/shrub planting in Vegetation Protection Areas. Council may request the Commission to impose a condition at the time of subdivision for tree/shrub planting in areas shown on the Subdivision Guide Plan utilising endemic native species in planting areas. Such planting shall be three tiered with tall trees (>10m at maturity), supported by medium trees and shrubs. All tree/shrub

planting shall be appropriately maintained for a minimum of 3 years. As an alternative, Council may be willing to accept a bonding guarantee for abovementioned works or a combination of planting as a condition of subdivision and a bonding guarantee.

7.3 Council may request the Commission to impose a condition at the time of subdivision for the fencing of remnant vegetation and areas of tree/shrub planting as shown on the Subdivision Guide Plan.

7.4 Additional tree planting may be required as a condition of development approval.

7.5 Council may request the Commission to impose a condition at the time of subdivision for rehabilitation works to be carried out on the northern portions of Lots 1, 2, 3 & 4 as shown on the Subdivision Guide Plan.

8.0 WATER SUPPLY

8.1 Council may request the Commission to impose a condition at the time of subdivision for the provision of reticulated water to the lots.

9.0 EFFLUENT DISPOSAL

9.1 On-site effluent disposal shall be the responsibility of the individual landowner.

9.2 All lots shall utilise an amended soil or similar alternative type of effluent disposal system for the retention of nutrients

9.3 Notwithstanding the general intent of Provision 9.2 and subject to detailed on-site testing at the applications cost, a conventional effluent disposal system can only be considered by Council where environmental and health requirements can be adequately addressed to the satisfaction of Council.

9.4 No more than one effluent disposal system will be permitted per lot.

Lots 20 and 21 of Wellington Location 3168 Southern Estuary Road, Waroona	(i) Development shall be consistent with the objective of maintaining and enhancing the visual amenity of the land and maintaining use, development and management of the land which is compatible with the natural environment. (ii) Subdivision of the land shall be generally in accordance with the Subdivision and Development Guide Plan which forms part of the Scheme, or any variation approved by the Commission. (iii) Council shall adopt a Bush Fires Management Plan for the subject land which shall be prepared in consultation with the Bush Fires Service of Western Australia. Council may amend the plan where it considers this to be necessary. All owners of affected lots shall manage their properties in accordance with the plan. Development which would conflict with, or impede bush fire management in accordance with the plan shall not be permitted or undertaken. (iv) Within the Conservation Area shown on the Subdivision and Development Guide Plan, no clearing of native vegetation shall be permitted or undertaken, excepting where the clearing occurs within a building envelope or is necessary for the provision of a road pavement, driveway access, essential services, firebreaks required by law or to remove vegetation which is dead, diseased or dangerous. No livestock shall be permitted within the Conservation Area. (v) The subdivider is to undertake a revegetation program on areas designated on a guideline plan for "replanting" and maintain such area in accordance with 4.15.6(e). (vi) A maximum of 2000m ² building and development envelope area shall be permitted but this area may be split between a residential building site and an area for keeping of animals or domestic gardening subject to specific Council approval. (vii) Use of zincalume or white cladding material on buildings in exposed elevated positions shall be prohibited. (viii) Conventional on-site effluent disposal systems shall not be permitted on Bassendean soils and only Health Department of WA approved aerobic treatment units or other modified systems using amended soil to attenuate nutrients may be used.

(ix) Where permitted, the number of livestock shall be consistent with Agriculture Western Australia guidelines with numbers calculated according to the area of land not subject to clearing restrictions. Where Council considers that the keeping of livestock is detrimental to the condition of the land or its vegetation, Council may require removal of livestock and may impose restrictions on the keeping of livestock at its discretion.

(x) Stock shall only be allowed in the area of the lots between the building envelopes and the edge of the lot as an occasional fire control measure on those lots already parkland cleared (ie tree canopy intact but understorey largely cleared).

(xi) The sites have been identified by the Bush Fires Board as being within a High Risk Bush Fire Prone Environment and dwellings will have to comply with the Building Code of Australia AS3959 1991 and draft SAA HB 36 1993 (or subsequent amendments) to satisfaction of Council.
