Wildlife Conservation Act 1950

**Wildlife Conservation (Exemption from  
Payment of Royalty) Notice 1998**

Made by the Minister for the Environment under section 18(1)(b) of the Act.

**1. Citation**

This notice may be cited as the *Wildlife Conservation (Exemption from Payment of Royalty) Notice 1998*.

**2. Exemption from payment of royalty**

- (1) The skins of the fauna mentioned in the table to this subclause are exempt from the payment of royalty by the persons specified in clause 3.

## Table

Freshwater crocodiles (*Crocodylus johnstoni*)Saltwater crocodiles (*Crocodylus porosus*)

- (2) The exemption given by subclause (1) applies to skins taken from any part of the State.

**3. Specified persons**

A specified person is a person —

- (a) who holds a licence issued under regulation 7 of the *Wildlife Conservation Regulations 1970* that authorizes the person to process the carcasses of the fauna mentioned in the table to clause 2(1); or
- (b) who holds a fauna farm licence issued under regulation 14 of those regulations that authorizes the person to farm and breed the fauna mentioned in that table for sale or commercial display.

**4. Period of exemption**

The exemption from the payment of royalty given by clause 2(1) expires on 31 December 1998.
