# Mental Health (Authorization of Public Hospitals) Order 1998

Made by the Lieutenant-Governor and deputy of the Governor in Executive Council under section 21 of the *Mental Health Act 1996* and the *Interpretation Act 1984*.

#### 1. Citation

This order may be cited as the *Mental Health (Authorization of Public Hospitals) Order 1998*.

## 2. Authorization of hospitals

- (1) The public hospital or part of a public hospital listed in Schedule 1 marked on the plan specified opposite that hospital or part of a hospital in that Schedule is authorized for
  - (a) the reception of persons; and
  - (b) the admission of persons as involuntary patients, under the Act.
- (2) In this clause —

**"plan"** means a plan the original of which is held in the offices of the Chief Psychiatrist at the Health Department of Western Australia in Perth;

"the Act" means the Mental Health Act 1996.

## 3. Repeal of Orders

- (1) The Mental Health (Authorization of Hospitals) Order 1998 is repealed.

ORDER TO EXCISE A PORTION OF STATE FOREST No. 22

Made by His Excellency the Governor under Section 9(2).

Whereas both Houses of Parliament passed a resolution that a proposal from His Excellency the Governor dated the Nineteenth day of June 1995, for the partial revocation of State forest Nos. 20, 22 and 65, should be carried out. Now, His Excellency the Governor, with the advice and consent of the Executive Council, declares that the dedication of Crown land as State forest No. 22 is partially revoked by excision of the area described in the schedule.

- 7. Pursuant to section 340BC(1) of the Act, each of the persons named in column 3 of table 2 are appointed as deputies to act in the place of the provisional members specified in column 1 of table 2 adjacent to the name of that person.

#### Terms of Appointment

8. The Chair of the Committee is to be appointed for a period of four years and the permanent and provisional members for a period of three years, commencing on the date specified in Column 4 of the Schedule adjacent to the name of that person.

9. Pursuant to section 340BJ(1) of the Act, Dr Colin Crichton Pope Eagle is appointed as an investigator to the Committee, commencing on the 20 November 1997 and ending 20 November 2000.

Pursuant to section 340BJ(3) of the Act, Dr Paul John Rodoreda is appointed to act as Investigator during the absence of the person appointed by clause 7 of this instrument, or where through any cause that person is unable to perform the functions of his office, or during any vacancy in that office, commencing on 20 November 1997 and ending 20 November 2000.






