Conservation and Land Management Act 1984

# Shark Bay Marine Park (Classified Waters) Notice 1999

Made by the Minister under section 62(la) of the Act, having taken the submission of the Marine Parks and Reserves Authority into account under section 62(1c) of the Act and having received the concurrence of the Minister for Fisheries and the Minister for Mines under section 62(3)(c) of the Act.

# 1. Citation

This notice may be cited as the *Shark Bay Marine Park* (*Classified Waters*) Notice 1999.

# 2. Interpretation

In this notice —

- "approved management plan" means the management plan for the Shark Bay Marine Park, entitled Shark Bay Marine Reserves Management Plan 1996-2006, approved by the Minister under section 60 of the Act as notified in the *Gazette* on 7 March 1997 at p. 1403;
- "high water mark" means that part of the high water mark that is a boundary of the Shark Bay Marine Park;
- **"Shark Bay Marine Park"** means all Western Australian waters reserved as Marine Reserve No. 7 under section 13 of the Act by an Order in Council published in the *Gazette* on 30 November 1990 at p. 5898.

# **3.** Classification of sanctuary areas

Waters of the Shark Bay Marine Park referred to in an item in Schedule 1 are classified under section 62(la)(c) of the Act as a sanctuary area.

# 4. Classification of recreation areas

Waters of the Shark Bay Marine Park referred to in an item in Schedule 2 are classified under section 62(la)(a) of the Act as a recreation area for the purposes set out in that item.

# 5. Classification of special purpose areas

Waters of the Shark Bay Marine Park referred to in an item in Schedule 3 are classified under section 62(la)(d) of the Act as a special purpose area for the purposes set out in that item.

# 6. Classification of a general use area

All waters of the Shark Bay Marine Park, other than the waters classified under clauses 3, 4, and 5, are classified under section 62(la)(b) of the Act as a general use area.

# 7. Declaration of activities incompatible with conservation purposes of a special purpose area

For the purposes of section 13B(5)(c), (6)(c), (7)(c), and (8)(c) of the Act, the activities referred to in Table 2 of the approved management plan which are designated as activities which are not permitted in a special purpose zone are declared incompatible with the conservation purposes described in the approved management plan for the special purpose zones classified as special purpose areas under clause 5 and referred to in Schedule 3.

# 8. Declaration of activities incompatible with recreational purposes of a recreation area

For the purposes of section 13B(7)(b) of the Act, the recreational fishing activities referred to in Table 1 of the approved management plan which are designated as activities which are not permitted in a recreation zone or part of a recreation zone are declared incompatible with another recreation purpose described in the approved management plan for the recreational zones classified as a recreational area under clause 4 and referred to in Schedule 2.

# 9. Revocation

The Shark Bay Marine Park (Classified Waters) Notice 1993, published in the Gazette of 22 January 1993 at p. 761, is revoked.

# Schedule 1 — Sanctuary Areas

[cl. 3]

# 1. Disappointment Reach Sanctuary Area

All waters of the Shark Bay Marine Park bounded by a line commencing at the intersection of  $25^{\circ} 38' 00''$  south latitude and  $113^{\circ} 53' 04''$  east longitude and extending —

southerly to the intersection of  $25^{\circ} 46' 00''$  south latitude and  $113^{\circ} 58' 16''$  east longitude,

then easterly to the intersection of  $25^{\circ} 46' 00''$  osouth latitude and the high water mark of Disappointment Reach in the Shark Bay Marine Park,

then generally northerly along the high water mark to its intersection with  $25^{\circ} 38' 00''$  south latitude,

then westerly to the starting point.

# 2. Lharidon Bight Sanctuary Area

All waters of the Shark Bay Marine Park bounded by a line commencing at the intersection of  $26^{\circ}$  10' 00" south latitude and  $113^{\circ}$  42' 55" east longitude and extending —

north-easterly to the intersection of  $26^{\circ} 08' 25''$  south latitude and  $113^{\circ} 50' 00''$  east longitude,

then generally southerly and then generally northerly along the high water mark of Lharidon Bight in the Shark Bay Marine Park to its intersection with the starting point.

## 3. Gudrun Wreck Sanctuary Area

All waters of the Shark Bay Marine Park bounded by a line at a 0.5 nautical mile radius from the intersection of  $25^{\circ} 25' 30''$  south latitude and  $113^{\circ} 31' 31''$  east longitude.

# 4. Big Lagoon Sanctuary Area

All waters of the Shark Bay Marine Park bounded by a line commencing at the intersection of  $25^{\circ} 46' 00''$  south latitude and  $113^{\circ} 27' 10''$  east longitude and extending —

easterly to the intersection of  $25^{\circ} 46' 10''$  south latitude and  $113^{\circ} 28' 00''$  east longitude,

then generally northerly and then generally southerly along the high water mark of Big Lagoon in the Shark Bay Marine Park to its intersection with the starting point.

# 5. Eighteen Mile Sanctuary Area

All waters of the Shark Bay Marine Park bounded by a line commencing at the intersection of the high water mark of the Henri Freycinet Harbour in the Shark Bay Marine Park and 26° 26' 00" south latitude and extending —

generally southerly along the high water mark to its intersection with  $26^{\circ} 32' 00''$  south latitude,

then westerly to a point along  $26^{\circ} 32' 00''$  south latitude that is one nautical mile from the high water mark,

then northerly to a point along  $26^{\circ} 26' 00''$  south latitude that is one nautical mile westerly of the starting point,

then easterly to the starting point.

# 6. Mary Anne Island Sanctuary Area

All waters of the Shark Bay Marine Park included in an area bounded by a line along the high water mark of Mary Anne Island in the Shark Bay Marine Park and a line 0.5 nautical miles seaward of the high water mark of Mary Anne Island.

# 7. Sandy Point Sanctuary Area

All waters of the Shark Bay Marine Park bounded by a line at a 2.5 nautical mile radius from Sandy Point, other than those waters within that radial line which are between the high water mark and 0.5 nautical miles seaward of the high water mark.

## 8. Surf Point Sanctuary Area

All waters of the Shark Bay Marine Park bounded by a line commencing at the high water mark at Surf Point in the Shark Bay Marine Park and extending —

south-westerly about 0.5 nautical miles along the boundary of the Shark Bay Marine Park to the intersection of  $26^{\circ} 07' 48''$  south latitude and  $113^{\circ} 10' 25''$  east longitude,

then easterly to the intersection of  $26^{\circ} 07' 55''$  south latitude and  $113^{\circ} 12' 10''$  east longitude,

then generally northerly and then generally southerly along the high water mark to the starting point.

# Schedule 2 — Recreation Areas

[cl. 4]

## 1. Monkey Mia Recreation Area

#### Area

All waters of the Shark Bay Marine Park bounded by a line commencing at the intersection of the high water mark west of the jetty at Monkey Mia in Red Cliff Bay in the Shark Bay Marine Park and a line at an 800 metre radius from the north-west corner of the jetty at Monkey Mia and extending —

generally northerly and then generally southerly along that radial line to its intersection with the high water mark at Eastern Bluff,

then generally northerly and then generally westerly along the high water mark to the starting point.

## Purpose

To provide for a wide variety of recreational uses compatible with the protection of dolphins and the maintenance of the dolphin interaction experience in accordance with the approved management plan.

# 2. Little Lagoon Recreation Area

### <u>Area</u>

All waters of the Shark Bay Marine Park bounded by a line commencing at the southern extremity of the mouth of Little Lagoon in the Shark Bay Marine Park and extending —

generally easterly and then generally northerly and then generally westerly along the high water mark of Little Lagoon to the northern extremity of the mouth of Little Lagoon,

then generally northerly along the high water mark towards Lagoon Point to the intersection of the high water mark and a line at a 275 metre radius from the central point of the mouth of Little Lagoon, then generally southerly along that radial line to its intersection with the high water mark,

then generally northerly along the high water mark to the starting point.

Purpose

To provide recreational opportunities compatible with the maintenance of the fish nursery values in accordance with the approved management plan.

#### 3. Dubaut Inlet Recreation Area

Area

All waters of the Shark Bay Marine Park bounded by a line commencing at the intersection of 113° 43′ 25″ east longitude and the high water mark at the northern extremity of the mouth of Dubaut Inlet in the Shark Bay Marine Park and extending —

generally southerly and then generally easterly and then generally northerly along the high water mark of Dubaut Inlet to the intersection of the high water mark at the southern extremity of the mouth of Dubaut Inlet and  $113^{\circ} 43' 25''$  east longitude,

then northerly along 113° 43' 25" east longitude to the starting point.

Purpose

To protect nursery habitat and local fish stocks in accordance with the approved management plan.

# Schedule 3 — Special Purpose Areas

[cl. 5]

#### 1. Cape Peron Special Purpose Area

Area

All waters of the Shark Bay Marine Park bounded by a line commencing at the intersection of the high water mark in Herald Bight in the Shark Bay Marine Park and 25° 30' 55" south latitude and extending —

easterly to the intersection of  $25^{\circ} 30' 55''$  south latitude and  $113^{\circ} 31' 33''$  east longitude,

then northerly to the intersection of  $25^{\circ} 29' 47''$  south latitude and  $113^{\circ} 31' 33''$  east longitude,

then westerly to the intersection of  $25^{\circ} 29' 47''$  south latitude and  $113^{\circ} 29' 54''$  east longitude,

then southerly to the intersection of  $113^{\circ} 29' 54''$  east longitude and the high water mark in Broadhurst Bight,

then generally northerly along the high water mark to Cape Peron North,

then generally southerly along the high water mark to the starting point.

#### Purpose

To provide marine wildlife viewing opportunities for visitors to the Cape and to preserve the biological components and diversity of this productive area in accordance with the approved management plan.

## 2. Wooramel Special Purpose Area

Area

All waters of the Shark Bay Marine Park bounded by a line commencing at the intersection of the high water mark of the Shark Bay Marine Park and the westerly prolongation of the southern boundary of Gascoyne location 343 and extending —

westerly along the northern boundary of the Shark Bay Marine Park to a point 6 nautical miles from the starting point,

then generally southerly at a distance of about 6 nautical miles seaward of the high water mark to the intersection of  $25^{\circ} 13' 00''$  south latitude and  $113^{\circ} 41' 00''$  east longitude,

then generally southerly at a distance of about 8 nautical miles seaward of the high water mark to  $25^{\circ} 27' 30''$  south latitude,

then generally southerly at a distance of about 8 nautical miles seaward of the high water mark to the intersection of  $25^{\circ} 38' 00''$  south latitude and  $113^{\circ} 53' 04''$  east longitude,

then easterly along  $25^{\circ}$  38' 00" south latitude to its intersection with the high water mark,

then generally northerly along the high water mark to the starting point.

Purpose

To conserve the Wooramel seagrass bank in accordance with the approved management plan.

# 3. Gladstone Special Purpose Area

Area

All waters of the Shark Bay Marine Park bounded by a line commencing at the intersection of  $25^{\circ} 50' 37''$  south latitude and  $114^{\circ} 08' 39''$  east longitude and extending —

southerly to the intersection of  $25^{\circ} 59' 00''$  south latitude and  $114^{\circ} 08' 39''$  east longitude,

then easterly along  $25^{\circ} 59' 00''$  south latitude to its intersection with the high water mark,

then generally northerly along the high water mark to its intersection with  $25^{\circ} 50' 37''$  south latitude,

then westerly along  $25^{\circ} 50' 37''$  south latitude to the starting point,

other than the waters that are bounded by a line commencing at the intersection of the high water mark and  $25^{\circ} 55' 57''$  south latitude and extending —

westerly along  $25^{\circ} 55' 57''$  south latitude to a point about 0.25 nautical miles seaward of the starting point,

then generally southerly at a distance of about 0.25 nautical miles seaward of the high water mark to  $25^{\circ} 57' 14''$  south latitude,

then easterly to the intersection of  $25^{\circ}$  57' 14" south latitude and the high water mark,

then generally northerly along the high water mark to the starting point.

#### Purpose

To conserve important dugong habitat and protect dugongs from disturbance while allowing compatible uses to continue in accordance with the approved management plan.

#### 4. Big Lagoon Special Purpose Area

<u>Area</u>

All waters of the Shark Bay Marine Park bounded by a line commencing at the intersection of  $25^{\circ} 46' 48''$  south latitude and  $113^{\circ} 26' 31''$  east longitude and extending —

easterly along  $25^{\circ} 46' 48''$  south latitude to its intersection with the high water mark,

then generally southerly and then generally northerly along the high water mark to its intersection with  $25^{\circ} 46' 00''$  south latitude and  $113^{\circ} 27' 10''$  east longitude,

then easterly to the intersection of  $25^{\circ} 46' 10''$  south latitude and  $113^{\circ} 28' 00''$  east longitude,

then generally southerly along the high water mark to its intersection with  $25^{\circ} 48' 37''$  south latitude,

then westerly to the intersection of  $25^{\circ}$  48' 37" south latitude and  $113^{\circ} 26' 31"$  east longitude,

then northerly to the starting point.

Purpose

To protect seagrass and mangrove habitat important as a fish nursery and to provide for recreational and commercial opportunities compatible with this protection in accordance with the approved management plan.

## Boorabuggatta Special Purpose Area

Area

5.

All waters of the Shark Bay Marine Park bounded by a line commencing at the intersection of 26° 29′ 30″ south latitude and the high water mark at the north-western extremity of the mouth of Boorabuggatta Inlet in the Shark Bay Marine Park and extending —

generally southerly and then generally northerly along the high water mark of Boorabuggatta Inlet to the intersection of the high water mark at the north-eastern extremity of the mouth of Boorabugatta Inlet and  $26^{\circ}$  29' 30" south latitude,

then westerly along 26° 29' 30" south latitude to the starting point.

#### Purpose

To protect fish stocks using the area for nursery purposes from over exploitation in accordance with the approved management plan.

## 6. Freycinet Special Purpose Area

Area

All waters of the Shark Bay Marine Park, excluding the waters of the Mary Anne Sanctuary Zone, bounded by a line commencing at the high water mark on the northern extremity of Giraud Point and extending —

to the high water mark on the northern extremity of Mary Anne Island,

then to the intersection of the high water mark on the north-eastern extremity of Salutation Island and  $26^{\circ} 32' 00''$  south latitude,

then easterly along  $26^{\circ} 32' 00''$  south latitude to its intersection with the high water mark of Henri Freycinet Harbour in the Shark Bay Marine Park,

then generally southerly, generally westerly and generally northerly along the high water mark to the starting point.

Purpose

To provide protection for important seagrass habitat and for dugongs in the summer months in accordance with the approved management plan.

## HEALTH ACT 1911

Shire of Carnamah

HEALTH LOCAL LAWS 1998

Made by the Council of the Shire of Carnamah

#### Citation

1. These local laws may be cited as the "Shire of Carnamah Health Local Laws 1998".

#### **Incorporation by Reference**

2. (i) In these local laws, "The Shire of Plantagenet Health Local Laws 1997";

- (a) means *The Shire of Plantagenet Health Local Laws 1997* published in the *Government Gazette*, special edition number 69, on the 30th March 1998; and
- (b) does not include any amendments that might be made to those Local Laws
- (ii) Subject to the modifications set out in the Schedule, *The Shire of Plantagenet Health Local Laws 1997* are incorporated with and form part of these Local Laws.

### Repeal

3. (1) The Health Local Laws adopted by the Shire of Carnamah and published in the *Government Gazette* on 15 November 1929 and amended from time to time, are repealed;

- (2) The Health Local Laws adopted by the Shire of Carnamah on 10 July 1953 and published in the *Government Gazette* on 2 October 1953, and amended from time to time, are repealed;
- (3) The Health Local Laws adopted by the Shire of Carnamah on 17 October 1956 and published in the *Government Gazette* on 21 January 1957, and amended from time to time, are repealed; and
- (4) The Health Local Laws adopted by the Shire of Carnamah on 4 February 1964 and published in the *Government Gazette* on 17 September 1964, and amended from time to time, are repealed.

*Shire of Kellerberrin* HEALTH LOCAL LAWS 1998

Made by the Council of the Shire of Kellerberrin

#### Citation

1. These local laws may be cited as the "*Shire of Kellerberrin Health Local Laws 1998*".

#### **Incorporation by Reference**

- 2. (i) In these local laws, "The Shire of Plantagenet Health Local Laws 1997";
  - (a) means The Shire of Plantagenet Health Local Laws 1997 published in the Government Gazette, special edition number 69, on the 30 March 1998; and
  - (b) does not include any amendments that might be made to those Local Laws
  - (ii) Subject to the modifications set out in the Schedule, *The Shire of Plantagenet Health Local Laws 1997* are incorporated with and form part of these Local Laws.

Repeal

- 3. (1) The Health Local Laws adopted by the Shire of Kellerberrin and published in the *Government Gazette* on the 22 October 1920 and amended from time to time, are repealed;

Where the Executive Director, Public Health has—

(a) under section 251 (6) of the Act, ordered a person to be isolated or quarantined at a place; and

(b) under section 251 (8) of the Act, forbidden the person from leaving the place,

the Executive Director, Public Health may-

- (c) if he or she has reasonable grounds for believing that the person is likely to unlawfully leave the place, restrain the person from leaving that place; and
- (d) restrain the person from engaging in conduct at the place that the Executive Director, Public Health believes, on reasonable grounds, is likely to lead to the spread of a dangerous infectious disease.

- 4. In respect of Shared Equity 1994 (Access) (Subsidised Rate) Loans the standard rate of interest shall be 6.5% per annum rising 0.5% per annum on every 30 June subsequent to the date from which interest is to be calculated until the rate of interest is 7.00% per annum.
- 5. In respect of Shared Equity 1994 (Real Start) (Unsubsidised Rate) Loans the standard rate of interest shall be 7.0% per annum.
- 6. In respect of Shared Equity 1997 (Good Start) (Subsidised Rate) Loans the standard rate of interest shall be 6.5% fixed per annum, until the borrowers' income exceeds Homeswest's maximum rental income eligibility limits. The rate will then move to the Commonwealth Bank standard home loan variable interest rate subject to a minimum interest rate of 6.5% per annum.

This determination shall take effect from 1 January 1999.
