**SCHEDULE****AMENDING STATUTE No. 1 of 1998****1. AMENDMENTS TO STATUTE No. 21—MUSIC EXAMINATIONS BOARD**

Existing clauses 1. to 9. are deleted and replaced by the following:

**Definition**

“AMEB” is the Australian Music Examinations Board.

“AMEB(WA)” is the Western Australian branch of the Australian Music Examinations Board.

1. AMEB(WA) shall be affiliated to the University of Western Australia through the University's School of Music, provided that either AMEB or the University may terminate the affiliation by no less than six months' notice.

2.(1) The principal role of AMEB(WA) shall be to ensure that public examinations in music, and in speech and drama, are held in Western Australia in accordance with AMEB regulations.

(2) AMEB(WA) may also involve itself from time to time in other activities in support of education in music and in speech and drama.

3. The Chair of AMEB(WA) shall be appointed by the University Senate from the permanent staff of the School of Music.

4. The structure and governance of AMEB(WA) shall be as determined from time-to-time by that body and the University Senate and may be reviewed at any time at the request of either body.

**FI401\*****FISH RESOURCES MANAGEMENT ACT 1994****WEST COAST PURSE SEINE MANAGEMENT PLAN AMENDMENT 1999**

FD 16/99 [274]

Made by the Minister under section 54(2).

**Citation**

1. This amendment may be cited as the *West Coast Purse Seine Management Plan Amendment 1999*.

**Principal Plan**

2. In this amendment the *West Coast Purse Seine Management Plan 1989\** is referred to as the principal Plan.

**Clause 10 amended**

3. Clause 10 of the principal Plan is amended by deleting subclause (1) and substituting the following—

“(1) The Executive Director may, by notice published in the Gazette, prohibit fishing in any part of the Fishery for the period specified in the notice if in the opinion of the Executive Director the prohibition is necessary for the protection of any part of the stocks of small pelagic fish or is required in the better interests of the Fishery.

(1a) A person must not fish in a part of the fishery at a time when fishing in that part has been prohibited by a notice made under subclause (1).”.

**Clause 17 inserted**

4. The principal Plan is amended by inserting after clause 16 the following—

**“Offences**

17. A person who contravenes a provision of clause 5, 6, 10 or 11 commits an offence.”.

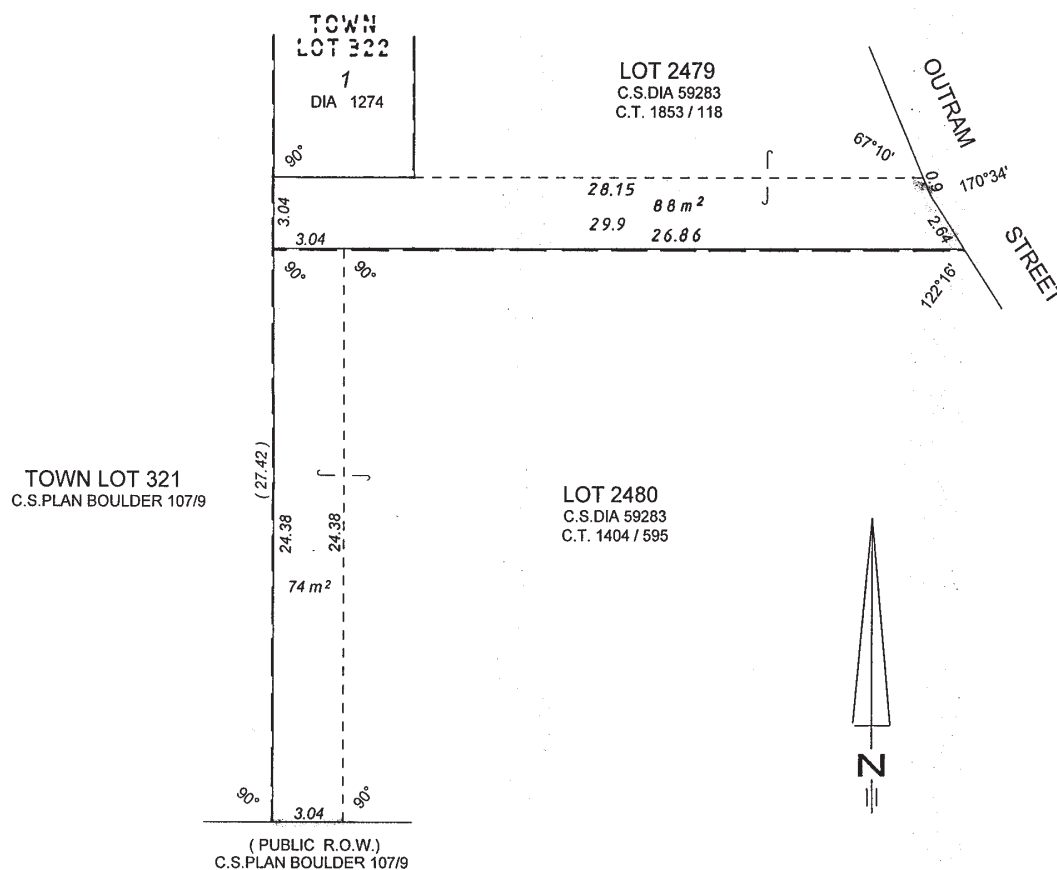
