Pursuant to the powers conferred under the Local Government Act 1995, the Council of the Local Government of the Shire of Mundaring hereby records having resolved on the 10th February 1999 to make the following Local Law.

PART 1—DIVISION A

DEFINITIONS AND INTRODUCTIONS

1.1 Citation

This Local Law may be cited as the Shire of Mundaring Local Law Relating to Parking Facilities.

1.2 Commencement

This Local Law commences operation fourteen (14) days from the date this Local Law is published in the *Government Gazette*.

1.3 Interpretation

In this Local Law unless the context otherwise requires—

"Parking Region" means the whole of the District of the Shire of Mundaring.

"No pre-school aged child shall be admitted to the Pool unless accompanied by and in the charge of a responsible person."

and insert in lieu thereof-

"No child under the age of ten (10) years shall be admitted to the Pool unless accompanied by and in charge of an adult and children under the age of five (5) years must be supervised by an adult at all times while present on the Pool premises."

STANDING ORDERS LOCAL LAW 1998

Under the powers conferred by the Local Government Act 1995, the Council of the Shire of Lake Grace resolved on the 25th day of November 1998, to adopt the Standing Orders Local Law published in the *Government Gazette* on 3 April, 1998, with such modifications as are here set out—

Part 1 in clause 1.4 insert "Shire of Lake Grace" after "The Standing Orders of the" and insert "21 January, 1983" after "published in the Government Gazette on";

Part 2 delete the whole of Part 2;

Part 3 insert new clause 3.1. "All Council business is to be dealt with at the ordinary meeting of Council and Council Standing Committees will meet only as required.

delete subclause 3.2(1) and substitute—

"The order of business at an ordinary meeting of the Council is to be as decided by the Council from time to time, or, if not decided by the Council, by the President and CEO":

delete clause 3.7:

Part 9 in clause 9.1—delete the heading "9.1 Members to Rise" and substitute "9.1 Members Wishing to Speak"; and delete the whole of the second sentence;

Part 12 in subclause 12.7(1), delete "deferral under clause 3.7 or";

Part 14 delete the whole of Part 14;

Part 15 in clause 15.3, delete "and be seated";

delete clause 15.8:

Part 17 in clause 17.6, delete paragraph (b);

Part 18 Insert new clause 18.3—Duty of Chief Executive Officer

"It is the duty of the Chief Executive Officer to draw the attention of the Council to any breach or likely breach of these Standing Orders even if it requires interrupting any person speaking, including the President.


