AG301**EXOTIC DISEASES OF ANIMALS ACT 1993****EXOTIC DISEASES OF ANIMALS (IMPORTATION RESTRICTION ORDER) 1999**

Made by the Minister under section 24.

Citation

1. This order may be cited as the *Exotic Diseases of Animals (Importation Restriction Order) 1999*.

Duration

2. This order comes into operation on the day on which it is published in the *Gazette* and has effect for a period of 30 days.

Certain entry or importation of birds or bird products prohibited unless approved

3. (1) The entry or importation into Western Australia of any animal or animal product that is, or is of, a bird that has come from an area described in subclause (2) is prohibited unless in a particular case the Chief Veterinary Officer has given prior approval.

(2) An area referred to in subclause (1) is an area of New South Wales that is declared under a law of that State to be a restricted area or a control area for the purpose of an outbreak or suspected outbreak of Newcastle disease.

FI401**FISH RESOURCES MANAGEMENT ACT 1994****KIMBERLEY PRAWN MANAGED FISHERY MANAGEMENT PLAN 1993****Clause 17—Closures of Areas within the Fishery**

In accordance with clause 17 of the *Kimberley Prawn Managed Fishery Management Plan 1993**, I hereby prohibit all persons from fishing—

- (a) in the waters described in Schedule 1 of that Plan during the period commencing at 1200 hours on 1 June 1999 and ending at 1800 hours on 4 August 1999;
- (b) in the waters described in Schedule 1 of that Plan during the period commencing at 0800 hours on 15 November 1999 and ending at 1200 hours on 1 April 2000; and
- (c) in the waters of Schedule 2 of that Plan during the period commencing at 1200 hours on 21 May 1999 and ending at 1800 hours on 4 August 1999.

1. This notice may be cited as the *Joint Authority Southern Demersal Gillnet and Demersal Longline Management Plan Amendment (No. 2) 1999*.

Principal Plan

2. In this amendment the *Joint Authority Southern Demersal Gillnet and Demersal Longline Management Plan 1992** is referred to as the principal Plan.

Arrangement amended

3. The arrangement to the principal Plan is amended by—

- (a) inserting after item “12. Offences” the following—
 - “13. Payment of fee by instalments
 - 14. Ground to refuse to transfer a licence or gear unit”; and
- (b) inserting after the item commencing “Schedule 3” the following—
 - “Schedule 4—Instalments”.

Clause 2 amended

4. Clause 2 of the principal Plan is amended by—

- (a) inserting after the item commencing “reel” the following item—
 - “ “regulations” means the *Fish Resources Management Regulations 1995*; ”; and
- (b) inserting after the item commencing “statutory return” the following item—
 - “ “total fee” means the fee as specified in item 3(24) of Part 3 of Schedule 1 of the regulations; ”.

Clause 7 amended

5. Clause 7 of the principal Plan is amended in paragraph (a) of subclause (4) by deleting “ 175 ” and substituting the following—

“ 162.5 ”.

Clauses 13 and 14 inserted

6. The principal Plan is amended by inserting after clause 12 the following clauses—

“Payment of fee by instalments

13. (1) For the purposes of regulation 137(2) of the regulations, the total fee may be paid by instalments as specified in Schedule 4 if—

- (a) an election to pay by instalments is made by the holder of a licence in accordance with subclause (2); and
- (b) there is no other fee, charge or levy in respect of the licence which has not been paid at the time the election is received at the head office of the Department.

(2) An election, for the purposes of subclause (1), must be—

- (a) made in writing;
- (b) received at the head office of the Department prior to the commencement of the licensing period to which the election relates; and
- (c) accompanied by the first instalment plus the surcharge.

(3) For the purposes of regulation 137(3) of the regulations, the surcharge shall be 3.13% of the total fee.

(4) The holder of a licence, or a person acting on that persons behalf, must not fish in the Fishery at any time when any fee or surcharge payable in respect of the licence is outstanding.

Ground to refuse to transfer a licence or gear unit

14. The Executive Director may, for the purposes of section 140(2) of the Act, refuse to transfer a licence or a gear unit on the ground that the total fee for a licence has not been paid. ”.

Schedule 4 inserted

7. The principal Plan is amended by inserting after Schedule 3 the following schedule -

“Schedule 4—Instalments

- (a) The first instalment is 25% of the total fee and is due for payment on or before 1 June of the year for which the licence is to be granted or renewed.
- (b) The second instalment is 25% of the total fee and is due for payment on or before 1 September immediately following the period specified in paragraph (a).

- (c) The third instalment is the total fee less the instalments provided for in paragraphs (a) and (b) and is due for payment on or before 1 December immediately following the period specified in paragraph (a). ”.

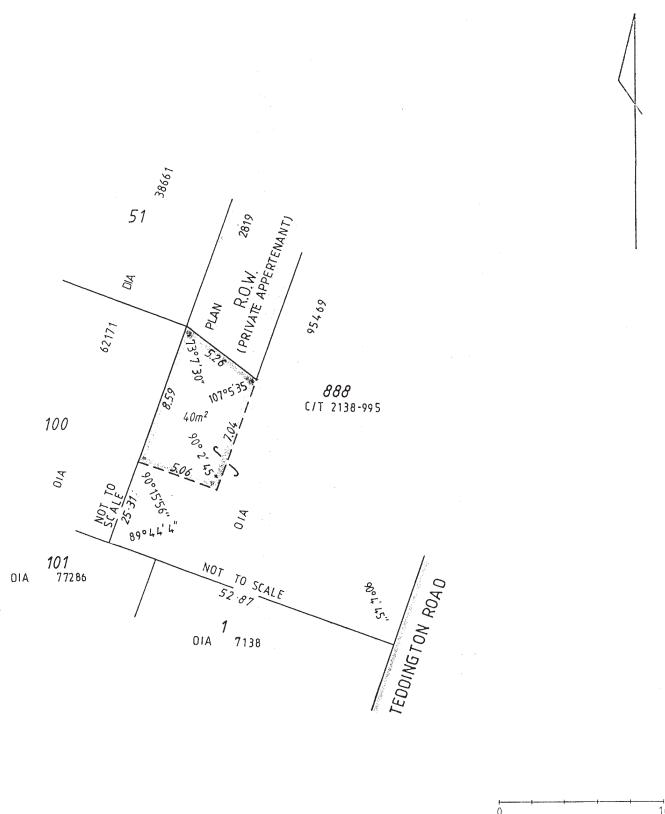

 - (b) The Outline Development Plan shall include sufficient detail to show the following:
 - topography of the area
 - natural vegetation of the area
 - the existing major road systems
 - the location and width of proposed roads and non-vehicular movement systems
 - the appropriate location and quantity of commercial, civic and public facilities proposed
 - the approximate location of recreation and open space areas proposed, the open space where appropriate to be related to creek lines, native vegetation and other natural landscape features

TB401**VOCATIONAL EDUCATION AND TRAINING ACT 1996****VOCATIONAL EDUCATION AND TRAINING (KIMBERLEY COLLEGE
OF TAFE) ORDER 1999**

Made by the Minister for Employment and Training under section 35 of the *Vocational Education and Training Act 1996*.

PART 1—PRELIMINARY**Citation**

1. This order may be cited as the *Vocational Education and Training (Kimberley College of TAFE) Order 1999*.

Commencement

2. This order comes into operation on 1 July 1999.

Interpretation

3. In this order unless the contrary intention appears—

“commencement day” means the day on which this order comes into operation under clause 2;

“interim governing council” means the interim governing council provided for by clause 5;

“staff” does not include the person holding the office of managing director of the former institution;

“the College” means Kimberley College of TAFE established under clause 4.

“the former institution” means the institution established by the *Vocational Education and Training (Kimberley College) Order 1997*.

PART 2—ESTABLISHMENT OF KIMBERLEY COLLEGE OF TAFE**Establishment and name**

4. (1) A college is established under section 35 of the Act on the lands occupied by the former institution immediately before the commencement of this order.

(2) The college established under sub-clause (1) is to be known as Kimberley College of TAFE.

Interim governing council

5. (1) The College is to have an interim governing council.

(2) The interim governing council is to consist of—

(a) a chairperson and not less than 2 persons appointed by the Minister; and

(b) the managing director for the time being of the college.

(3) The term of office of a member of the interim governing council is terminated when a governing council is appointed in relation to the College under section 39 of the Act.

(4) Schedule 1 of the Act with such modifications as are necessary for the purpose apply to and in relation to the terms of the appointment of, and the procedures to be followed by, the interim governing council.

(5) The interim governing council is authorised to exercise the powers conferred on the governing council of a college under section 43 of the Act.

PART 3—CONSEQUENTIAL PROVISIONS**Objects**

6. The objects of this Part are to protect the rights, interests and welfare of the persons affected by the establishment of the College and for the purpose of ensuring compliance with the requirements of the *Financial Administration and Audit Act 1985*.

Staff

7. (1) The staff employed or engaged for the purposes of the former institution immediately before the commencement day are with effect on and from that day to be taken to be employed or engaged by the College on the same terms and conditions including the salary payable, as those on which they were employed or engaged immediately before the commencement day.

(2) The persons to whom sub-clause (1) applies retain all their existing and accruing rights, including rights under the *Superannuation and Family Benefits Act 1938* or the *Government Employees Superannuation Act 1987*, as the case may be, as if their employment or engagement by the College under that sub-clause were a continuation of their employment immediately before the commencement day.

Students

8. (1) On the commencement day—

(a) each person who was, immediately before commencement day, enrolled as a student of the former institution becomes an enrolled student of the College;

(b) each person who was, immediately before commencement day, eligible to be enrolled as a student of the former institution is eligible to be enrolled as a student of the College; and

- (c) each person who was, immediately before commencement day, entitled to be, but had not been, awarded a diploma, certificate or honorary award by the former institution is entitled to be awarded an appropriate diploma certificate or honorary award by the College.
- (2) A person who has completed part of a course of study as an enrolled student at the former institution is to be taken to have completed that part of the course of study at the College.
- (3) Students enrolled at the former institution under sub-clause (1) are entitled, on completion of their courses, to be awarded an appropriate award by the College.

Financial provisions

9. (1) As soon as practicable after commencement day the chief executive is to cause sections 66, 67 and 68 of the *Financial Administration and Audit Act 1985* to be complied with in relation to the former institution in respect of the period commencing 1 July 1998 and ending immediately before commencement day.

(2) A report prepared under sub-clause (1) is to be taken to be an annual report for the purposes of section 69 of the *Financial Administration and Audit Act 1985*.

(3) Notwithstanding clause 4, the chief executive is to continue to have management and control of the College for the purposes of sub-clause (1).

(4) The College is to provide such clerical and other assistance as is necessary for the purposes of sub-clause (1).

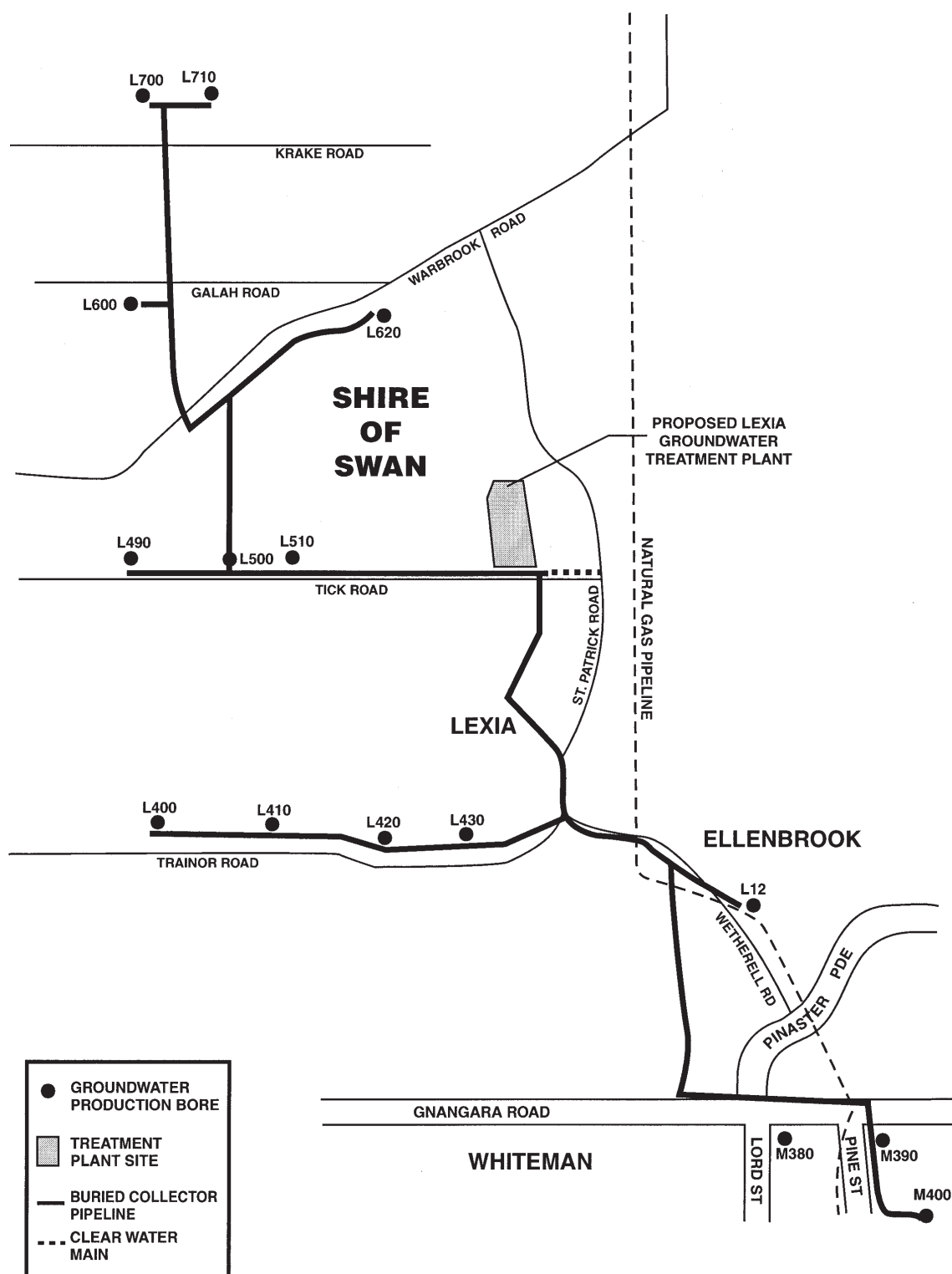

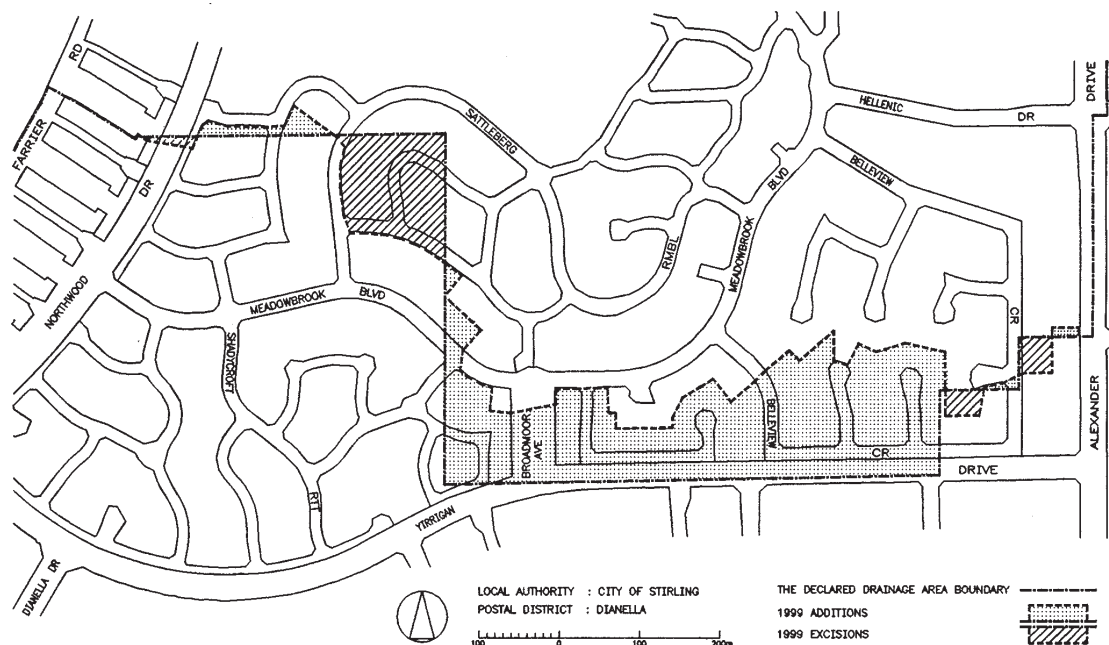

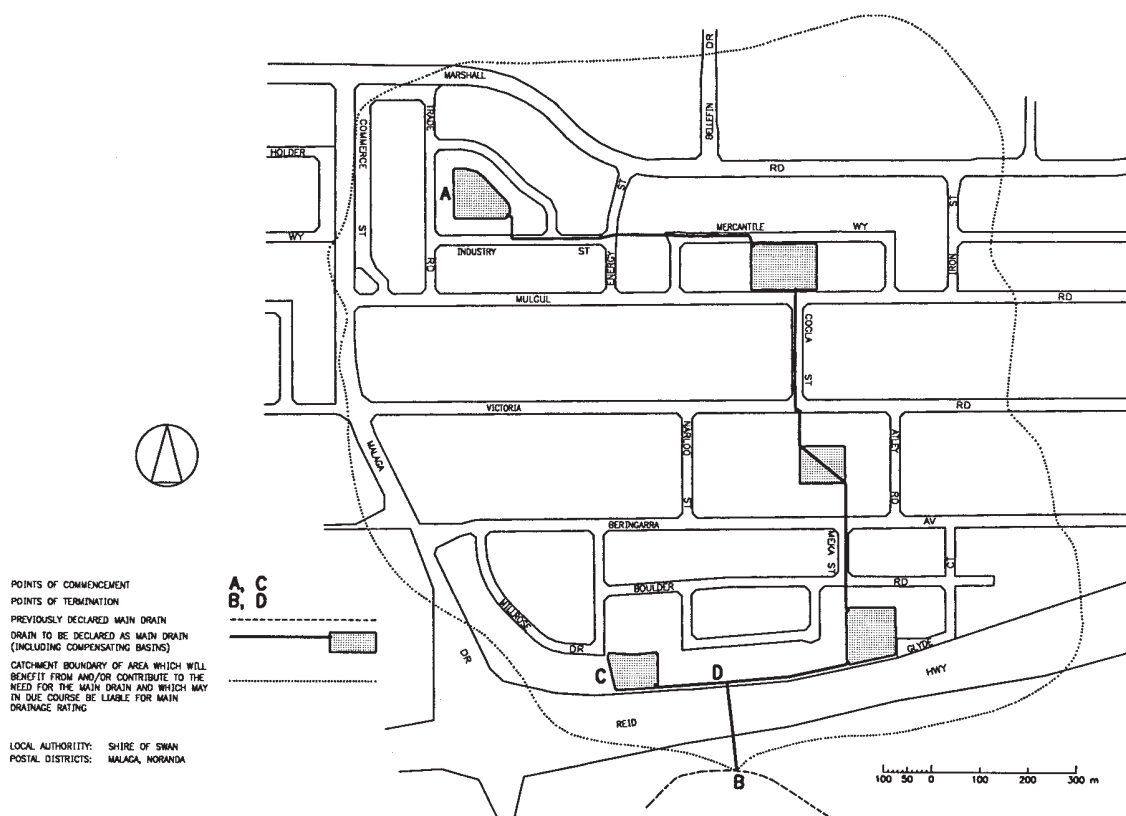
