Lotteries Commission Act 1990

Lotteries Commission (Cash 3) Amendment Rules 1999

Made by the Lotteries Commission under section 28.

1. Citation

These rules may be cited as the *Lotteries Commission (Cash 3) Amendment Rules 1999.*

2. Commencement

These rules come into operation on 26 August 1999.

3. The rules amended

The amendments in these rules are to the *Lotteries Commission* (Cash 3) Rules 1998*.

[* Published in Gazette 4 September 1998, pp. 4873-87.]

4. Rule 3 amended

Rule 3 is amended as follows:

- (a) by deleting the definitions of "advance play option", "Consecutive days" and "Pick a Day/s";
- (b) in the definition of "game" by deleting "with a" and inserting
 - " with at least one ";
- (c) by inserting in the appropriate alphabetical order the following definition —

"advance play option" is where —

- (a) a subscriber using an entry coupon requests that the entry be valid for a particular day or days as specified on the coupon; or
- (b) an oral request is made for an entry to be valid for a specified day or sequence of days;

5. Rule 5 amended

Rule 5 is amended by deleting "shown in Schedule 1." and inserting instead —

" set out in these rules. ".

6. Rule 8 amended

- (1) Rule 8(2) is repealed and the following subrule is inserted instead
 - (2) For each game board filled out on the entry coupon, the subscriber must
 - (a) indicate whether the wager is a 50 cent wager or a \$1.00 wager; and
 - (b) indicate the type of play (e.g. 'Exact order', 'Any order', or both),

but if the selection is for both an 'Exact order' and an 'Any order' play type, then the subscriber is to select either a 50 cent wager for each option or a \$1.00 wager for each option.

(2) Rule 8(5) is amended by deleting "6" and inserting instead —

"3".

7. Rule 9 amended

- (1) Rule 9(2) is amended as follows:
 - (a) at the end of paragraph (a) by deleting "and" and inserting instead —

" or ";

(b) by deleting paragraph (b) and inserting the following paragraph instead —

(b) one of the "default" options, being either —

- (i) an 'Exact order' play type, for 7 consecutive days, with a 50 cent wager per day (\$3.50);
- (ii) an 'Any order' play type, for 7 consecutive days, with a 50 cent wager per day (\$3.50); or
- (ii) a combination of subparagraphs (i) and (ii) (i.e. an 'Exact order' play type, and an 'Any order' play type, for 7 consecutive days, with a 50 cent wager per day for the 'Exact order' play type and a 50 cent wager per day for the 'Any order' play type) (\$7.00).

(2) Rule 9(3) (b) is amended by deleting "an 'Exact /Any' play type" and inserting instead —

"

a combination of an 'Exact order' and an 'Any order' play type

(3) Rule 9(5) is repealed.

8. Rule 17 replaced

Rule 17 is repealed and the following rule is inserted instead —

17. Availability of results

The Commission is to ensure that, as a minimum, the result of each Cash 3 draw is available from each authorized retailer of Cash 3, on and from the commencement of business hours of the trading day following the draw.

- (a) to promote bonus prizes that are to be offered; and



BUSH FIRES ACT 1954

Shire of Murray

1999/2000 Firebreak Notice

In pursuance of the powers conferred in Section 33 of the Bush Fires Act, 1954, notice is herby given to all owners and/or occupiers of land within the Shire of Murray that Council has adopted the following requirements to prevent the outbreak or spread of a bush fire within the Shire.

All owners and/or occupiers of land are required to carry out fire prevention work in accordance with this notice on land owned or occupied by you on or before the 15 day of December 1999 or within fourteen days of the date of you becoming the owner or occupier should this be after the 15 day of December 1999. All work required by this Notice shall be maintained until the 31day of May 2000.

Definitions

For the purpose of this Order the following definitions apply—

- "Firebreak" means an area of ground, of a specified width that is kept and maintained totally clear of all material (living or dead) by scarifying, cultivating, ploughing or other means, and includes the pruning and removal of any living or dead trees, scrub or other material that overhang the cleared firebreak area to a vertical height of 4.5 metres from the ground.
- "Fuel Depot" means an area of land, a building or structure where fuel, ie (petrol, diesel, kerosene, liquid gas or any other fossil fuel) is kept in any container or manner.
- "Urban Land" means Residential, Commercial or Industrial land within a townsite or within any area subdivided for any purpose. The following areas are townsites- Pinjarra, Dwellingup, Furnissdale, Coolup, North Dandalup, Barragup, South Yunderup, North Yunderup, Ravenswood and Murray Bend.
- "Flammable Material" means material that can be easily ignited, ie—dead or dry grass, leaves, timber, paper, plastic and other material or thing deemed by an authorised officer to be capable of combustion.
- "Hills Landscape Protection Land" means land zoned or defined in the Town Planning Scheme as Hills Landscape Protection Land.
- "Plantation" means any area of planted pines, eucalypt, hardwood or softwood trees exceeding (3) hectares in area.

Fire Prevention Requirements

1. Rural Land

- (a) Firebreaks of at least two (2) metres wide are to be constructed within fifty (50) metres of the boundaries of the land, where the land abuts—gazetted roads, railway reserves, CALM controlled land or a Plantation.
- (b) If the land abuts "Special Rural", "Special Use", "Special Residential", "Hills Landscape Protection Land" or "Urban" or "Farmlet Land" a Firebreak of at least three (3) metres wide shall be constructed along that portion of the Rural Land that abuts the abovementioned land. The Firebreak is to be located immediately inside the boundary of the rural land where it abuts the abovementioned land.
- (c) Firebreaks of at least two (2) metres shall be constructed to surround all buildings, sheds, haystacks and fuel depots/storage areas on the land. The inner perimeter of the Firebreak is to be within twenty (20) metres of all buildings, sheds, haystacks and fuel depots/storage areas.

2. Special Rural, Special Residential, Special Use or Farmlet Land.

(Other than Rural Land previously described)

- (a) Where the area of land is 2024 sqm (approximately half an acre) or LESS, remove all flammable material (except living standing trees) from the whole of land by slashing, mowing, rotary hoeing, chemical spraying or cultivation, or;
- (b) Where the area of land EXCEEDS 2024 sqm (half acre) a Firebreak of at least three (3) metres wide shall be installed or constructed immediately inside all external boundaries of the land and also immediately surrounding all buildings situated on the land. Where several adjoining lots are held or used by the owner/occupier the Firebreak may be constructed inside and along all the external boundaries of the group of Lots.

3. Urban Land (Excluding land abutting canals)

- (a) Where the area of land is 2024 sqm (approximately half an acre) or LESS, remove all flammable material (except living standing trees) from the whole of land by slashing, mowing, rotary hoeing, ploughing, chemical spraying or cultivation, or;
- (b) Where the area of land EXCEEDS 2024 sqm (half acre) a Firebreak of at least three (3) metres wide shall be installed or constructed immediately inside all external boundaries of the land and also immediately surrounding all buildings situated on the land.

4. Canal System Locations

All owners of land that abuts a canal shall undertake fire prevention work in accordance with Clause 3 (a) and (b) of this Order, depending on the total square metre area of the land. The owners of Undeveloped Lots ie-(*Vacant Land*) of LESS than 2024 sqm shall remove all flammable material from the land by mowing, slashing or burning only.

5. Culeenup, Ballee and Yunderup Islands

All owners of land on the abovementioned islands shall undertake fire prevention work in accordance with Clause 2 (a) or 2 (b) of this Order, depending on the total square metre area of their land.

6. Hills Landscape Protection Land

Each owner of land zoned "Hills Landscape Protection" shall undertake fire prevention work in accordance with Clause 2 (a) and 2 (b) of this Order, depending on the total square metre area of their land. All work required by this Order, shall be in addition to any work required by the Fire Management Plan that exists for each lot zoned Hills Landscape Protection Land.

7. Plantations

All plantations established after the 30 November 1984 that exceed 3 hectares in total area shall have a twenty (20) metres wide firebreak completely surrounding the perimeter of planted trees.

A plantation that abuts a used road shall have a 10 metres wide firebreak along that portion of the plantation that abuts the road.

Each compartment of a plantation is limited to area of less than 30 hectares in size, each 30 hectare area shall have a 10 metres wide firebreak surrounding the perimeter of planted trees. This will permit unrestricted access to each compartment of planted trees by fire fighting equipment.

Variations

If it is considered to be impractical to comply with the provisions of this Order, you may apply for a variation by the following means—

- Apply in writing to the Chief Executive Officer, prior to the 30 November 1999.
- Provide a plan of your land (co-signed by your area Fire Control Officer) detailing the alternate positions of Firebreaks and/or other fire prevention measures.

Variations may be approved for a 1 or 3 year period, subject to the owner/occupier of the land remaining the same. If the application is not approved by the Chief Executive Officer, you will be required to comply with the requirements of this Order by the due date.

DATES TO REMEMBER

Burning Permits Required

1st November 1999 each to 14th December 1999 (inclusive)

15th March 1999 to 31st May 2000 (inclusive) **Burning Prohibited**

15th December 1999 to 14th March 2000 each year (inclusive)

The above dates are subject to variation. Alterations will be published in a local newspaper circulating the district.

ADDITIONAL REQUIREMENTS

Special Orders

The requirements of this Order are considered the minimum standard for fire prevention work not only to protect individual properties but the district generally. Council retains the ability to issue Special Orders pursuant to Section 33 of the Bush Fires Act 1954 to individual landowners if hazard removal or reduction is considered necessary.

Camp or Cooking Fires

Cooking or campfires in the open air are totally banned throughout the Shire during the Prohibited Burning Period, except in recognised camping and picnic areas where properly constructed facilities exist. Gas barbecues or appliances are exempt and they may be operated during the Prohibited Burning Period.

NOTICE TO ALL OWNERS AND/OROCCUPIERS OF LAND SITUATED IN THE SHIRE OF MUNDARING

Take Notice that pursuant to Section 33(4) of the Bush Fires Act, where the owner or occupier of land who has received notice fails or neglects to comply with the requisitions of the notice within the time specified, the Shire of Mundaring may, by its officers and with such servants, workmen and contractors, vehicles and machinery as the officers deem fit, enter upon the land and carry out the requisitions of the notice which have not been complied with and pursuant to Section 33(5) of the Bush Fires Act the amount of any costs and expenses incurred may be recovered from you as the owner or occupier of the land.

FIREBREAKS

Pursuant to the powers contained in Section 33 of the Bush Fires Act 1954, you are hereby required to clear of flammable material firebreaks not less than 3 metres in width immediately inside all external boundaries of any lot owned or occupied by you and situated within the Shire of Mundaring.

Such firebreaks may be constructed by one or more of the following methods—

Ploughing, Cultivating, Scarifying, Burning, Chemical Spraying or Other Approved Method.

and are to be cleared to the satisfaction of an Authorised Officer of the Shire. In addition you may be required to carry out further works which are considered necessary by an Authorised Officer of the Shire and specified by way of a separate written notice forwarded to the address as shown on the Shire of Mundaring rates record for the relevant land.

In some instances naturally occurring features such as rocky outcrops, natural watercourses or landscaping such as reticulated gardens, lawns or driveways may be an acceptable substitute for cleared firebreaks. This option must first be discussed with an Authorised Officer of the Shire, and approved by the Authorised Officer in writing.

On any lot having an area of less than 3,000m² with a dwelling constructed on it, where the lot is substantially developed (i.e. at least 75% cleared of bush), the keeping of grass on the lot at all times covered by this notice to a height less than 5 centimetres will be accepted in lieu of clearing a firebreak. For the purpose of this notice grass kept at a height of less than 5 centimetres will be deemed not to be flammable material.

All firebreaks and other alternative arrangements allowed by the preceding parts of this notice must be established before the 30th day of November 1999 (or within 14 days of you becoming the owner or occupier should this occur after that date) and maintained clear of flammable material up to and including the 14th day of March 2000.

APPLICATION TO VARY THE ABOVE REQUIREMENTS

If it is considered impracticable for any reason whatsoever to clear firebreaks or establish other arrangements as required by this notice, you may apply in writing to the Shire of Mundaring not later than the 15th day of November 1999 for permission to provide firebreaks in alternative positions on the land. If permission is not granted by the Shire, you must comply with the requirements of this notice.

If the requirements of this notice are carried out by burning, such burning must be in accordance with the relevant provisions of the Bush Fires Act.

The penalty for failing to comply with this Notice is a fine not exceeding \$1,000 and a person in default is also liable whether prosecuted or not to pay the costs of performing the work directed by this notice if it is not carried out by the owner and/or occupier by the date required by this notice.

Shire of Boddington FIREBREAK ORDER

 $Important\ information\ relating\ to\ your\ responsibility\ as\ a\ landholder\ in\ the\ Boddington\ Shire.$

With reference to Section 33 of the Bushfires Act, 1954-1981, you are required to carry out fire prevention work on land owned or occupied by you in accordance with the provision of this order.

An inspection of firebreaks will be carried out in all areas of the shire by an authorised officer.

Failure to comply with this Firebreak Order is an offence under Section 33 of the Bushfires Act. Penalty \$1,000. Additionally Council may carry out the required work at cost to the owner or occupier.

If it is considered for any reason to be impractical to clear firebreaks or remove flammable materials as required by this notice, or if natural features render firebreaks unnecessary, you may apply to the Council in writing not later than the 15th November for permission to provide firebreaks in alternative positions or to take alternative action to abate fire hazards on the land. If permission is not granted by the Council, you shall comply with the requirements of this notice.

RURAL LANDS

- (a) This work must be carried out by 15th November and kept maintained throughout the summer months until 15th April.
- (b) A firebreak not less than 2.5 metres wide must be constructed along and within 100 metres of the external boundary of each property (i.e cleared or part cleared land) and where the boundary is adjacent to or adjoins a used gazetted road.
- (c) In the interest of protection from soil erosion, firebreaks may be constructed on the land contours but only with prior approval of the Council or its duly authorised officer.
- (d) An area 10 metres wide cleared of all flammable material shall be established immediately around the perimeter of all homesteads, buildings, haystacks and fuel storage areas.
- (e) In such positions as is necessary to divide land in excess of 200 hectare into areas not exceeding 200 hectare each completely surrounded by a firebreak.
- (f) A fire fighting unit with a minimum capacity of 450 litres is to be kept available at or adjacent to harvesting operations.

(g) Where there is agreement between adjoining land owners for one or the other to provide a firebreak on their boundary, this firebreak will be deemed the boundary of the adjoining property, subject to insurance company approval. Please contact your fire control officer if any uncertainty exists.

PINE AND EUCALYPTUS PLANTATIONS

Any pines or eucalyptus planted for commercial purposes constitutes a pine or eucalyptus plantation and you are hereby required to keep clear of all flammable materials firebreaks not less than 10 metres wide around the perimeter of each plantation, and any plantation exceeding 29 hectares will also require a subdivisional firebreak 6 metres in width for each 30 hectares, and bush surrounding planted areas is to be kept in a low fuel condition.

SMALL LOT HOLDERS OR HOBBY FARMS 20 HECTARE OR LESS

- (a) On or before 15th November every year a firebreak not less than 2.5 metres wide must be constructed along and within 100 metres of the external boundary of each property (i.e. cleared or part-cleared land) and where the boundary is adjacent to or adjoins a used gazetted road.
- (b) An area 10 metres wide cleared of all flammable material shall be established immediately around the perimeter of all homesteads, buildings, haystacks and fuel storage areas.

TOWNSITES OF BODDINGTON AND RANFORD

On or before 15th November every year all town lots under 4000 square metres in area and all fuel depots within the shire are required to be cleared of all debris and flammable material. Lots 4000 square metres and over are to have a minimum 2.5 metre firebreak installed immediately inside all external boundaries.

SPECIAL NOTE TO LAND OWNERS AND OCCUPIERS

The requirements of this order are considered to be the minimum standard of fire prevention work to protect not only individual properties but the district generally.

In addition to the requirements of this order Council may issue separate special orders on owners or occupiers if hazard removal is considered necessary in specific areas.

1.0 PLAN OF SUBDIVISION

- 1.1 Subdivision of Special Residential Zone Area No. 7 shall generally be in accordance with the Subdivision Guide Plan endorsed by the Chief Executive Officer.
- 1.2 Council shall recommend against the further breakdown of lots however, minor variations to the subdivision design, if approved by the Western Australian Planning Commission, may be acceptable.

2.0 OBJECTIVE OF THE ZONE

The objective of Special Residential Zone Area No. 7 is to provide a larger lot residential estate providing a range of lot sizes, a high level of servicing, comprehensive revegetation and site drainage within close proximity to the services and facilities provided by the Albany Central Area.

- 3.0 LANDUSE
- 3.1 Within Special Residential Zone Area No. 7 the uses are permitted—
 - · Residential Dwelling House.
- 3.2 The following uses are not permitted unless the Special Approval of Council is granted—
 - Home Occupation
 - Public Utility
 - · Cottage Industry
 - Education Establishment
 - Place of Worship
 - Other incidental or non defined landuses considered appropriate by Council as being consistent with the objective of the zone.

4.0 KEEPING OF LIVESTOCK/ANIMALS

- 4.1 With the intention of preventing land degradation and practices detrimental to the environmental amenity of the zone, the keeping of sheep and horses, cattle and/or other heavy beasts, shall not be permitted.
- 4.2 The keeping of not more than two dogs may be permitted, provided it/they are kept in a manner that is sensitive to the proximity of nearby rural and residential areas.
- 5.0 LOCATION OF BUILDINGS AND STRUCTURES
- 5.1 No building may be erected closer to the boundary of a lot than—
 - (i) from the frontage of a lot—10m
 - (ii) from the side or rear boundary of a lot-5m
- 5.2 Notwithstanding 5.1 above, Council may approve a lesser distance when Council is of the opinion that the topography or shape of the lot or vegetation on the lot makes it desirable to vary this provision.
- 5.3 No residential dwelling or effluent disposal system shall be located within the Creekline Setback as shown on the Subdivision Guide Plan.
- 5.4 Floor levels for dwellings shall achieve a minimum of 1.1m vertical separation to the Estimated Maximum Flood Level, as shown on the Subdivision Guide Plan.
- 5.5 Floor levels for other buildings shall achieve a minimum of 600mm vertical separation to Estimated Maximum Flood Level, as shown on the Subdivision Guide Plan.
- 6.0 BUILDING DESIGN, MATERIALS AND COLOUR
- 6.1 Dwelling houses and all outbuildings shall not exceed 7.5m in height which is measured vertically from the natural ground level.
- 6.2 Council may request the Commission to impose a condition at the time of subdivision requiring the provision of a 600m² sand pad on Lots 30 to 37, as shown on the Subdivision Guide Plan. Such sand pads shall comprise imported fill, be filled out from the upper level to create elevated areas for effluent disposal systems and achieve a minimum of 1.1m vertical separation to the Estimated Maximum Flood Level, as shown on the Subdivision Guide Plan.
- 6.3 Subject to clause 6.2, Council may request the Commission to impose a condition at the time of subdivision requiring the compaction of sand pads and professional certification that such pads are capable of accommodating a two storey, double brick and tile dwelling.
- 6.4 On those lots abutting the Public Open Space reserve as shown on the Subdivision Guide Plan, no boundary fencing shall be constructed of fibre cement, metal sheeting or wooden picket. If boundary fencing is utilised, it is to be of rural construction such as post and strand, post and rail (or similar) to the satisfaction of Council.
- 6.5 Council shall not approve dwellings or outbuildings with walls and roofs constructed of reflective materials such as unpainted zincalume and pale or "off white" colours.
- 7.0 BUILDING EXCLUSION AREA
- $7.1\,$ No buildings shall be permitted within the Building Exclusion Area, as shown on the Subdivision Guide Plan.
- 7.2 Council shall refuse to approve landuses and/or development within the Building Exclusion Area which are considered to place the Building Exclusion Area, groundwater and/or the creekline at risk of erosion, pollution and/or nutrient enrichment.
- 8.0 REVEGETATION
- 8.1 The clearing of revegetation and tree planting areas shall not be permitted.
- 8.2 Council may request the Commission to impose a condition at the time of subdivision for the revegetation of the areas shown and in the form shown on the Subdivision Guide Plan. Such revegetation shall comprise endemic species approved by Council.
- 8.3 Additional tree planting may be required as a condition of development approval.

9.0 WATER SUPPLY

- 11.5 Lots 3, 7, 8, 9, 10, 20, 21, 22, 23 & 24, as shown on the Subdivision Guide Plan, shall be maintained in a low fuel state.
- 11.6 Council may request the Commission to impose a condition at the time of subdivision for the construction of strategic firebreaks as shown on the Subdivision Guide Plan.
- 11.7 Strategic firebreaks shall be constructed to a standard suitable for safe access by heavy duty 4WD fire appliances.
- 11.8 In cases where only part of the zone is developed, an interim firebreak system or strategic fire break system shall be prepared and put in place, to the satisfaction of Council and the Bush Fires Service of WA.
- 11.9 Where a lot is traversed by a strategic firebreak as shown on the Subdivision Guide Plan, the owner of the lot shall maintain such firebreak to the satisfaction of Council. Fencing and/or gates across the strategic firebreak shall only be permitted at the discretion of and to the satisfaction of Council and the Bush Fires Service of WA.

12.0 SITE DRAINAGE & MANAGEMENT

- 12.1 Council will request the Commission to impose a condition at the time of subdivision requiring the preparation and implementation of a comprehensive Stormwater Management Plan utilising, where possible, the best management and onsite management techniques of the Water Sensitive Urban (Residential) Design approach to stormwater management. The objective of such a plan shall be to retain stormwater onsite for design events (1:10 year storms & min. 72 hour detention) and protect and enhance the existing creekline, its potential ecological value and its potential public amenity. The plan should ensure post-development rates of water runoff do not exceed pre-development rates and increase the likelihood of downstream flooding.
- 12.2 Council may request the Commission to impose a condition at the time of subdivision requiring the construction of 500mm deep swales along one side of common lot boundaries for Lots 30 to 37, as shown on the Subdivision Guide Plan.

13.0 PUBLIC OPEN SPACE


