#### LOCAL LAW RELATING TO SIGNS, HOARDINGS AND BILL POSTING

**Insert Clause 5.10.3** 

"Notwithstanding the provision of Clause 5.10.1 and Clause 5.10.2 approval for the erection of a pylon sign that does not meet the requirements of these Local Laws may only be granted by Absolute Majority of the Local Government"

#### **RULES OF HARNESS RACING 1999**

NOTICE OF AMENDMENT

Notice is hereby given that at a meeting of the Committee of the Western Australian Trotting Association held at Gloucester Park, East Perth, on the 12th October 1999 it was resolved by an absolute majority of members of the Committee that the Rules of Harness Racing be amended as follows—

To re-include local rule 164 as amended below-

**Changing Positions (Easing Out)** 

I R164

- (1) Notwithstanding Rule 163 (1) (b), a driver may make another horse cover more ground than necessary where—
  - (a) the driver does so on or after entering the front straight with one lap of the race to run; or
  - (b) the driver does so prior to entering the front straight with one lap of the race to run, and the other horse is not maintaining or improving its position,
  - and provided that the driver does so only to the extent necessary to obtain an improved position for the driver's horse.
- (2) For the obviation of doubt, nothing in this local rule authorises any act which is contrary to any rule other than Rule 163 (1) (b).

# Road Traffic (Licensing) Amendment Regulations (No. 3) 1999

Made by the Governor in Executive Council.

#### 1. Citation

These regulations may be cited as the *Road Traffic (Licensing) Amendment Regulations (No. 3) 1999.* 

# 2. Regulation 21M replaced

Regulation 21M of the *Road Traffic (Licensing) Regulations* 1975\* is repealed and the following regulation is inserted instead —

"

## 21M. Tractors or tractor plant used for farming, etc.

- (1) This regulation applies to a vehicle that is a tractor (other than a prime mover type) or tractor plant if the Director General is satisfied that the vehicle is only to be used for one or more of the following
  - (a) to pass from one portion of a farm to another;
  - (b) to travel between a farm and some other place for farming activities;
  - (c) to carry out fire fighting or fire prevention operations;
  - (d) to take part in fire control exercises previously authorized by a bush fire control officer appointed under the *Bush Fires Act 1954*;
  - (e) if a farm is in an area that is declared by the Minister for Primary Industry to be drought affected or water deficient, to travel between that farm and a water supply for the purpose of carting water for stock or for domestic purposes.
  - (2) The vehicle licence fee payable for a vehicle to which this regulation applies is reduced to \$4.

- "Firebreak" means ground which is cleared to a "Mineral Earth" standard in which all flammable material (which includes vegetation and with all overhanging branches, trees, limbs etc to be trimmed back clear of the firebreak area) has been removed and on which no flammable material (which includes vegetation) is permitted during the firebreak period.
  - Firebreak must be the required width from the ground up in a vertical line with no restrictions.
- "Firebreak Period" means the time between 30 November in any year until 14 March in the year following;
- 2. Subject to Part 3, all owners and/or occupiers of land within the District shall prior to the commencement of the Firebreak Period, or within fourteen (14) days of becoming the owner or occupier of land should this occur within the Firebreak Period, establish and thereafter maintain during the Firebreak Period Firebreaks of the following dimensions;
  - (a) Land which is 2032sqm (approximately ½ acre) or less in area shall have the following options with regard to Firebreak provisions;
    - (i) construct a two (2) metre Firebreak as per (b) (I) and (iii) below;
    - (ii) remove all flammable material on the land except living sturdy trees to the satisfaction of Council's Authorised Fire Control Officers;
    - (iii) have a hazard reduction burn completed by 30 November in any year to the satisfaction of Council's Authorised Fire Control Officers;
    - (iv) clear all land by ploughing, cultivating, scarifying, burning, chemical spraying or other approved method which is to be completed to the satisfaction of Council's Authorised Fire Control Officers;
  - (b) All land which is greater than 2032sqm in areas shall have a firebreak three (3) metres wide;
    - (i) immediately inside all external boundaries of the land;
    - (ii) immediately surrounding all buildings (if any) situated on the land
    - (iii) immediately surrounding all fuel dumps and ramps (if any) on the land.
- 3. (a) If for any reason an owner or occupier considers it impractical to clear Firebreaks in accordance with Part 2 above, the owner or occupier may apply in writing to Council no later than 31 October in any year for approval to construct a Firebreak in an alternative position on his or her land. If Council, or its duly Authorised Fire Control Officers do not approve the application for an alternative Firebreak within seven (7) days then the owner or occupier shall comply with all the requirements of this Fire Control Order.
  - (b) An approval to construct an alternative Firebreak shall only remain in force until a change of ownership of the land following the date of the grant of the approval. If having been granted approval, if the owner or occupier fails to comply with the variation order then the provisions of Part 2 of this Fire Control Order shall apply. Council reserves the right, at any time, to revoke, alter or add to the provisions of this variation order.
  - (c) If Council has granted approval to construct a Firebreak in an alternative position and the owner or occupier has not constructed that Firebreak in accordance with Council's Authorised Fire Control Officers' approval, by 30 November of any year of the date of approval then the owner or occupier shall in all respects comply with this Fire Control Order as if the approval to construct a Firebreak in an alternative location had never been given.
- 4. Where an owner or occupier of land fails or neglects to comply with any requirements of this Fire Control Order within the time specified in this Fire Control Order, the Council may by its Authorised Fire Control Officers' with such employees and/or contractors, vehicles and machinery as the officer deems necessary enter upon the land and do all such things as necessary pursuant to this Fire Control Order and may revoke costs and expenses of doing so in the relevant court from the owner or occupier of the land pursuant to the Act, in addition to any penalty which might be imposed.
- 5. A person who fails to comply with any provision of this Fire Control Order commits an offence and shall upon conviction be liable to a penalty not exceeding \$1000.00.
- 6. The provisions outlined in this Fire Control Order in no way limit the ability of Council's Fire Control Officers from entering any property within the district to effect such fire control measures as deemed necessary by written order of Council's Authorised Fire Control Officers'.

If for any reason it is considered impracticable to comply with the provisions of the Order, a written application for a variation may be made to the Chief Executive Officer, to reach him not less than two weeks prior to the date by which the firebreak(s), are to be cleared.

No such application will be considered unless it bears the signature of the Fire Control Officer for the area in which the property is situated signifying that the Officer's agreement to the variation applied for. Failure to comply with this notice shall subject the offender to the penalties prescribed in the Bush Fires Act 1954 (as amended).

Restricted Burning Period: 15<sup>th</sup> September 1999-31<sup>st</sup> October 1999 Prohibited Burning Period: 1<sup>st</sup> November 1999-28<sup>th</sup> February 2000 Restricted Burning Period: 1<sup>st</sup> March, 2000-15<sup>th</sup> March, 2000.

Firebreak Order 1999/00

Pursuant to the powers contained in Section 33 of the Bush Fires Act 1954, owners and occupiers of property within the Shire of Brookton are hereby required, on or before the 1st day of December, 1999, to plough, cultivate, scarify, chemically spray or otherwise clear and thereafter maintain free of all flammable material until the 15th day of April, 2000, firebreaks as stipulated in the following positions.

#### Schedule

#### ON LAND OUTSIDE OF THE TOWNSITE BOUNDARY

- $1.1\,\mathrm{A}$  firebreak, which is at least 5 metres wide, must be installed around and within 15 metres of the following
  - a building, a haystack, a fuel drum, a fuel depot or any groupings of buildings, haystacks, fuel drums or fuel depots.

#### **BURNING OFF**

- 1.2 All landholders are required to have an operational independent, mobile, water filled fire fighting unit, having a water capacity of not less than 450 litres, within 50 metres of a paddock in which any burning off activity is being conducted during the *restricted* and *prohibited* burning periods. The tank of the unit shall be kept full of water at all times during the burning off.
- 1.3 During the *open* burning season all landholders are required to have a 2 metre firebreak cleared of all flammable material around any area to be burnt, or a fire fighting unit within 50 metres of any paddock in which burning off activity is being conducted.

## **DURING HARVESTING**

1.4 During any period when harvesting operations are being conducted there shall be provided in the same paddock or within 50 metres of that paddock an operational independent mobile water filled fire fighting unit, having a water capacity of not less than 450 litres. The tank of the unit shall be kept full of water at all times during the harvest operations. The responsibility to supply the unit being that of the landholder.

#### OPERATION OF PLANT AND MACHINERY

1.5 During the *prohibited* burning time all trucks, bulldozers and tractors shall not be operated on rural land unless fitted with a fire extinguisher.

A fire extinguisher means a device which comprises—

- (a) a container filled with at least 7.5 litres of water, and be capable of discharging that water under pressure and which is in a sound working condition, or
- (b) an approved operative chemical extinguisher.
- 1.6 During the prohibited burning time, all internal combustion motors being stationary and unattended shall not be operated unless clear of all flammable material immediately surrounding the said motor for a distance of not less than 5 metres.

#### LAND WITHIN THE BROOKTON TOWNSITE BOUNDARY

- $2.1\,\mathrm{All}$  land with an area of less than  $1000\mathrm{m}^2$  with no buildings, must be completely clear of all flammable material from the whole of the land.
- 2.2 All land with an area of less than 1000m2 with buildings or groupings of buildings must have an area cleared of flammable material no less than 2 metres wide, not more than 15 metres from such building or groups of buildings or the external boundary of the land—whichever is the nearer.
- $2.3\,\mathrm{All}$  land with an area of greater than  $1000m^2$  with no buildings must be completely surrounded by a firebreak of not less than 2 metres wide as near as possible to the boundary.
- 2.4 All land with an area of greater than 1000m² with buildings or groupings of buildings must have an area cleared of flammable material no less than 2 metres wide, not more than 15 metres from the building or groups of buildings or the external boundary of the land—whichever is nearer.

The firebreaks may be inspected shortly after the 14th day of November 1996, and the penalty for failing to comply with this notice is a fine of not more than \$1,000 or a penalty of \$40 may be incurred by the issue of an infringement notice, and a person in default is also liable, whether prosecuted or not, to pay the cost of performing the work directed in this notice if it is not carried out by the owner or occupier by the date required by this notice.

If it is considered to be impracticable for any reason to comply with the provisions of this notice, application may be made not later than the 1st day of November, 1996, in writing to the Council or its authorised officer for permission to provide alternative fire protection measures. If permission is not granted the requirements of this notice must be complied with.

If the requirements of this notice are carried out by burning, such burning must be in accordance with the relevant provisions of the Bush Fires Act 1954, which includes the necessity for permits to burn during the *restricted* and *prohibited* burning season.

Failure to comply with these requirements renders the offenders to the penalties prescribed in the Bush Fires Act 1954, as amended.

#### 1.0 PLAN OF SUBDIVISION

- 1.1 Subdivision of Special Residential Zone Area No. 11 shall be generally in accordance with the Subdivision Guide Plan endorsed by the Chief Executive Officer/Administrator.
- 1.2 The Council will not recommend lot sizes less than 4000m². Subdivision shall generally be in accord with the lot sizes and layout shown on the Subdivision Guide Plan. Any significant variation to the Subdivision Guide Plan will need to be justified in terms of land capability, visual impact, retention of views, vegetation retention, emergency access/egress and setbacks from King River and creeks. Consultation with and general support of surrounding landowners will be a prerequisite to consideration of any significant variation to the Subdivision Guide Plan.

#### 2.0 OBJECTIVES OF THE ZONE

Within Special Residential Zone Area No. 11 the objectives are to-

- 2.1 Allow for a range of lot sizes based on land capability and landscape design considerations.
- 2.2 Provide for the protection of the King River, creeklines and associated floodplains.
- 2.3 Integrate development with the landscape, protect remnant vegetation and revegetate areas in order to minimise visual impact.
- 2.4 Allow for tourist activities within Special Use Zones and appropriate rural uses on lots in excess of one hectare.

#### 3.0 LAND USE

- 3.1 Within Special Residential Zone Area No. 11 the following uses are permitted—
  - Residential Dwelling House
  - Home Occupation
- 3.2 The following uses may be permitted subject to the special approval of Council—
  - Public Utility
  - Cottage Industry
  - Livestock, grazing and agistment
  - Stables
  - Other incidental or non defined activities considered appropriate by Council which are consistent with the objective of the zone.

### 4.0 KEEPING OF LIVESTOCK/ANIMALS

4.1 Intensive agricultural pursuits such as piggeries, feed lotting, poultry farms are not permitted. The keeping of livestock shall be restricted to fenced pastured areas of the lot. The owner shall be responsible for the maintenance of stock proof fencing to protect remnant vegetation and revegetation areas. Animal numbers shall not exceed the stocking rates recommended by Agriculture W.A. The keeping of animals shall not result in the removal or damage of vegetation and trees or result in soil degradation and dust nuisance. The keeping and rearing of stock shall not be permitted on lots of less than 1 hectare, except for domestic purposes and in such cases shall not exceed one horse or one cow or two sheep.

- 4.2 Where in the opinion of Council the continued presence of animals on any portion of land is likely to contribute, or is contributing to the dust nuisance or soil degradation, notice may be served on the owner of the land, requiring immediate removal of those animals specified in the notice.
- 4.3 Where notice has been served on a landowner in accordance with clause 4.2, the Council may also require the land to be rehabilitated to its satisfaction within three (3) months of serving the notice. In the event that such action is not undertaken, Council may carry out such works as are deemed necessary, with all costs being borne by the landowner.

#### 5.0 FORESHORE MANAGEMENT PLAN

Council may request the Commission impose a condition at the time of subdivision to implement appropriate components of the foreshore management plan and fencing of foreshore reserves.

#### 6.0 LOCATION OF BUILDINGS AND STRUCTURES

- 6.1 Buildings, tanks and structures shall be located within the building envelope areas designated on the Subdivision Guide Plan.
- 6.2 The building envelope takes into account a number of factors which include—
  - · exclusion from the 100 year flood plain;
  - a minimum fifty metre setback from the King River and creekline.
  - A fifty metre setback from the foreshore footpath/bridlepath.
  - · 20 metre setback from revegetation areas.
  - 15 metre boundary setbacks with the exception of 30 metres for lots abutting Willyung Road.
  - · exclusion from areas subject to inundation during winter months.
- 6.3 Council may approve a lesser boundary setback if Council is of the opinion that (i) the topography or shape of the lot, or natural vegetation on it, makes it desirable to alter this provision and (ii) that the location of the building or structure will not detract from the environmental quality of the area or from the amenity of existing or future residences on adjoining lots. Council may require hydrological testing for footings and alternative wastewater effluent disposal systems

#### 7.0 BUILDING DESIGN, MATERIALS & COLOUR

- 7.1 Dwellings and outbuildings shall be designed and constructed of materials which allow them to blend into the landscape of the site. Council shall refuse to approve walls and roofs constructed of reflective materials such as unpainted zincalume and off-white colours. Council will be supportive of walls and roofs with green, brown or red tonings in keeping with the amenity of the area.
- 7.2 Dwelling houses shall not exceed 7.5 metres in height which is measured vertically from the natural ground level unless otherwise approved by council.
- 7.3 No boundary fencing shall be constructed of fibre cement, metal sheeting or wooden picket. If boundary fencing is utilised, it shall be of rural construction such as post and strand to the satisfaction of Council.
- 7.4 Any water tanks shall be coloured an appropriate natural shade of brown or green or suitably screened with vegetation in keeping with the amenity of the area to the satisfaction of Council.

#### 8.0 VEGETATION AND REVEGETATION

- 8.1 No clearing of vegetation shall occur except for—
  - (a) clearing to comply with the requirements of the Bush Fires Act 1954 (as amended);
  - (b) clearing may reasonably be required to construct an approved building and curtilage;
  - (c) trees that are diseased or dangerous;
  - (d) clearing to gain vehicular access to an approved dwelling or any other clearing which may be approved by the Council;
  - (e) clearing required to establish a low fuel buffer.
- 8.2 Council may request the Commission to impose a condition at the time of subdivision for revegetation of areas shown on the Subdivision Guide Plan. Such revegetation shall be appropriately maintained for a minimum of three years and preference should be given to local species. Revegetation areas adjacent to the King River and over the western creekline to be revegetated and fenced in accordance with Agwest's guidelines, as outlined in Amendment No. 177.
- 8.3 Additional tree planting may be required as a condition of development approval.

#### 9.0 WATER SUPPLY

In accordance with Western Australian Planning Commission policy, a reticulated supply should be provided to the proposed lots.

#### 10.0 EFFLUENT DISPOSAL

- 10.1 On-site effluent disposal shall be the responsibility of the individual landowner.
- 10.2 The disposal of liquid and/or solid wastes shall be carried out with an effluent disposal system approved by Council and the Health Department of WA. Systems shall be designed and located to minimise nutrient export and/or release into any waterway or ground water.

Conventional effluent disposal areas for new dwellings shall be set back a minimum of 100 metres from the natural permanent watercourse and situated 2 metres above the highest known ground water level.

10.3 Council shall require the use of amended soil type effluent disposal systems, such as Ecomax/ATU Systems in the following situations—

- where a 100 metre setback from a creek line or water course cannot be achieved;
- where soil conditions are not conducive to the retention of nutrients; and
- in low lying areas.

Separation from waterways and ground water shall be determined by Council in accordance with the Health Department of WA and Department of Environmental Protection guidelines.

10.4 Variations to the design or location of effluent disposal areas will require a suitably qualified practitioner demonstrating that effluent disposal will not cause environmental or health impacts to the satisfaction of Council and the Department of Health.

10.5 No more than one effluent disposal system will be permitted on one lot.

#### 11.0 BUSHFIRE MANAGEMENT CONTROL

- 11.1 Council may request the Commission to impose a condition at the time of subdivision for the construction of strategic firebreaks as shown on the Subdivision Guide Plan.
- 11.2 The strategic firebreaks shall be constructed to a standard suitable for all year access by heavy duty fire appliances and two wheel drive vehicles.
- 11.3 A "low fuel buffer" not less than 20 metres wide shall be provided and maintained around all residential buildings.
- 11.4 In cases where only part of the zone is developed, an interim firebreak system or strategic fire break system shall be prepared and put in place, to the satisfaction of Council and the Bush Fires Service of WA.
- 11.5 Council may request the Commission to impose a condition at the time of subdivision for a contribution towards the provision of fire fighting facilities.
- 11.6 Fire hydrants shall be provided at intervals of 200 metres along subdivisional water mains.
- 11.7 The subdivider shall make arrangements to the satisfaction of Council to ensure prospective purchasers are aware of the fire management guidelines of the Home Owners Bushfire Survival Manual and the Australian Standard 3959 "Construction of Buildings in Bushfire Prone Areas."

#### 12.0 ROAD UPGRADING, ACCESS AND DESIGN AND STORMWATER MANAGEMENT

- 12.1 Council may request the Commission to impose a condition at the time of subdivision for a contribution to the upgrading of Willyung Road.
- 12.2 Roads and bridges within the 100 year floodplain shall be designed and constructed to minimise obstruction to floodwaters to Council's satisfaction.
- 12.3 All stormwater shall be disposed of in a manner that meets water sensitive guidelines and avoids the need for detention basins within the foreshores of the river or creeks to the satisfaction of Albany Waterways Management Authority and Council.

#### 13.0 NOTIFICATION OF PROSPECTIVE OWNERS

- 13.1 Provision shall be made to Council's satisfaction to ensure prospective purchasers of land within Special Residential Zone Area No. 11 are given a copy of these Special Provisions prior to entering into an agreement to acquire any property.
- 13.2 Council may request the Commission impose a condition at the time of subdivision for the preparation and distribution to prospective purchasers of an information sheet which outlines the objectives of the river wildlife corridor, discourages the keeping of pets on lots adjacent to the corridor and promotes measures that should be taken to minimise the impacts pets have on native fauna (eg, night cat curfews, keeping dogs on leashes etc).
- 13.3 Application for Planning Scheme Consent shall require the submission of—
  - (i) a completed "Application for Grant of Planning Scheme Consent" form;
  - (ii) three copies of a Plan showing the precise location and size of all the buildings proposed and the parkland clearing and fire protection measures to be adopted;
  - (iii) three scaled elevation plans showing the elevation of the buildings proposed and the materials and colour's to be used.

However, Council shall encourage mixture of commercial activity, particularly along the waterfront edge, the waterfront square, and Casuarina Drive; (xxiv) Development around the waterfront market square shall be predominantly commercial in nature, to promote a high level of usage and activity within the waterfront square.
