RESTRICTION OF PEARLING AND HATCHERY ACTIVITIES (NEEDLE ROCK) NOTICE 1999 FD 1205/98 [327]

Made by the Minister under section 19.

Citation

1. This notice may be cited as the *Restriction of Pearling and Hatchery Activities (Needle Rock) Notice* 1999.

Cessation

2. This notice will cease operation on 30 November 2000.

Interpretation

3. In this notice—

"holding site" means the area bounded by a line commencing at the intersection 15° 27.925' south latitude and 124° 29.924' east longitude; thence to the intersection of 15° 28.445' south latitude and 124° 29.924' east longitude; thence to the intersection of 15° 28.505' south latitude and 124° 29.144' east longitude; thence to the intersection of 15° 28.295' south latitude and 124° 29.144' east longitude; thence in a straight line to the commencement point (AGD 84);

"operator" means Paspaley Pearling Company Pty Ltd (ACN 009 591 708).

General restriction of pearling and hatchery activities

4. A person other than the operator must not undertake any pearling or hatchery activity in the holding site.

Restriction of pearling and hatchery activities by the operator

- 5. The operator must not undertake any pearling or hatchery activity in the holding site other than—
 - (a) the activity of temporarily holding seeded pearl shells prior to transport to a pearl oyster farm; and
 - (b) in the manner specified in the Executive Director's letter to the operator dated 27 October 1999.

- (d) Modify Part 5 to read as follows: Part 5—City Centre Shopping, Commercial, Office and Mixed Business/Residential Zones.
- (e) Insert the following new clauses—

5.2.4 Mixed Business/Residential Zone

Zone intended to accommodate the development of land for a suitable mix of residential, office and consulting room uses and a variety of complementary activities that are deemed compatible by Council. In particular, attention will be given to—

- Achieving an suitable balance and distribution of residential, office and consulting room land uses;
- Promoting an integrated design with adjoining lots and roads that will avoid land use and traffic conflicts;
- The retention, maintenance and enhancement of existing characteristics of the area that, in the opinion of Council, are integral to the area such as residential amenity, historic built form or any other heritage conservation matter, vegetation, streetscape appearance and topography;
- High standards of architectural design in promoting the integral characteristics of the area with regard to promoting a place for work, living and recreation; and
- Encouraging the retention and reuse of existing residential buildings that contribute to the residential character of the area.
- 5.3.3 The following plot ratios to apply in the City Centre Mixed Business/Residential Zone—
 - 1.0 where a building contains a residential component of not less than 40% of the total floorspace of the development;

- Where a building contains a residential component of less than 40% of the total floorspace of the development or is used solely for residential purposes the plot ratio shall not exceed that prescribed in the Residential Planning Codes for R60.
- 0.5 where a building does not contain any residential component.
- (f) Renumber the existing Clause 11.4.1 (q) as Clause 11.4.1 (r) and introduce the following new text for Clause 11.4.1 (q)—

The need for the Mixed Business/Residential zone to contain a significant residential component.

- (g) Modify Clauses 5.4.1, 5.13 and 7.6 to read as follows—
 - 5.4.1 The site coverage of buildings in the City Centre shopping, Commercial, Office and Mixed Business/Residential Zones, shall be determined by Council.
 - 5.13 Where an application for planning consent is made for residential purposes in the City Centre Shopping, Commercial, Office and Mixed Business/Residential Zones, the Residential Planning Code R60 shall apply, unless in any particular case the Council decides that a Residential Planning Code of a lower density is to apply.
 - 7.6 Areas for the loading/unloading of vehicles carrying goods or commodities to or from premises within the City Centre Shopping, Commercial, Office and Mixed Business/Residential Zones shall be incorporated behind appropriate screen walling into any approved development plans to the requirements of Council and shall be subsequently provided and maintained as part of the that development.
- 2. Rezone the following lots in Armadale from "Residential R40" to "Mixed Business/Residential" and modify the Town Planning Scheme Maps accordingly—
 - 1, 4, 83 and 84 Church Avenue;
 - · 125 and 126 corner Church Avenue and Third Road;

 - Pt 130 corner South Western Highway and Third Road;
 - 124, 127, 128 and 129 Third Road:
 - 109 and 200 corner Church Avenue and Thomas Street;
 - · 107 and 110 Thomas Street;
 - 83 and 201 corner Church Avenue and Fourth Road;
 - · 5 and 82 Fourth Road;

 - 56 and 59 William Street;

NOTICE OF PROPOSED AMENDMENT (SECTION 33) TO THE METROPOLITAN REGION SCHEME

Metropolitan Region Scheme Amendment No. 992/33 Clarkson-Butler

CALL FOR PUBLIC SUBMISSIONS

The Western Australian Planning Commission intends to amend the Metropolitan Region Scheme (MRS) for land in the Cities of Joondalup and Wanneroo and is seeking public comment.

Purpose

The proposed Clarkson-Butler amendment is intended to facilitate the implementation of important elements of the Commission's *North West Corridor Structure Plan (1992)* in relation to the Parks and Recreation, Public Purposes, Railways, Primary Regional Roads and Other Regional Roads reservations and the Rural, Urban and Urban Deferred zones.

The inclusion of the necessary zones and reservations in the MRS will formalise long term planning within the North West Corridor. These include the alignments for the future extension of the Northern Suburbs Passenger Railway and the Mitchell Freeway.

Environmental Review (Amendment No. 1139)

The Environmental Protection Authority (EPA) required an Environmental Review for six of the eleven proposals in the Amendment. These proposals relate to the rezoning of part lot 2 Burns Beach and the northern portion of lot 17; the reservation of two east-west roads and the Mitchell Freeway Transportation Corridor including a railcar depot; and the rationalisation of Wanneroo Road.

Separate Environmental Review reports have been prepared for each of the six proposals assessed by the EPA, along with an Environmental Review Summary Report. These examine the potential environmental impacts associated with the implementation of the amendment, and put forward proposed environmental management measures.

The Environmental Review Summary Report and associated separate reports are being advertised concurrently with the Metropolitan Region Scheme amendment so that environmental matters related to the Amendment can be commented on.
