# **Home Building Contracts Amendment Regulations 2000**

Made by the Governor in Executive Council.

### 1. Citation

These regulations may be cited as the *Home Building Contracts* Amendment Regulations 2000.

### 2. The regulations amended

The amendments in these regulations are to the *Home Building* Contracts Regulations 1992\*.

### 3. Regulation 4A inserted

After regulation 4 the following regulation is inserted —

### 4A. Special condition for GST adjustments

- (1) This regulation applies in relation to contracts signed after this regulation comes into operation and before 1 July 2000.
- (2) When this regulation applies, the forms of contracts set out in Schedules 2 to 7 are taken to include a special condition in the form set out in Schedule 8.

### 4. Schedule 8 inserted

After Schedule 7 the following Schedule is inserted —

"

# Schedule 8 — Special conditions for GST adjustments

[r. 4A]

- (a) This special condition will apply if:
  - (i) this Contract is signed before 1 July 2000 and a supply is made under this Contract on or after 1 July 2000;
  - (ii) the Builder is registered or required to be registered for the purposes of the GST Act and has incurred further costs or had further costs imposed as a direct consequence of the introduction of the GST Act; and
  - (iii) the Builder has sought to claim the amount of GST payable on any supply made under this Contract as an adjustment to the Contract Price.
- (b) The Contract Price is to be adjusted for the amount of GST payable on each supply made under this Contract on or after 1 July 2000 and any reduction in the price of goods or materials to reflect the full effect of the repeal of wholesale sales tax.
- (c) If the Builder claims an adjustment to the Contract Price pursuant to this Special Condition the Builder must give the Owner a notice setting out details of the adjustment including the way in which the price adjustment has been calculated and must state that the adjustment is solely the result of the introduction of the GST Act.
- (d) Each adjustment to the Contract Price because of the amount of the GST payable on the supply or the repeal of wholesale sales tax is to be made by the Builder claiming or allowing a change to the price of the Works in a progress or final claim. Where the cost of a supply which is covered by a progress claim has both increased and decreased the net result of the change is to be claimed or allowed.

- (e) The Builder is not entitled to claim the amount of GST payable on any supply made under this Contract on or after 1 July 2000 as an adjustment to the Contract Price unless:
  - the value of all work and materials permanently incorporated in or affixed to the Site as at
     1 July 2000 has been determined in accordance with the requirements of Section 19 of the Transition Act:
  - (ii) the supply to which the claim for payment of GST relates has been made under this Contract at the time of the claim; and
  - (iii) the valuation required by this Special Condition is the obligation of the Builder and is at the Builder's cost.
- (f) In this special condition:
  - "GST Act" means A New Tax System (Goods and Services Tax) Act 1999 of the Commonwealth;
  - "Transition Act" means A New Tax System (Goods and Services Tax Transition) Act 1999 of the Commonwealth;
  - "GST" and "supply" have the meanings given to those terms in the GST Act.

# **Sentencing Amendment Regulations 2000**

Made by the Governor in Executive Council.

# Part 1 — Preliminary

### 1. Citation

These regulations may be cited as the *Sentencing Amendment Regulations 2000*.

# Part 2 — Sentencing Regulations 1996

### 2. Regulations amended

The amendments in this Part are to the *Sentencing Regulations 1996*\*.

### 3. Regulations 5A and 5B inserted

After regulation 5 the following regulations are inserted —

# 5A. Re-sentencing of offender — courts of summary jurisdiction and Children's Court (s 37A)

- (1) This regulation applies to an application (a "lower court application") under section 37A(2) of the Act in relation to a sentence imposed by a court of summary jurisdiction or the Children's Court.
- (2) A lower court application must be in an approved form and may be made at any time.
- (3) A lower court application must be lodged with the court that imposed the sentence concerned.
- (4) On receiving a lower court application, a court officer is to issue a summons (in an approved form) to all parties concerned to a hearing on a date and at a place fixed by the officer.
- (5) The summons must be served by the prosecutor on the offender.
- (6) If satisfied that all parties concerned have been served with a summons issued under this regulation, the court may, subject to section 14 of the Act, exercise the powers in section 37A(1) of the Act.
- (7) The court hearing a lower court application need not be constituted by the same judicial officer that constituted the court that imposed the sentence.

### 5B. Re-sentencing of offender — superior courts (s 37A)

- (1) This regulation applies to an application (a "superior court application") under section 37A(2) of the Act in relation to a sentence imposed by a superior court.
- (2) A superior court application must be made in accordance with rules of court to the court that imposed the sentence concerned.
- (3) If satisfied that all relevant rules of court have been complied with in relation to the superior court application, the court may, subject to section 14 of the Act, exercise the powers in section 37A(1) of the Act.

(4) The court hearing a superior court application need not be constituted by the same judicial officer that constituted the court that imposed the sentence.

".

  - " court of summary jurisdiction ".

### **LOCAL GOVERNMENT ACT 1995**

TOWN OF VICTORIA PARK REPEAL LOCAL LAW 2000

Under the powers conferred by the *Local Government Act 1995* and all other powers, the Council of the Town of Victoria Park resolved to make the following Local Law on the 8th February 2000.

### **ARRANGEMENT**

PART 1—PRELIMINARY ...... Clauses 1-3
PART 2—REPEAL ...... Clause 4

### PART 1—PRELIMINARY

### Title

1. This Local law may be referred to as the *Town of Victoria Park Repeal Local Law 2000*.

### **Commencement**

2. This Local law comes into operation 14 days after the date of its publication in the  $Government\ Gazette$ .

### Purpose and Intent

- 3. (1) The purpose of this local law is to repeal those local laws made obsolete by new legislation or considered no longer relevant within the Town of Victoria Park.
- (2) The effect of this Local law is to repeal obsolete or outdated local laws within the Town of Victoria Park

### PART 2—REPEAL

- 4. The following Local laws of the Town of Victoria Park relating to—
  - (1) Awnings over Streets (No. 58): as published in the *Government Gazette* on 6 January 1959 and amended;
  - (2) Motels (No. 72): as published in the *Government Gazette* on 11 May 1961 and amended;
  - (3) Verandahs over Streets (No. 73): as published in the *Government Gazette* on 15 February 1962 and amended;
  - (4) Air Conditioning Units (No. 74): as published in the *Government Gazette* on 8 July 1964 and amended;

are repealed on the day this local law comes into operation.

General Description

The Hon Minister for Planning has granted approval to the declaration of a Planning Control Area over land at Badgerup Lake, as shown on Western Australian Planning Commission Plan No. 3.1240.

### Purpose of The Planning Control Area

The purpose of the Planning Control Area is to protect the regionally significant vegetation. The Commission considers that the Planning Control Area is required to ensure that no development occurs on this land which might prejudice this purpose until it may be reserved for the purpose of Parks and Recreation in the Metropolitan Region Scheme.

### Duration And Effects

The declaration remains in effect for a period of five years from the date of publication of this notice in the *Government Gazette* or until revoked by the Western Australian Planning Commission with approval by the Minister, whichever is the sooner.

A person shall not commence and carry out development in a Planning Control Area without the prior approval of the Western Australian Planning Commission.
