Environmental Protection Act 1986

### **Environmental Protection Amendment Regulations (No. 4) 2000**

Made by the Administrator in Executive Council on the recommendation of the Environmental Protection Authority.

**1. Citation**

These regulations may be cited as the *Environmental Protection Amendment Regulations (No. 4) 2000*.

**2. Commencement**

These regulations come into operation on 1 October 2000.

**3. The regulations amended**

The amendments in these regulations are to the *Environmental Protection Regulations 1987\**.

**4. Regulation 4 amended**

Regulation 4(5) is repealed and the following subregulations are inserted instead —

“

- (5) In this Part (other than regulation 5G) and in Schedule 3 fee amounts are expressed in units or fractions of a unit, one unit being equivalent to the amount specified in column 2 of the Table to this subregulation during the period specified in column 1 of that Table.

##### WATER SKI AREA

##### WHITFORDS—MULLALOO

Department of Transport,  
Fremantle WA, 4 August 2000.

Acting pursuant to the powers conferred by Section 48A of the Navigable Waters Regulations the Department of Transport by this notice revokes paragraph (1)(a)(15) of Notice MH404 as published in the Government Gazette of 25 October 1991 relating to the Water Ski-ing area known as Whitfords-Mullaloo and substitutes the following—

Whitfords-Mullaloo: All those waters contained within an area commencing at a point 31° 48.1914'S, 115° 43.7274'E on the foreshore being approximately 300 metres north of Pinnaroo Point; thence extending seaward on a bearing of 290 degrees towards Whitford Rock for a distance of 400 metres; thence in a northerly direction for 1450 metres; thence in an easterly direction to a point on the foreshore being approximately 400 metres south of the Mullaloo Surf Life Saving Clubhouse.

Provided however that no water ski-ing shall take place within 200 metres from the foreshore, except within the water-ski take-off area (marked by signage and buoys) which extends for 150 metres north of the above-mentioned point of commencement.

This take-off area is only to be used for the purpose of towing a water skier from the shore or returning to the foreshore, providing that on Saturdays, Sundays and Public Holidays, the water ski area may be closed after 1200 hrs. (all coordinates based on GDA94).

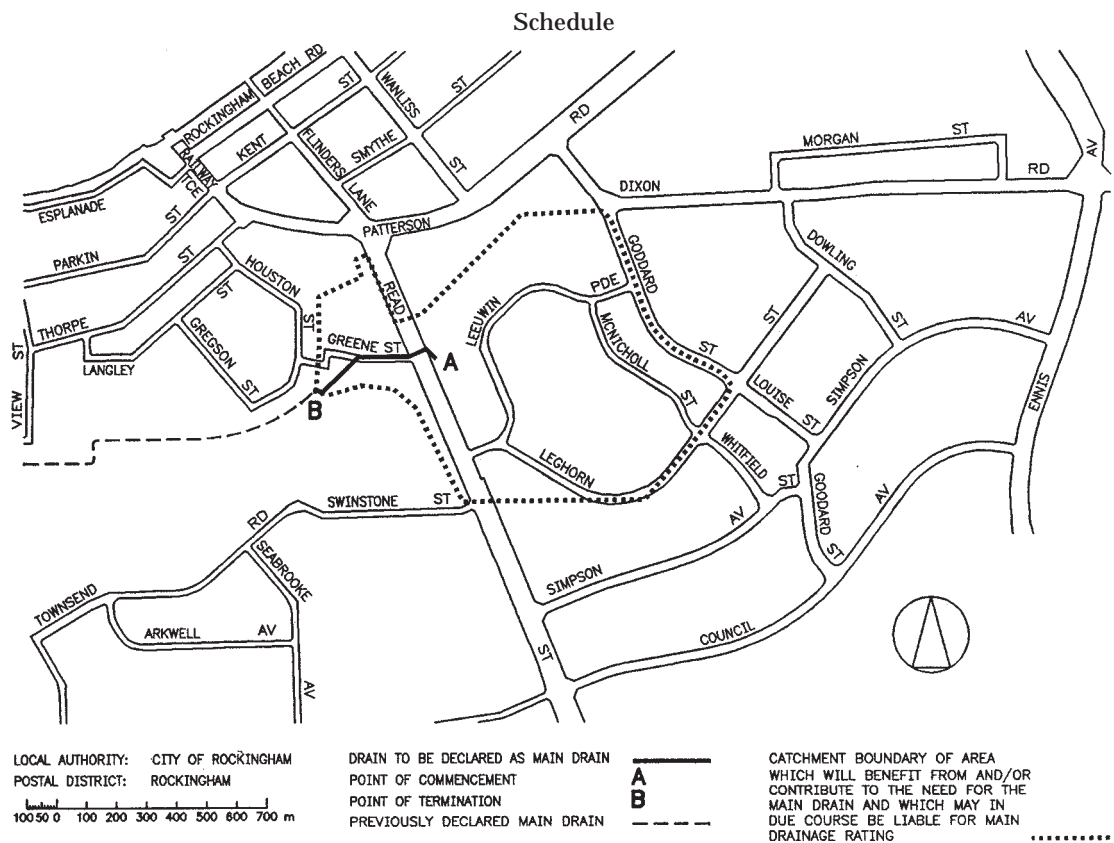
