Fish Resources Management Act 1994

# Fish Resources Management Amendment Regulations (No. 3) 2000

Made by the Governor in Executive Council.

# 1. Citation

These regulations may be cited as the *Fish Resources Management Amendment Regulations* (*No. 3*) 2000.

# 2. The regulations amended

The amendments in these regulations are to the *Fish Resources* Management Regulations 1995\*.

# 3. Regulation 14 amended

Regulation 14 is amended as follows:

- (a) after paragraph (f), by deleting "and";
- (b) after paragraph (g), by deleting the full stop and inserting instead
  - "; and ";
- (c) at the end of the regulation, by inserting the following paragraph
  - (h) Division 4E Bag limit for trout in, and other restrictions on fishing at, Lake Navarino (Waroona Dam).

# 4. Part 4 Division 4E inserted

After regulation 30I the following Division is inserted —

# Division 4E — Bag limit for trout in, and other restrictions on fishing at, Lake Navarino (Waroona Dam)

30J. Bag limit for trout in Lake Navarino (Waroona Dam)

For the purposes of section 50 of the Act, the bag limit in respect of —

(a) brown trout;

".

- (b) rainbow trout; or
- (c) a combination of brown trout and rainbow trout,

taken from the waters of Lake Navarino (Waroona Dam) and its tributaries is 2 trout.

# 30K. Restrictions on fishing at Lake Navarino (Waroona Dam)

 A person must not fish in the waters of Lake Navarino (Waroona Dam) or its tributaries using as a bait or lure anything other than an artificial lure.

Penalty: \$2 000.

(2) In subregulation (1) —

"artificial lure" includes —

- (a) a lure that is made of feather, fur, wool or any other material and that is known as an artificial fly; and
- (b) a lure that incorporates a spinning device or another device that causes the lure to move.
- (3) A person must not fish in the waters of Lake Navarino (Waroona Dam) or its tributaries during the period beginning on 1 May in any year and ending on 31 August in that year.

Penalty: \$2 000.

# 5. Regulation 61 amended

- (1) Regulation 61(3) is amended as follows:
  - (a) in paragraph (a), by deleting "waterproof cardboard,";
  - (b) in paragraph (c), by deleting "100 millimetres in length and not less than 60 millimetres" and inserting instead —

(2) After regulation 61(3) the following subregulation is inserted —

(3a) In relation to rock lobster, the reference in subregulation (3)(b) to the exterior of any package, container or receptacle ("the package") is a reference to an exterior side surface of the package and does not include a reference to the exterior upper or lower surface of the package. ٤٢

- (3) Regulation 61(5) is amended as follows:
  - (a) by deleting "specify " and inserting instead —
    " clearly identify ";
  - (b) after paragraph (a), by deleting "and";
  - (c) in paragraph (b), by deleting "fish and the initial letter of the port from which the boat operates." and inserting instead —
    - " fish; and ";
  - (d) at the end of the subregulation, by inserting the following paragraph
    - "
- (c) the fishery, and if applicable the area or zone of the fishery, from which the fish were taken.

#### 6. Regulation 118A inserted

After regulation 118 the following regulation is inserted —

118A. Authority conferred by fishing boat licence of no effect if managed fishery licence authorises use of same boat

At any time when a managed fishery licence —

- (a) has been granted in respect of the West Coast Rock Lobster Managed Fishery declared under the West Coast Rock Lobster Management Plan 1993;
- (b) authorises the use in that fishery of the same boat in respect of which a fishing boat licence is in force; and
- (c) confers a total pot entitlement of less than 63 units,

the authority conferred by the fishing boat licence referred to in paragraph (b) is of no effect.

# 7. Schedule 2 amended

Schedule 2 Part 2 Division 1 is amended by deleting the definition of "setose" and inserting the following definition instead —

**"setose"** means a female rock lobster that has fine hair-like filaments (*ovigerous setae*) —

(a) for the attachment of eggs on the branched structures (*biramous endopodites*) forming part of the swimmerets (*pleopods*) underneath its tail; or

(b) that, although not capable of the attachment of eggs as described in paragraph (a), are in the process of lengthening as part of the development of the rock lobster to sexual maturity;

# **District of Cockburn (Change of Ward Boundaries and Representation) Order 2000**

Made by the Governor in Executive Council.

# 1. Citation

This order may be cited as the *District of Cockburn (Change of Ward Boundaries and Representation) Order 2000.* 

# 2. Abolition of existing wards

Under section 2.2(1)(d) of the Act, on and after 6 December 2000 the following wards in the District of Cockburn are abolished —

- (a) the Coastal Ward;
- (b) the North Ward;
- (c) the South Ward.

## 3. New ward created

- Under section 2.2(1)(b) of the Act, on and after
   6 December 2000 a new ward called the Central Ward is created in the District of Cockburn.
- (2) The Central Ward consists of the land described in Schedule 1.

# 4. Change of ward boundaries

Under section 2.2(1)(c) of the Act, on and after 6 December 2000 —

- (a) the boundaries of the East Ward in the District of Cockburn are changed so that the ward consists of the land described in Schedule 2; and
- (b) the boundaries of the West Ward in the District of Cockburn are changed so that the ward consists of the land described in Schedule 3.

## 5. Number of councillors changed

- Under section 2.18(3)(a) of the Act, on and after
   6 December 2000 the number of offices of councillor on the council of the City of Cockburn is changed from 14 to 9.
- (2) Under section 2.18(3)(b) of the Act, on and after6 December 2000 the number of offices of councillor is 3 for each of the East Ward, the Central Ward and the West Ward.

## 6. Proposed poll — directions under s. 9.62 of the Act

- Part 4 of the Act applies to preparing for and conducting the proposed poll as if the amendments effected by clauses 2, 3, 4 and 5 had taken effect on the day on which this order commenced.
- (2) For the purposes of subsection (1)
  - (a) Part 4 of the Act is modified to the extent necessary to give effect to the direction in subclause (1); and
  - (b) without limiting paragraph (a), a reference in that Part to a ward, in relation to the District of Cockburn, is to be read as a reference to the Central Ward, the East Ward or the West Ward as described in Schedule 1, 2 or 3 respectively.

**"proposed poll"** means the poll for the election of a new council for the City of Cockburn that is to be held on 6 December 2000, being the day fixed for that purpose by clause 5 of the *City of Cockburn (Dismissal of Council) Order 2000.* 

# Schedule 1 — Description of land in Central Ward

[cl. 3(2)]

All that portion of land bounded by lines starting from the intersection of the Low Water Mark of the Indian Ocean with the prolongation westerly of the northernmost boundary of Clarence Lot 177 (Reserve 40184), a point on a present western boundary of the City of Cockburn and extending easterly to and easterly, southerly and again easterly along boundaries of that lot and onwards to the centreline of Cockburn Road; thence generally southeasterly along that centreline to the prolongation westerly of the northernmost northern boundary of Lot 303, as shown on Office of Titles Diagram 66976; thence easterly to and easterly, southeasterly and again easterly to a western boundary of Lot 170 (Reserve 8710); thence generally southerly, generally northeasterly and northerly along boundaries of that lot and onwards to the centreline of Mayor Road; thence easterly along that centreline to the prolongation southerly of the centreline of Hamilton Road; thence northerly to and northerly and generally northeasterly along that centreline to the prolongation westerly of the centreline of Troode Road; thence easterly to and along that centreline and onwards to the centreline of Rockingham Road; thence generally northwesterly and generally northerly along that centreline to the prolongation westerly of the centreline of Barrington Street; thence easterly to and along that centreline to the centreline of an undedicated portion of Stock Road; thence generally northerly along the centrelines of dedicated and undedicated portions of that road to the centreline of Winterfold Road, a point on a present northern boundary of the City of Cockburn and thence generally easterly along boundaries of that city to the centreline of North Lake Road; thence generally southerly and generally southeasterly along the centreline of dedicated and undedicated portions of that road to the prolongation northeasterly of the centreline of Hammond Road; thence southwesterly to and southwesterly, southerly, southeasterly and generally southerly along that centreline to the prolongation easterly of the southern boundary of Lot 501, as shown on Office of Titles Diagram 97689; thence westerly to and along that boundary to the centreline of Branch Circus; thence southerly, generally southwesterly, generally southeasterly and again generally southwesterly along that centreline to the easternmost northern boundary of the southern severance of Cockburn Sound Location 2726 (Class A Reserve 15556); thence easterly and southerly along boundaries of that severance and onwards to a western side of Frankland Avenue; thence southerly, easterly and generally southerly along sides of that avenue to the southeastern corner of Location 2022 (Reserve 27057), a point on a present southern boundary of the City of Cockburn and thence generally easterly, generally northerly, generally westerly and generally northeasterly along boundaries of that city to the starting point.

# Schedule 2 — Description of land in East Ward

[cl. 4(a)]

All that portion of land bounded by lines starting from the intersection of the centreline of Winterfold Road with the centreline of North Lake Road, a point on a present northern boundary of the City of Cockburn, and extending generally southerly and generally southeasterly along the centreline of dedicated and undedicated portions of North Lake Road to the prolongation northeasterly of the centreline of Hammond Road; thence southwesterly to and southwesterly, southerly, southeasterly and generally southerly along that centreline to the prolongation easterly of the southern boundary of Lot 501, as shown on Office of Titles Diagram 97689; thence westerly to and along that boundary to the centreline of Branch Circus; thence southerly, generally southwesterly, generally southeasterly and again generally southwesterly along that centreline to the easternmost northern boundary of the southern severance of Cockburn Sound Location 2726 (Class A Reserve 15556); thence easterly and southerly along boundaries of that severance and onwards to a western side of Frankland Avenue; thence southerly, easterly and generally southerly along sides of that avenue to the southeastern corner of Location 2022 (Reserve 27057), a point on a present southern boundary of the City of Cockburn and thence easterly, generally northerly, generally northeasterly and generally northwesterly along boundaries of that city to the starting point.

# Schedule 3 — Description of land in West Ward

[cl. 4(b)]

# Road Traffic (Drivers' Licences) Amendment Regulations (No. 3) 2000

Made by the Governor in Executive Council.

## 1. Citation

These regulations may be cited as the *Road Traffic (Drivers' Licences) Amendment Regulations (No. 3) 2000.* 

# 2. Commencement

These regulations come into operation on 18 September 2000.

# **3.** The regulations amended

The amendments in these regulations are to the *Road Traffic* (*Drivers' Licences*) Regulations 1975\*.

# 4. Regulation 5A amended

- (1) Regulation 5A(1) is repealed and the following subregulation is inserted instead
  - "
    - (1) Unless subregulation (2) or (3) applies, a driver's licence may be issued or renewed to have effect for
      - (a) if paragraph (b) does not apply, a period of 12 months or 5 years, as elected by the applicant for the licence; or
      - (b) if a driver's licence is issued to a person who holds a corresponding licence in another State or a Territory —
        - (i) a period equal to the period for which the corresponding licence still has effect; or
        - (ii) a period of 5 years,

whichever is the lesser.

(2) Subregulations (2) and (3) are amended by inserting after "period" —

", not exceeding 5 years, ".

(3) After regulation 5A(3) the following subregulation is inserted —

"

(4) If a driver's licence is issued to a person who holds a corresponding licence in another State or a Territory, the period determined under subregulation (2) or (3) cannot be more than the period for which the corresponding licence still has effect.

#### RETAIL TRADING HOURS (TOWNSITE OF NORTHAM) EXEMPTION ORDER 2000

Made by the Minister for Fair Trading under Section 5 of the Act.

#### **1** Citation

This order may be cited as the Retail Trading Hours (Townsite of Northam) Exemption Order 2000.

#### 2 Interpretation

In this order—

"motor shop" means a general retail shop or portion of a general retail shop, as the case requires—

- a) in, on or from which motor vehicles are sold by way of a retail sale; or
- b) in, on or from which spare parts are sold by way of retail sale in conjunction with the sale of motor vehicles.

#### **3 Application**

(1) This order applies to all general retail shops, other than motor shops, within the town boundaries of the townsite of Northam.

(2) This order does not affect the operation of the Retail Trading Hours Exemption Order (No. 12) 1994.

#### **4** Commencement

This Order comes into operation on the day on which it is published in the Government Gazette.

#### **5 Exemptions**

Each general retail shop to which this order applies is exempted from section 12(1)(d) of the Act on 17 December 2000 and 24 December 2000 provided the shop is closed on those days until 12.00 noon and from and after 6.00pm.

**6** Each general retail shop to which this order applies is exempted from section 12(1)(a) of the Act on 20 December 2000 and 22 December 2000 provided the shop is closed on those days until 8.00am and from and after 9.00pm.
