# Crimes (Confiscation of Profits) (Corresponding Laws) Amendment Regulations 2000

Made by the Governor in Executive Council.

# 1. Citation

"

These regulations may be cited as the *Crimes (Confiscation of Profits) (Corresponding Laws) Amendment Regulations 2000.* 

### 2. The regulations amended

The amendments in these regulations are to the *Crimes* (*Confiscation of Profits*) (*Corresponding Laws*) *Regulations 1990*\*.

## **3. Regulation 2 amended**

Regulation 2 is amended by deleting the definition of "the Queensland Act".

# 4. Regulations 16, 17, 18, 19 and 20 replaced

Regulations 17, 18, 19 and 20 are repealed and the following regulations are inserted instead —

16. Declaration — corresponding laws

- (1) The *Crimes (Confiscation of Profits)* Act 1989 of Queensland, as amended from time to time, is declared to be a law which corresponds to the Act.
- (2) The *Crimes (Confiscation) Act 1989* of Queensland, as amended from time to time, is declared to be a law which corresponds to the Act.

# **17. Declaration** — forfeiture order

A forfeiture order made —

- (a) under section 8(1) of the *Crimes (Confiscation of Profits)* Act 1989 of Queensland; or
- (b) under section 23(1) of the *Crimes* (*Confiscation*) *Act 1989* of Queensland,

is declared to be an order within the definition of "interstate forfeiture order" in section 3(1) of the Act.

# **18.** Declaration — special forfeiture order

A special forfeiture order made —

- (a) under section 60 of the *Crimes (Confiscation of Profits) Act 1989* of Queensland; or
- (b) under section 86(1) of the *Crimes* (*Confiscation*) *Act 1989* of Queensland,

is declared to be an order within the definition of "interstate forfeiture order" in section 3(1) of the Act.

# **19.** Declaration — pecuniary penalty order

A pecuniary penalty order made ----

- (a) under section 13(1) of the *Crimes (Confiscation of Profits)* Act 1989 of Queensland; or
- (b) under section 34(1) of the *Crimes* (*Confiscation*) *Act 1989* of Queensland,

is declared to be an order within the definition of "interstate pecuniary penalty order" in section 3(1) of the Act.

## 20. Declaration — restraining order

A —

- (a) restraining order made under section 17 of the *Crimes (Confiscation of Profits) Act 1989* of Queensland;
- (b) restraining order made under section 40 of the *Crimes (Confiscation) Act 1989* of Queensland; or
- (c) further order (relating to an order under paragraph (b) of this regulation) made under section 45 of the *Crimes (Confiscation) Act 1989* of Queensland,

is declared to be an order within the definition of "interstate restraining order" in section 3(1) of the Act.

#### LOCAL GOVERNMENT ACT 1995

TOWN OF CLAREMONT

#### AMENDMENTS TO LOCAL LAW RELATING TO SIGNS

That under the powers conferred by the *Local Government Act 1995* (the Act) and under all the powers enabling it, the Council of the Town of Claremont resolves on 3rd day of October 2000 to amend the Local law Relating to Signs which was published in the *Government Gazette* on 15 March 2000 and to proceed with amending the Local Law in accordance with Section 3.12 of the Act as follows—

(a) Amend Clause 5.1 by deleting the definition of 'Election Sign' and substituting the following—

'Election Sign'

"Means a bill, poster, placard or advertisement relating to an election or a prospective or forthcoming election of Parliament of the Commonwealth or the State or municipal elections and to a referendum, but does not include a sign erected by Council for public information";

- (b) Amend Clause 7 by—
  - (i) Substituting the words 'Any sign complying with Clause 32' for the words 'A sale sign not exceeding 1m<sup>2</sup> in subclause 7.1.2.';
  - (ii) Inserting the words *Temporary community signs or notices or* at the commencement of subclause 7.1.4;
  - (iii) Inserting a new subclause—
    - *'7.1.9 an Election Sign from a period of three weeks before the subject election to three days following that election';*
  - (iv) Inserting a new subclause—
    - *'7.1.10* Temporary residential type signs such as "garage sale" signs providing the sign is displayed only on the land where the sale is being held and the sign does not exceed 0.2m<sup>2</sup> in area and it is displayed for no more than three consecutive days';
  - (v) Inserting a new subclause—
    - 7.1.11 A portable sign not exceeding 1 metre in height and 0.8 metres in width that is placed on privately owned land, it is the only

portable sign to be on that land and is located at least 1 metre inside the front boundary of that land';

- (c) Amend subclause 14.1 by—Substituting the word '*five*' for the word '*four*' in line (3);
- (d) Amend subclause 29.3 by—
   Inserting the words 'in any road reserve, street or way' immediately after the word 'permitted' in line (1);
- (e) Amend subclause 32.4 (a) by—Substituting the figure '1.5' for the figure '1'.

2. WIDTH AND MANNER DESCRIBED

(a) Rural Land

At least 3 metres wide and not more than 100 metres from the perimeter of all buildings and/ or haystacks or groups of buildings and/or haystacks so as to completely surround the buildings, haystacks and/or fuel dumps or so as to effectively surround the buildings, haystacks and/or fuel dumps which may be combined with strategic breaks e.g. roads, clear ground etc, with an effective cleared width of 3 metres.

- (b) Townsite Land
  - 1. If lot is 2024m<sup>2</sup> (1/2 acre) or less, clear of all flammable material from the whole of the area. Acceptable methods of clearing include grazing, mowing, grading or burning.

- 2. If lot is larger than  $2024m^2$  (1/2 acre), there be a firebreak of either 3 metres inside the boundary or 3 metres outside the boundary. Where there is a road free of flammable material, applications can be made annually to the Chief Fire Control Officer for exemption.
- (c) Fuel Dumps

In respect of land owned or occupied by you, on which is situated any fuel dump, in addition to the requirements of paragraphs (a) and (b) you shall remove all flammable materials or material likely to become flammable during summer from land occupied by bulk storage tanks and/or drums used for storage of liquid fuel whether the bulk storage tanks and/or drums contain liquid fuel or not. This includes the land on which ramps for holding the drums are constructed. The flammable material free ground must be maintained to a distance of at least 3 metres outside the perimeter of any drum, stack of drums or drum ramp or bulk storage tank.

Flammable material is defined for the purpose of this notice to include vegetation, timber, boxes, cartons, paper and like materials, rubbish and any other combustible matter, but does not include green standing trees, garden plants, growing bushes or maintained lawns, stacked wood heaps or buildings.

- (d) If it is considered to be impracticable for any reason to clear firebreaks on the land in the situations required by this Notice or by the date required by this Notice, you may apply to the Council or its duly Authorised Officer for variations by the Order. An application must be made no later than 14 days prior to the date by which firebreaks are required to be constructed, for permission to provide firebreaks in alternative positions or by an alternative date or to take alternative action to abate fire hazards on the land. If permission is not granted by the Council or its duly Authorised Officer you shall comply with the requirements of this Notice.
- (e) The penalty for failing to comply with this Notice is a fine of \$80 by infringement or not more than \$1,000 if prosecuted, and the person in default is liable, whether prosecuted or not, to pay the cost of performing the work.
- (f) If the requirements of this notice are carried out by burning, such burning must be in accordance with the relevant provisions of the Bush Fires Act 1954.

At any time, where a landholder intends to burn, a three (3) metre firebreak clear of flammable material must be placed within the property alongside the road reserve to prevent the escape of fire from the paddock to the road reserve.

Where a fire escapes through a lack of a suitable firebreak, the landholder will be responsible for the cost of reinstating the lost vegetation in addition to any fine or infringement incurred for not complying with this notice.


