Hospitals and Health Services Act 1927

Hospitals and Health Services (Reorganisation of Hospital Boards) Notice (No. 2) 2000

Made by the Governor in Executive Council under section 16(1) of the Act.

1. Citation

This notice may be cited as the *Hospitals and Health Services (Reorganisation of Hospital Boards) Notice (No. 2) 2000*.

2. Commencement

This notice comes into operation on 1 November 2000.

3. Amalgamation of boards to form new board

The boards mentioned in Schedule 1 Division 1 are reorganised by amalgamating them to form a new board.

4. Assignment of a corporate name to new board

The new board formed under clause 3 is assigned the corporate name "Wellington Health Service Board".

5. Constitution of Wellington Health Service Board

The Wellington Health Service Board is constituted in relation to the public hospitals mentioned in Schedule 1 Division 2.

Hospitals and Health Services Act 1927

Hospitals and Health Services (Wellington Health Service Board Appointments) Instrument 2000

Made by the Governor in Executive Council under section 15 of the Act.

1. Citation

This instrument may be cited as the *Hospitals and Health Services (Wellington Health Service Board Appointments) Instrument 2000*.

2. Commencement

This instrument comes into operation immediately after the reorganisation notice comes into operation.

3. Definitions

In this instrument —

“**former board**” means a board mentioned in Schedule 1 Division 1 to the reorganisation notice;

“**reorganisation notice**” means the *Hospitals and Health Services (Reorganisation of Hospital Boards) Notice (No. 2) 2000*;

“**Wellington Health Service Board**” means the board assigned that corporate name under clause 4 of the reorganisation notice.

4. Termination of term of tenure

The term of tenure of every member of a former board who holds office on the coming into operation of this instrument is terminated.

5. Appointment to the Wellington Health Service Board

The persons mentioned in Schedule 1 to this instrument are appointed to constitute the Wellington Health Service Board —

- (a) in the case of the persons mentioned in Division 1 of that Schedule — from 1 November 2000 to 30 September 2001; and
- (b) in the case of the persons mentioned in Division 2 of that Schedule — from 1 November 2000 to 30 September 2002.
