LOCAL GOVERNMENT ACT 1995

SHIRE OF HARVEY

ACTIVITIES ON THOROUGHFARES AND TRADING IN THOROUGHFARES AND PUBLIC PLACES LOCAL LAW—AMENDMENT (1)

Made by the Shire of Harvey under the *Local Government Act 1995*.

Citation

1. This Local Law may be cited as the Shire of Harvey Activities on Thoroughfares and Trading in Thoroughfares and Public Places Local Law—Amendment (1).

Principal Local Law

2. In this Law, the Shire of Harvey Activities on Thoroughfares and Trading in Thoroughfares and Public Places Local Law*, are referred to as the principal Local Law.

Amendment

3. The principal Local Law is amended to include after Clause 4.4 the following— $\,$

***4.5 Condition on Election Sign**

If the Local Government approves an application for a permit for the erection or placement of an election sign on a thoroughfare, the application is to be taken to be approved, subject to the sign—

- (a) being erected at least 30m from any intersection.
- (b) being free standing and not being affixed to any existing sign, post, power or light pole, or similar structure.
- (c) being placed so as not to obstruct or impede the reasonable use of a thoroughfare, or access to a place by any person.
- (d) being placed so as not to obstruct or impede the vision of a driver of a vehicle entered or leaving a thoroughfare or crossing.
- (e) being maintained in good condition.
- (f) not being erected until the election to which it relates has been officially annuanced
- (g) being removed within 24 hours of the close of polls on voting day.
- (h) not being placed within 100m of any works on the thoroughfare.
- (i) being securely installed.

- (j) not being an illuminated sign.
- (k) not incorporating reflective or fluorescent materials; and
- (l) not displaying only part of a message which is to be read with other separate signs in order to obtain the whole message."

LOCAL GOVERNMENT ACT 1995

SHIRE OF ASHBURTON

LOCAL LAW TO AMEND THE LOCAL LAW RELATING TO THE MANAGEMENT AND CONTROL OF PUBLIC SWIMMING POOLS

In pursuance of the powers conferred upon it by the above mentioned Act and all other powers enabling the Council and the Shire of Ashburton hereby records having resolved on 19 September 2000 to amend the "Local Law Relating to the Management and Control of Public Swimming Pools", as published in the *Government Gazette* on 3 June 1998, as follows—

Clause 7 is amended by the replacement of subclause (j) to read—

(j) take into the pool premises or have possession of any illegal substance.

Part 5 is added as follows-

PART 5—HIRING OF FACILITIES

- (1) Any person, group, organisation or association who wishes to hire any portion of the complex premises or any property of equipment for use in association therewith shall make written application to the Local Government and shall state the purpose for which the facility, property or equipment is required.
- (2) As a condition of hiring, the hirer will be required to deposit an amount nominated by the Local Government to cover any damage to the complex premises or property or equipment during the term of the hiring.
- (3) The hire of the premises or any part thereof or any equipment therein;
 - (a) shall maintain and keep good order and decent behaviour therein;
 - (b) shall make good any damage to the complex premises and any loss or damage to the property and equipment hired within or situated therein caused during the term of hiring or at the option of the Local Government, pay the cost thereof;
 - (c) shall be responsible for the carrying out of the terms of and the compliance with all Council's local laws;
 - (d) shall permit the Chief Executive Officer or Manager or any person authorised by the Council to have free ingress to the premises for the purpose of making an inspection of enforcing this local law;
 - (e) shall leave the premises and equipment in a clean and tidy condition after the term of the hiring;
 - (f) shall report any damage or defacement to the Local Government.
- (4) The Local Government may impose any terms or conditions on the hiring as it considers reasonable.
- (5) The hirer of the complex premises or any portion thereof of any equipment shall comply with the provisions of the Health Act, Liquor Licensing Act 1988, Police Act and the Criminal Code Act and any other Act in force for the time being, applicable to such hiring.
- (6) The consumption of alcohol may be permitted provided the premises is hired outside of normal opening hours.
- (7) Acceptance of the provisions of this local law shall be deemed to be a condition of the hiring.

FIREBREAK NOTICE 2000—2001

Notice to All Owners and/or Occupiers of Land in the Town of Kwinana

Pursuant to the powers contained in Section 33 of the above Act, you are hereby required on or before the 1^{st} day of December, 2000 or within 14 days of the date of you becoming an Owner or an Occupier should this be after the 1^{st} day of December, 2000, and thereafter up to and including the 31^{st} day of March, 2001, to have firebreaks, as defined, clear of all inflammable material, in the position, of the width, height and for the period as specified hereunder:

1. Definitions

"Firebreaks"

- (i) Firebreaks are to be mineral earth.
- (ii) Maintained lawns are accepted in conjunction with or in lieu of mineral earth firebreaks under clause 2 A and around buildings under clause 2 B;

"Inflammable matter" includes all forms of vegetation both living and dead, and any other inflammable materials and combustible matter.

2. Firebreaks to be Cleared

A. TOWNSITE LAND:

All land which is 3,000 square metres or less in area or which is zoned under the Town of Kwinana Town Planning Scheme No 2 as "Residential" or "Special Residential".

Remove all inflammable matter from the whole of the land except living trees and shrubs, plants under cultivation and lawn.

- B. ALL OTHER LAND WITHIN THE DISTRICT OF THE TOWN OF KWINANA:
 - (i) Firebreaks of a minimum width and height of 3 metres are to be cleared immediately inside all external boundaries of the land. Maintained lawns are acceptable in conjunction with or in lieu of mineral earth firebreaks, provided that the same width and height requirements for a firebreak are maintained.
 - (ii) Remove all inflammable matter except living trees, shrubs, plants under cultivation and lawns, to a minimum width of 3 metres and height of 3 metres immediately surrounding all buildings situated on the land;
 - (iii) Firebreaks 3 metres in width and 3 metres in height are to be cleared immediately surrounding any place where inflammable liquids, chemicals and gas products are kept on the land.
 - (iv) In addition to the requirements in (i), (ii) and (iii) above where the area of land exceeds 10 hectares, Council may require firebreaks of no less than 3 metres in width and 3 metres in height to be cleared so as to ensure that no area of land within firebreaks exceeds 10 hectares in area.

3. Additional Requirements

In addition to the requirements in clause 2 A and B, Council may, by notice in writing, require an owner or occupier to act as and when specified in the notice with respect to anything which is upon land and which in the opinion of Council is or is likely to be conducive to the outbreak of a bush fire or the spread or extension of a bush fire.

All firebreaks and fire prevention measures shall be in place on or before 1st December, 2000, and thereafter maintained clear of inflammable matter up to and including 31st March, 2001.

If the requirements of this Notice are carried out by burning, such burning must be in accordance with the relevant provision of the Bush Fire Act 1954.

4. Variation To Fire Prevention Measures

If for any reason an owner or occupier considers it impractical to clear firebreaks or comply with other fire protection measures in accordance with this Notice, the owner or occupier may apply in writing to the Council no later than 31 October in any year for a variation. If permission is not granted in writing by Council or its duly authorised officer, the owner or occupier must comply with the requirements of this Notice. Any variation granted by Council will apply only for the 2000/2001 season. A variation granted by Council shall only remain in force until 31 April, 2001.

5. Powers of Council

Where an owner or occupier of land fails or neglects to comply with any requirement of this Notice within the time specified in this Notice, the Council may by its officers with such servants, workmen and contractors, vehicles and machinery as the officers deem necessary enter upon the land and do all such things as are necessary in this Notice and may recover the costs and expenses of doing so in a Court of competent jurisdiction from the owner or occupier of the land pursuant to the Act, in addition to any penalty which might be imposed.

6. General
