Environmental Protection Act 1986

Environmental Protection (Northam and Districts Gun Club) Exemption Order 2000

Made by the Minister with the approval of the Governor in Executive Council under section 6 of the Act.

1. Citation

This order may be cited as the *Environmental Protection* (Northam and Districts Gun Club) Exemption Order 2000.

2. Commencement and expiry

This order comes into operation on the day on which it is published in the *Gazette* and, subject to section 6 of the Act, expires on 31 December 2005.

3. Background and proposal to review

- (1) This order is made in recognition of the background circumstances that
 - (a) the club has operated at the club premises for a period of more than 30 years;
 - (b) during that period the use of land within the vicinity of the club premises has become increasingly residential;
 - (c) noise emissions from the club premises have been found to be unacceptable to, and the subject of complaints by, some of the residents who live in the vicinity of the club premises;
 - (d) the only practicable solution to the problem of noise emissions from the club premises is for the club to move to premises located away from land used, or to be used, for residential purposes; and
 - (e) the club should be given a reasonable period to find and move to appropriate new premises and should be required to adopt appropriate noise management procedures at the club premises during that period.
- (2) The Minister proposes to review the operation and effectiveness of this order before 31 December 2003.

4. Definitions

In this order —

- "club day" means a day on which clay target shooting takes place at the club premises;
- "club premises" means the clay target shooting range operated by the club in an area in the Town of Northam located north of the Avon River and west of Mortlock Avenue:
- **"commencement day"** means the day on which this order comes into operation;
- "Director" means the Director of the Pollution Prevention Division of the Department of Environmental Protection at 141 St George's Terrace, Perth;
- "first period of exemption" means the period from the commencement day to 31 December 2003;
- "second period of exemption" means the period from 1 January 2004 to 31 December 2005;
- **"the club"** means the Northam and Districts Gun Club (Incorporated), an incorporated association within the meaning of the *Associations Incorporation Act 1987*.

5. Application of order

This order applies only while the club remains the sole operator of any clay target shooting that takes place at the club premises.

6. Declaration of exemption and requirement to comply

- (1) Part V of the Act and the *Environmental Protection (Noise)*Regulations 1997 are declared not to apply to the noise emitted from clay target shooting that takes place at the club premises.
- (2) The declaration under subclause (1) is subject to the conditions specified in Schedule 1.
- (3) The club is required to comply with the conditions specified in Schedule 1.

7. Application of conditions

- (1) The conditions specified in Schedule 1 Division 1 apply to the whole period during which this order is in operation.
- (2) The conditions specified in Schedule 1 Division 2 apply only to the first period of exemption.
- (3) The conditions specified in Schedule 1 Division 3 apply only to the second period of exemption.

Schedule 1 — Conditions of exemption

[cl. 6]

Division 1 — Conditions generally

1. Notice of proposed club days to be published

- (1) At least once in 2000 and once in each period of 6 months from 1 January 2001 notice is to be published in a local newspaper circulating in the Northam district setting out
 - (a) the proposed dates of club days during the 6 months following the day of publication of the notice; and
 - (b) the times during those club days when clay target shooting is proposed to take place.
- (2) If there is a change to a date or time of which notice has been published under subclause (1) ("the original notice"), notice of the new time or new date is be published in a local newspaper circulating in the Northam district
 - (a) if the club day is to be held on a date that is earlier than the date set out in the original notice at least 10 days before the new club day; or
 - (b) in any other case at least 10 days before the date set out in the original notice.

2. Shooters to use limited powder loads

Cartridges used in clay target shooting on a club day are to have a powder load of not more than 28 grains.

3. Inspections of cartridges to be carried out

- (1) On at least
 - (a) one club day in 2000; and
 - (b) 4 club days in each subsequent calendar year,

an inspection is to be carried out at the club premises of all the cartridges that are proposed to be used by each of at least 5 people intending to take part in clay target shooting on the club day concerned.

- (2) The people whose cartridges are inspected under subclause (1) are to be selected by means of names drawn randomly from the names of all the people intending to take part in clay target shooting on the club day concerned.
- (3) A written report is to be prepared of the results of an inspection carried out under this clause, which is to include the names of the people whose cartridges were inspected and details of those cartridges, and a copy of the report is to be given to the Director within 10 days after the club day on which the inspection was carried out.

Division 2 — Conditions applicable to first period of exemption

4. Club days and times for shooting: commencement day to 31 December 2003

Clay target shooting is not to take place at the club premises on any day or at any time other than —

- (a) from 2 p.m. to 5 p.m. on a Saturday (other than the Saturday referred to in paragraph (e));
- (b) from 8.30 a.m. to 6 p.m. on not more than half the Sundays from the commencement day to 31 December 2000;
- (c) from 8.30 a.m. to 6 p.m. on not more than 24 Sundays (excluding the Sunday referred to in paragraph (e)) in each of 2001, 2002 and 2003;
- (d) for the purposes of the schools gun safety program from 9 a.m. to 3 p.m. on not more than 2 weekdays in each week of a school term, but subject to a maximum period of clay target shooting authorised by this paragraph in any week of 4 hours; and
- (e) for the purposes of the Island Farm Championships on a consecutive Friday, Saturday and Sunday in August
 - (i) from 3 p.m. to 6 p.m. on Friday; and
 - (ii) from 8.30 p.m. to 6 p.m. on Saturday and Sunday.

Division 3 — Conditions applicable to second period of exemption

5. Club days and times for shooting: 1 January 2004 to 31 December 2005

Clay target shooting is not to take place at the club premises on any day or at any time other than —

- (a) from 2 p.m. to 5 p.m. on not more than 3 Saturdays in each calendar month (including the Saturday referred to in paragraph (d));
- (b) from 8.30 a.m. to 6 p.m. on not more than 16 Sundays in each calendar year (excluding the Sunday referred to in paragraph (d));
- (c) for the purposes of the schools gun safety program from 9 a.m. to 3 p.m. on not more than 2 weekdays in each week of a school term, but subject to a maximum period of clay target shooting authorised by this paragraph in any week of 4 hours; and
- (d) for the purposes of the Island Farm Championships on a consecutive Friday, Saturday and Sunday in August
 - (i) from 3 p.m. to 6 p.m. on Friday; and
 - (ii) from 8.30 p.m. to 6 p.m. on Saturday and Sunday.

Land Administration Act 1997

Land Administration Amendment Regulations (No. 3) 2000

Made by the Governor in Executive Council.

1. Citation

These regulations may be cited as the *Land Administration Amendment Regulations* (No. 3) 2000.

2. Commencement

These regulations come into operation on the day on which section 4 of the *Acts Amendment (Australian Datum) Act 2000* comes into operation.

3. Regulation 17A inserted

After regulation 17 of the *Land Administration*Regulations 1998* the following regulation is inserted in Part 2 —

"

17A. Prescribed Australian datum for determining Divisions of State

- (1) The position on the surface of the Earth of the Divisions referred to in section 6 of the Act are determined by reference to the Australian Geodetic Datum ("the AGD").
- (2) For the purposes of subregulation (1), the AGD is defined by an ellipsoid having a semi-major axis (equatorial radius) of 6 378 160 metres and a flattening of 1/298.25 and fixed by the position of the origin being the Johnston Geodetic Station in the Northern Territory of Australia.
- (3) The Johnston Geodetic Station is taken to be situated at
 - (a) 25° 56′ 54.5515″ south latitude and 133° 12′ 30.0771″ east longitude; or

(b) where decimal reckoning is used, 25° 56.90919′ south latitude and 133° 12.50129′ east longitude,

and to have a ground level elevation of 571.2 metres above the ellipsoid referred to in subregulation (2).

LOCAL GOVERNMENT ACT 1995

AGRICULTURE AND RELATED RESOURCES PROTECTION ACT 1976

SHIRE OF YORK

Local Laws Relating to Pest Plants

In pursuance of the powers conferred upon it by the abovementioned Acts and of all other powers enabling it, the Council of the Shire of York hereby records having resolved on the 21st February 2000, to make and submit for confirmation by the Governor, the following local laws:—

- 1. These local laws may be cited as the Shire of York Pest Plant Local Law 2000.
- 2. In these local laws, unless the contrary intention appears
 - "district" means the district of the local government;
 - "local government" means the Shire of York;
 - "Pest Plant" means a plant described as a pest plant by clause 4 of these local laws.
- 3. These local laws apply in respect of the district.
- 4. Every plant described in the First Schedule to these local laws is a pest plant.
- 5. (a) The local government may serve on the owner or occupier of private land within the district, a duly completed notice in the form of the Second Schedule to these local laws requiring him to destroy, eradicate or otherwise control any pest plant on that land.
 - (b) A person served with a notice under subclause (a) of this clause shall comply with that notice within the time and in the manner specified therein.
- 6. Where a person fails to comply with a notice under clause 5 of these local laws served upon him, the local government may:—
 - (a) Without payment of any compensation in respect thereof, destroy, eradicate or control, as the case may be, any pest plant, the destruction, eradication or control of which was required by the notice; and
 - (b) Recover in a court of competent jurisdiction from the person to whom the notice is directed, the amount of the expense of such destruction, eradication or control.

Petroleum Amendment Regulations (No. 3) 2000

Made by the Governor in Executive Council.

1. Citation

These regulations may be cited as the *Petroleum Amendment Regulations (No. 3) 2000*.

2. Commencement

These regulations come into operation on the day on which section 7 of the *Acts Amendment (Australian Datum) Act 2000* comes into operation.

3. The regulations amended

The amendments in these regulations are to the *Petroleum Regulations 1987**.

In these regulations —

"the AGD" means the Australian Geodetic Datum referred to in regulation 11;

"the GDA" means the Geocentric Datum of Australia referred to in regulation 9.

5. Regulations 9, 10 and 11 inserted

After regulation 8 the following regulations are inserted —

"

9. Application of Geocentric Datum of Australia

- (1) Subject to regulation 11, the GDA is the prescribed Australian datum for the purposes referred to in section 8(1) of the Act.
- (2) The reference ellipsoid for the GDA is the Geodetic Reference System 1980 ("GRS80") ellipsoid with a semi-major axis of 6 378 137 m exactly and an inverse flattening (l/f) of 298.257 222 101.
- (3) The reference frame for the GDA is realised by the coordinates of the following Australian Fiducial Network geodetic stations referred to the GRS80 ellipsoid determined within the International Earth

Rotation Service Terrestrial Reference Frame 1992 (ITRF92) at the epoch of 1994.0 —

Third Schedule — Transitional provisions relating to Geocentric Datum of Australia

1. Interpretation

(1) In this Schedule —

"Australian Geodetic Datum" means the datum described in clause 2;

"block" means a block as described in section 56C;

"commencement day" means the day on which section 5 of the Acts Amendment (Australian Datum) Act 2000 comes into operation;

"existing exploration licence" means an exploration licence referred to in clause 3(1) or (3);

"number", in relation to a block, has the same meaning as it has in section 56C(4);

"prescribed land" means all of an area of land that, as a result of the operation of section 9B in relation to the Geocentric Datum of Australia referred to in regulation 89A —

(a) immediately before the commencement day, was on the western and southern boundaries, but not within, a block or blocks; and

- (b) on the commencement day, is in the block or blocks identified by reference to the same number or numbers by reference to which the block or blocks referred to in paragraph (a) was or were identified.
- (2) The note and diagram after clause 8 are provided to assist understanding and do not form part of this Schedule.

2. Australian Geodetic Datum

- (1) For the purposes of this Schedule, the Australian Geodetic Datum is defined by an ellipsoid having a semi-major axis (equatorial radius) of 6 378 160 m and a flattening of 1/298.25 and fixed by the position of the origin being the Johnston Geodetic Station in the Northern Territory of Australia.
- (2) The Johnston Geodetic Station is taken to be situated at
 - (a) 25° 56′ 54.5515″ south latitude and 133° 12′ 30.0771″ east longitude; or
 - (b) where decimal reckoning is used, 25° 56.90919′ south latitude and 133° 12.50129′ east longitude,

and to have a ground level elevation of 571.2 m above the ellipsoid referred to in subclause (1).

3. Exploration licences

- (1) For the purposes of the Act or these regulations, the position on the surface of the Earth of the land that is the subject of an exploration licence in force before the commencement day is to be determined by reference to the Australian Geodetic Datum.
- (2) For the purposes of the Act or these regulations, the position on the surface of the Earth of the land that is the subject of an application for an exploration licence lodged before the commencement day and pending immediately before that day is to be determined by reference to the Australian Geodetic Datum.
- (3) For the purposes of the Act or these regulations, the position on the surface of the Earth of the land that is the subject of an exploration licence granted on or after the commencement day in respect of an application referred to in subclause (2) is to be determined by reference to the Australian Geodetic Datum.

4. Land surrendered or forfeited etc.

- (1) If after the commencement day
 - (a) land becomes available from an existing exploration licence; and

(b) any portion of that land is in a block in respect of which an exploration licence has been granted in respect of an application lodged on or after the commencement day,

the exploration licence referred to in paragraph (b) is to be amended, by force of this subclause, to include the land that has become available from the existing exploration licence.

- (2) If after the commencement day
 - (a) land becomes available from an existing exploration licence; and
 - (b) any portion of that land is in a block in respect of which an application for an exploration licence is lodged on or after the commencement day,

the application referred to in paragraph (b) is taken to extend to the land that has become available from the existing exploration licence and, if an exploration licence is granted in respect of that application, that land is to be included in the exploration licence.

- (3) Subclauses (1) and (2) do not apply if
 - (a) the land that becomes available from an existing exploration licence has been included in an application under section 67 or 70B; and
 - (b) a mining lease, general purpose lease or retention licence has been granted in respect of the application.
- (4) Subclause (2) does not apply if the land that becomes available from an existing exploration licence is in a block identified by reference to the same number as a block in respect of which an application referred to in subclause (2)(b) has been lodged.
- (5) A reference in this clause to land becoming available from an existing exploration licence is a reference to the land that is the subject of the licence being surrendered under section 65 or to the surrender, forfeiture (otherwise than under section 98) or expiry of the licence.

5. Land exempted under section 19

For the purposes of the Act or these regulations, the position on the surface of the Earth of land that is the subject of an exemption given by an instrument in force under section 19 and made before the commencement day is to be determined by reference to the Australian Geodetic Datum.

6. Areas declared under section 57(4), and savings

- (1) For the purposes of the Act or these regulations, the position on the surface of the Earth of land that is the subject of a declaration in force under section 57(4) and made before the commencement day is to be determined by reference to the Geocentric Datum of Australia.
- (2) Subclause (1) does not affect the validity of
 - (a) an existing exploration licence; or
 - (b) an application for an exploration licence lodged before the commencement day and pending immediately before that day.

7. Certain prospecting licences and mining leases may be amalgamated with existing exploration licences


- (1) If a person is the holder of both an existing exploration licence and another tenement, the person or an agent of the person may, without marking out the land, apply in writing to the Minister in the manner prescribed for the purposes of section 67A(1) for the other tenement, or part of the other tenement, to be amalgamated with the exploration licence.
- (2) Another tenement, or part of another tenement, cannot be amalgamated with an exploration licence under this clause unless the land that is the subject of the other tenement, or of that part of the other tenement, is
 - (a) wholly within the same block or same blocks within which the land that is the subject of the exploration licence is situated: and
 - (b) contiguous with the land referred to in paragraph (a).
- (3) Subject to subclause (2), section 67A(4) and (5) apply to an application under subclause (1) as if
 - (a) the application had been made under section 67A(1); and
 - (b) a reference in section 67A(4) or (5) to "secondary tenement" were a reference to, as the case requires, the "other tenement" or "part of the other tenement" mentioned in subclause (1).
- (4) This clause does not affect the operation of section 67A.
- (5) In this clause
 - "another tenement" or "other tenement" means a prospecting licence or mining lease applied for and granted after the commencement day in respect of prescribed land.

8. Prescribed land does not need to be marked out

Despite section 105, if an application for a prospecting licence or mining lease is made on or after the

commencement day in respect of prescribed land only, that land does not need to have been marked out.

RETAIL TRADING HOURS ACT 1987

RETAIL TRADING HOURS CITY OF MANDURAH EXEMPTION ORDER 2000

Made by the Minister for Fair Trading under Section 5 of the Act.

Citation

1. This Order may be cited as the Retail Trading Hours City of Mandurah Exemption Order 2000.

Interpretation

2. In this Order-

"Public Holiday" means a public holiday under section 5, section 7 or section 8 of the *Public and Bank Holidays Act 1972* but does not include Anzac Day, Christmas Day or Good Friday;

"School term" means a school term determined by the Minister charged with the administration of the *Education Act 1928* under that Act.

Exemption Periods

- 3. (1) During the period commencing on the first-mentioned day in each of the following paragraphs and ending at the close of business on the second-mentioned day in each of those paragraphs, namely—
 - (a) the Saturday preceding Foundation Day to Foundation Day;
 - (b) the Saturday following the end of the second school term to the Sunday preceding the third school term;
 - (c) the Saturday following the end of the third school term to the Sunday preceding the fourth school term;
 - (d) the Saturday preceding the Queen's Birthday public holiday to the Queen's Birthday public holiday;
 - (e) the first Sunday in December to the last Sunday in April.

General retail shops other than specified general retail shops in the area or locality specified in Column 1 of the Schedule are exempted from the *Retail Trading Hours Act 1987* on the days specified in the Schedule subject to the conditions as to hours of closing specified opposite and corresponding to the area or locality in Column 2 of the Schedule;

(2) In sub-clause (1)—

"specified general retail shops" means general retail shops—

- (a) in, on or from which motor vehicles are sold; or
- (b) in, on or from which spare parts for motor vehicles are sold by way of retail sale in conjunction with the sale of motor vehicles.


