City of Fremantle
DOG LOCAL LAWS
AMENDMENT

Pursuant to its powers under the Local Government Act 1995 the City of Fremantle resolved on the 22 January 2001 to make the following amendments to the City of Fremantle Dog Local Law:

#### 1. Preliminary Part 1 1.3

In the correct alphabetical order, insert new definition as follows—

"District" means the district of the City of Fremantle.

"Fees Schedule" means the schedule of fees and charges which form part of the annual budget.

#### 2. Part 4 Kennel Establishments

Insert new clause-

- 4.7 Fees;
  - (a) On lodging an application for a licence, the applicant is to pay a fee to Council.
  - (b) On the issue or renewal of a licence, the licensee is to pay a fee to Council.
  - (c) On lodging an application for the transfer of a valid licence, the transferee is to pay a fee to the Council.
  - (d) The fees referred to in subclauses (a) to (c) are to be imposed and determined by the Council in its annual budget.

#### 3. Part 5 Impounding

Delete clause "5.1" and substitute the following—

5.1 The Council pound shall be open for the release of impounded dogs at times and on days of the week determined by the Council. At any other reasonable time a dog may be released from the pound upon payment of the applicable fees for the opening of the pound specified in the Fees Schedule of the Budget.

Insert the following clause-

- 5.3 The following are to be imposed and determined by the Council in the Schedule of fees and charges which form part of the Annual Budget, under sections 6.16-6.19 of the Local Government Act 1995—
  - (a) The charges to be levied under section 29(4) of the Act relating to the seizure and impounding of a dog;

- (b) The additional fee payable under section 29(4) of the Act where a dog is released at a time or on a day other then those determined under clause 5.1; and
- (c) The costs of the destruction and disposal of a dog referred to in section 29(15) of the Act.

#### 4. Delete the "First Schedule."

SOIL AND LAND CONSERVATION (LAKE GRACE LAND CONSERVATION DISTRICT) AMENDMENT ORDER 2000

Made by the Governor in Executive Council under sections 22 and 23 of the *Soil and Land Conservation Act 1945* on the recommendation of the Minister.

#### 1. Citation

This order may be cited as the Soil and Land Conservation (Lake Grace Land Conservation District) Amendment Order 2000.

#### 2. Principal Order

In this order the *Soil and Land Conservation (Lake Grace Land Conservation District) Order 1996\** is referred to as the principal order.

#### 3. Clause 3 deleted and replaced

Clause 3 of the principal order is deleted and replaced with the following—

#### 3. Lake Grace Land Conservation District

The area shown cross hatched on the plan set out in Schedule 1 is constituted the Lake Grace Land Conservation District.

#### 4. Clause 4 deleted and replaced.

Clause 4 of the principal order is deleted and replaced with the following—

#### 4. Establishment of the committee

A land conservation district committee is established for the Lake Grace Land Conservation District.

#### 5. Clause 5 deleted and replaced.

Clause 5 of the principal order is deleted and replaced with the following—

#### 5. Constitution of committee

- (1) It is determined, on the recommendation of the Minister, after consultation with the Shire of Lake Grace, that the district committee established under clause 4 is to comprise 12 members, of whom—
  - (a) one is to be the Commissioner of Soil and Land Conservation or a nominee of the Commissioner; and
  - (b) the others are to be appointed by the Commissioner.
- (2) Of the members appointed under subclause (1)(b)—
  - (a) one is to be appointed on the nomination of the Shire of Lake Grace;
  - (b) two are to be appointed under subclause (3);
  - (c) one is to be appointed under subclause (4);
  - (d) seven are to be persons actively engaged in, or affected by or associated with, land use in the district.
- (3) The Western Australian Farmers Federation (Inc.) is to submit to the Commissioner a panel containing the names of persons willing to be appointed as members of the committee and, where such a panel is submitted, two persons whose names appear on the panel are to be appointed by the Commissioner.
- (4) The Pastoralists and Graziers Association is to submit to the Commissioner a panel containing the names of persons willing to be appointed as members of the committee and, where such a panel is submitted, one person whose name appears on the panel is to be appointed by the Commissioner.
- (5) The Commissioner may terminate the appointment of a member appointed under subclause (1)(b).
- (6) A member appointed under subclause (1)(b) may resign his or her office by written notice addressed to the Commissioner.

#### 6. Clause 6 deleted and replaced.

Clause 6 of the principal order is deleted and replaced with the following—

#### 6. Proceedings of the committee

To the extent that they are not provided for under the *Soil and Land Conservation Act 1945* or Part VII of the *Interpretation Act 1984*, the committee may determine its own procedures.



- (2) Of the members appointed under subclause (1)(b)—
  - (a) two are to be appointed on the nomination of the Shire of Kent;
  - (b) two are to be appointed under subclause (3);
  - (c) one is to be appointed under subclause (4);
  - (d) 11 are to be persons actively engaged in, or affected by or associated with, land use in the district.
- (3) The Western Australian Farmers Federation (Inc.) is to submit to the Commissioner a panel containing the names of persons willing to be appointed as members of the committee and, where such a panel is submitted, two persons whose names appear on the panel are to be appointed by the Commissioner.
- (4) The Pastoralists and Graziers Association is to submit to the Commissioner a panel containing the names of persons willing to be appointed as members of the committee and, where such a panel is submitted, one person whose name appears on the panel is to be appointed by the Commissioner.
- (5) The Commissioner may terminate the appointment of a member appointed under subclause (1)(b).
- (6) A member appointed under subclause (1)(b) may resign his or her office by written notice addressed to the Commissioner.

#### 6. Proceedings of the committee


