#### **HEALTH ACT 1911**

Town of Mosman Park

HEALTH AMENDMENT LOCAL LAWS 2000

Made by the Council of the Town of Mosman Park under section 342 of the *Health Act 1911* in accordance with subdivision 2 of Division 2 of Part 3 of the *Local Government Act 1995.* 

#### Citation

**1.** These local laws may be cited as the *Town of Mosman Park Health Amendment Local Laws 2000.* 

#### **Principal local laws**

**2.** In these local laws, the *Town of Mosman Park Health Local Laws 1995* made under the *Health Act 1911* and passed by the Council of the Town of Mosman Park on 26 September 1995, by notice published in the *Government Gazette* on 9 September 1996, and amended by the *Town of Mosman Park Health Amendment Local Laws 1999* made under the *Health Act 1911* and passed by the Council of the Town of Mosman Park on 23 February 1999, by notice published in the *Government Gazette* on 13 July 1999, are referred to as the principal local laws.

#### **Definition amended**

**3.** In subclause 3(1), delete the definition of **"Building Code"** and substitute the following—

"**"Building Code**" means the latest edition of the Building Code of Australia published from time to time by, or on behalf of, the Australian Building Codes Board, as amended from time to time, but not including explanatory information published with that Code.'

#### **Clause 11 deleted**

4. Delete clause 11 and the heading thereto.

#### Clause 16 deleted

5. Delete clause 16 and the heading thereto.

#### **Clause 18 amended**

#### HEALTH ACT 1911

#### TOWN OF MOSMAN PARK HEALTH (EATING HOUSES) LOCAL LAWS 2000

Made by the Council of the Town of Mosman Park under section 342 of the *Health Act 1911* in accordance with subdivision 2 of Division 2 of Part 3 of the *Local Government Act 1995.* 

#### PART 1-PRELIMINARY

#### 1. Citation

These Local Laws may be cited at the Town of Mosman Park Health (Eating-Houses) Local Laws 2000.

#### 2. Repeal

The Health Local Laws of the Town of Mosman Park, described as *"Health Local Laws—Eating Houses"* made by the Town of Mosman Park and published in the *Government Gazette* on the 29 April 1949 and amended from time to time, are repealed.

#### 3. Interpretation

In these Local Laws, unless the context otherwise requires—

"Act" means the *Health Act 1911* as amended;

- "Chief Executive Officer" means the Chief Executive Officer of the Town of Mosman Park and includes an Acting Chief Executive Officer;
- "Council" means the Council of the Town of Mosman Park;
- "Eating house" shall have the same meaning as defined in Section 160 of the *Health Act 1911;*
- **"Environmental Health Officer"** means an Environmental Health Officer appointed by the Council under the Act and includes an Acting or Assistant Environmental Health Officer.
- "Licence" means a licence to conduct an eating house issued under these Local Laws;
- "Proprietor" means the person having the management or control of premises.
- "Registered" means registered as an eating house under these Local Laws.

#### PART 2-REGISTRATION AND LICENSING

#### 4. Prescribed Date

(1) For the purposes of Section 162 of the Act, the prescribed date is fixed as the 30 June, 2001.

(2) For the purpose of Section 163 of the Act, 30 June in each year is prescribed as the date on or before which the annual application for registration of an eating-house and licence for the proprietor of an eating-house shall be made.

#### 5. Requirement for registration and licensing

(1) A person shall not occupy or use or cause, suffer, or permit to be occupied or used any premise as an eating house unless and until—

- (a) the premises are registered under these local laws as an eating house;
- (b) the proprietor of the said premises is the holder of a licence issued by the Council authorising him or her to conduct on the premises the business of an eating house; and
- (c) the premises and the operations conducted within the premises comply with the requirements of the *Health (Food Hygiene) Regulations 1993.*

#### 6. Registration of an Eating House

(1) An application for registration of an eating-house shall be forwarded to the Chief Executive Officer together with—

- (i) the fee as fixed from time to time by Council under Section 344C of the Act;
- (ii) in relation to an eating house which is not currently registered, detailed plans and specifications of the eating-house which shall include the following details—
  - (a) the use of each room;
  - (b) the structural finish of each wall, floor and ceiling;
  - (c) the position and type of each fitting and fixture;
  - (d) all sanitary conveniences, change rooms, ventilating systems, drains, grease traps and provisions for waste disposal;
  - (e) the proposed number of persons, including the proprietor or proprietors expected to be engaged in the preparation, manufacture, processing, cooking or serving of meals; and
  - (f) the proposed menu.

(2) Before any premises are registered as an eating house, the site intended to be used for such purpose shall be subject to the approval of the Council.

(3) The Council may attach such conditions as it deems necessary to ensure compliance with the requirements of the Act, to the registration of an eating house, and these conditions shall be set out in the certificate of registration.

(4) Upon approval of an application for registration of an eating house, the Chief Executive Officer shall provide the applicant with a certificate of registration.

#### 7. Licence to conduct an eating house

(1) An application for a licence to conduct an eating house shall be forwarded to the Chief Executive Officer together with—

- (i) the fee as fixed from time to time by Council under Section 344C of the Act;
- (ii) the full name and address of the applicant;
- (iii) the name and location of the premises for which the licence is sought; and
- (iv) details of any previous experience in the operations of eating houses.

(2) Where there are two or more applicants for a licence to conduct an eating house, the licence shall be issued in joint names.

(3) Upon approval of an application for a licence to conduct an eating house, the Chief Executive Officer shall issue to the applicant a licence.

#### 8. Licence conditions

(1) A licence shall be issued upon and subject to the condition that the holder of the licence shall—  $\!\!\!$ 

- (a) not allow more patrons to be accommodated on the premises than the maximum number shown on the certificate of registration;
- (b) notify the Council in writing of any proposed alteration, addition or other work relating to the construction, drainage or ventilation of the eating house prior to the commencement of such alteration, addition or other work;
- (c) notify the Council in writing of any proposed changes to the menu that shall affect the classification under the *Health (Food Hygiene) Regulations 1993;*
- (d) notify the Council in writing of any proposed increases in staff numbers;
- (e) notify the Council of anything which may or has caused contamination of food;
- (f) prevent public access to the food preparation and storage areas at all times;
- (g) not permit the reuse of any table napkin or serviette unless such table napkin has been thoroughly washed and cleansed since it was used;
- (h) not allow animals or birds to be slaughtered and dressed or any poultry, pigeons or game to be plucked in any part of the premises;
- (i) not gut, clean or scale any fish on any portion of the premises unless that portion of the premises has been constructed for that purpose and approved in writing by an Environmental Health Officer;
- (j) not allow any outside area used in conjunction with the eating house, to be used for the service of meals to the public, unless it is paved, graded and drained to the satisfaction of an Environmental Health Officer. The surface finish of the paving shall be smooth, even and impervious so that it does not hold liquids;
- (k) not allow any hat or clothing to be placed or kept in any room open to the public or in any kitchen, scullery or food store, provided that the patrons may be permitted to hang their hats and coats in any room open to the public;
- not allow any food contained in a package, tin or container or any cooking, eating or drinking utensil to be stored in anyplace other than a cabinet, cupboard or shelf;
- (m) not use, keep or store or permit to be used, kept or stored any petrol, bottles or containers of liquid petroleum gas, kerosene, benzene, naphtha, alcohol, mineralised or methylated spirit or any volatile liquid (not being an article of food) in any kitchen or room where food is prepared, manufactured, processed, cooked or stored;
- (n) not allow any food to be prepared, manufactured, processed, cooked or thawed in any room wherein any water closet or urinal or any wash basin for use in connection with the same is situated;
- (o) ensure that the number of persons accommodated at any one time in any public room on the premises, shall not exceed the ratio of 1 person to 1 square metre of the floor area of the room.

#### 9. Certificates of Registration and Licences

Every proprietor of registered premises shall keep the certificates of registration and the licence on the registered premises in a position visible to the general public and shall, when requested to do so by an Environmental Health Officer, produce the certificate of registration and the licence issued to the proprietor in respect such premises.

#### 10. Period of Registration and Licence

Every certificate of registration and every licence shall be in force from the day of issue to 30 June next, inclusive, unless the same is cancelled in the meantime in accordance with the provisions of the Act.

#### **11. Renewal Applications**

Application for renewal of certificates of registration and licences shall be made annually during the month of June.

#### 12. Change of Address

Whenever any person identified as the proprietor on a certificate of registration and/or a licence issued pursuant to these local laws, changes his place of abode he shall, within seven days of such a change, give notice in writing to the Chief Executive Officer specifying his new place of abode and he shall, at the same time, produce such certificate of registration and/or licence to the Chief Executive Officer and the amendment shall be endorsed thereon.

#### **13. Licence Personal to Holder**

Any licence issued under the provisions of these local laws to any proprietor to conduct an eating house, shall not be transferable to any other person except as specified in Section 168 subsection 2 of the Act.

#### 14. New Proprietors to apply for Licence

If the licensed proprietor of any premises registered as an eating house ceases to be the proprietor, as defined under these local laws then any person wishing to become the proprietor of such premises must make application to the Chief Executive Officer for a licence to conduct an eating house as required by clause 7 of these local laws.

# **15.** Power to Grant or Refuse an Application or cancel a Registration or Licence

Where an application is made for either—

- (a) an eating house to be registered; or
- (b) a licence to be issued to conduct the business of an eating house; then-
  - (i) such application may be issued or refused subject to Sections 165 and 166 of the Act; and
  - (ii) any such registration or licence, if allowed and issued, may be cancelled at any time for any one of the reasons described in subsections 165(3) and 166(3) of the Act.

#### PART 3—PENALTIES

#### 16. Penalties

A person who commits a breach or fails to comply with any of the requirements of these local laws commits an offence and is liable to the penalties as follows—

- (a) a penalty which is not more than \$2,500 and not less than-
  - (i) in the case of a first offence \$250;
  - (ii) in the case of a second offence \$500; and
  - (iii) in the case of a third offence or subsequent offence \$1,250; and
- (b) if that offence is a continuing offence, a daily penalty which is nor more than \$250 and not less than \$125.

#### LOCAL GOVERNMENT ACT 1995

#### SHIRE OF CHITTERING

#### ACTIVITIES ON THOROUGHFARES AND TRADING IN THOROUGHFARES AND PUBLIC PLACES LOCAL LAW

Under the powers conferred by the *Local Government Act 1995* and under all other powers enabling it, the Council of the Shire of Chittering resolved on 7 December 2000 to make the following local law—

The Shire of Kojonup Activities On Thoroughfares And Trading In Thoroughfares and Public Places Local Law as published in the Government Gazette of 16 May 2000, is adopted as a local law of the Shire of Chittering, with the modifications which follow—

#### 1. Preliminary

Wherever the "Shire of Kojonup" is mentioned in the local law substitute "Shire of Chittering".

#### 2. Clause 1.2—Definitions

In the definition of "townsite" delete "Kojonup and Muradup" and substitute "Bindoon, Muchea and Wannamal".

#### 3. Clause 1.4—Repeal

3.1 After clause 1.3, insert the clause designation "1.4" before the heading "Repeal".

3.2 In subclause (1) delete paragraphs (a) and (b) and substitute-

By-laws Relating to Removal and Disposal of Obstructing Animals or Vehicles, published in the Government Gazette of 10 December 1964.

#### 4. Part 3-New clause inserted

4.1 Renumber clauses 3.2 to 3.5 inclusive to 3.3 to 3.6 respectively.

4.2 In Division 1 insert the following new clause-

#### **"3.2 Application**

Where there is any inconsistency between this Part and the Shire of Chittering Local Laws Relating to Signs, Hoardings and Bill Posting, published in the Government Gazette of 7 August 1992, as amended by publication in the Government Gazette of 19 August 1993, the provisions of this Part prevail.".

# 5. Clause 6.5—Relevant considerations in determining application for permit

In subclause (2)-

- (a) after ";" in subparagraph (iii) of paragraph (c) delete "or";
- (b) renumber paragraph (d) to paragraph (e);
- (c) insert a new paragraph (d) as follows—
- "(d) that the needs of the district, or the part for which the permit is sought, are adequately catered for by established shops or by persons who have valid permits to carry on trading or to conduct a stall; or".

#### 6. Clause 6.8—Conduct of stallholders and traders

- 6.1 In subclause (1)-
  - (a) at the conclusion of paragraph (b) delete the word "and";
  - (b) at the conclusion of paragraph (c) delete "." and insert "; and";
  - (c) insert "(d) comply with the provisions of the Health Act 1911.".
- 6.2 In subclause (2)-
  - (a) renumber paragraphs (a) to (d) inclusive to (b) to (e) respectively;
  - (b) insert a new paragraph (a) as follows-
    - "(a) attempt to conduct a business within a distance of 300m of any shop or permanent place of business that is open for business and has for sale any goods or services of the kind being offered for sale by the stallholder or trader;".

#### 7. Schedule 1

Under the column headed "Clause", after the clause designation 2.2 wherever it occurs insert the subclause designation "(1)" before each paragraph designation.

#### 8. Forms

Delete Forms 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11 and 12.

Made by the Governor in Executive Council.

## 1. Citation

These regulations may be cited as the *Water Services Coordination (Plumbers Licensing) Amendment Regulations 2001.*

# 54. Drainage plumbing work — transitional arrangements

- (1) This regulation applies to a person who
  - (a) was engaged in carrying out drainage plumbing work on or after the day on which these regulations commenced;
  - (b) does not hold a plumber's licence or a tradesperson's licence; and

<sup>&</sup>quot;tradesperson's licence (drainage plumbing)" means a licence of the kind referred to in regulation 13(2);

".

- (c) does not comply with the requirements set out in Schedule 3 in respect of a plumber's licence or a tradesperson's licence.
- (2) If the person applies for a tradesperson's licence (drainage plumbing) on or before 15 June 2001, then until the licence is issued or the Board decides not to issue the licence and notifies the person to that effect, the person is to be treated for all purposes as if the person was, at all material times, the holder of a tradesperson's licence (drainage plumbing) that authorised the person to carry out the drainage plumbing work.
- (3) Subregulation (2) has effect despite regulations 9 and 10.

- (b) has sufficient experience and knowledge to qualify the applicant to carry out competently the drainage plumbing work that the applicant would be authorised to carry out under the licence.


