2. Mandurah Fire District — adjustment of boundaries and declaration as permanent fire district


- (1) The boundaries of the Mandurah Fire District are adjusted so that the boundaries of that district are the boundaries of the area coloured yellow on Department of Land Administration Statutory Services Plan 21001.
- (2) The Mandurah Fire District is declared to be a district served by a permanent fire brigade.


3. Falcon Fire District — adjustment of boundaries

BUSH FIRES ACT 1954

Shire of Irwin

BUSH FIRE BRIGADES LOCAL LAW

Under the powers conferred by the Bush Fires Act 1954 and under all other powers enabling it, the Council of the Shire of Irwin resolved on 8 May 2001 to make the following local law.

The Bush Fire Brigades Local Law of the Shire of Bridgetown-Greenbushes published in the *Government Gazette* of 20 October 2000, is adopted as a local law of the Shire of Irwin with the modifications which follow:

1. Preliminary

1.1 Wherever the "Shire of Bridgetown-Greenbushes" is mentioned in the local law substitute "Shire of Irwin".

1.2 In clause 1.2 delete the definition of "Bush Fire Management Committee".

1.3 Wherever "Bush Fire Management Committee" or "Management Committee" are mentioned in the local law substitute "Bush Fire Advisory Committee" and "Advisory Committee" respectively.

2. Clause 1.3-Repeal

Delete clause 1.3 and substitute—"All previous local laws of the Shire of Irwin relating to the Organisation, Establishment, Maintenance and Equipment of Bush Fire Brigades, are repealed.".

3. First Schedule–Rules Governing The Operation of Bush Fire Brigades

3.1 Clause 2.4—Applications for membership

Delete "of that in Appendix 1" and substitute "determined by the local government from time to time.".

3.2 Clause 2.9—Existing liabilities to continue

In subcaluse (1) delete "2.6" and substitute "2.7".

3.3 Delete Appendices I and II.

HEALTH ACT 1911

SHIRE OF SERPENTINE-JARRAHDALE HEALTH AMENDMENT LOCAL LAWS 2000

Under the powers conferred under section 342 of the *Health Act 1911* and in accordance with subdivision 2 of Division 2 of Part 3 of the *Local Government Act 1995*, the Council of the Shire of Serpentine-Jarrahdale resolved on 19 February 2001 to amend the Shire of Serpentine-Jarrahdale Health Local Laws 1999.

Citation

1 These local laws may be cited as the "*Shire of Serpentine-Jarrahdale Health Amendment Local Laws 2000*".
