Plant Diseases Amendment Regulations (No. 2) 2001

Made by the deputy of the Governor in Executive Council.

1. Citation

These regulations may be cited as the *Plant Diseases Amendment Regulations* (No. 2) 2001.

2. The regulations amended

The amendments in these regulations are to the *Plant Diseases Regulations 1989**.

[* Reprinted 17 March 2000. For amendments to 7 May 2001 see 2000 Index to Legislation of Western Australia, Table 4, p. 457-8.]

3. Regulation 17F amended

- (1) Regulation 17F(1) and (2) are repealed and the following subregulations are inserted instead
 - (1) In this regulation
 - "Ord River Irrigation Area" means that portion of the State that is north of latitude 17°S and east of longitude 127°E.
 - (2) A person who takes citrus fruit or stone fruit into the Ord River Irrigation Area from another part of the State during the period beginning on 1 June and ending on 30 November in any year unless the fruit is certified
 - (a) as being from a part of the State that is free from Mediterranean fruit fly (*Ceratitis capitata*); or
 - (b) as having been disinfested in an approved manner,

commits an offence.

Penalty: \$5 000.

,,

- (2) Regulation 17F(3)(a) is amended by deleting "Kimberley Area" and inserting instead
 - " Ord River Irrigation Area".

4. Schedule 1 amended

- (1) Schedule 1, Part B, item 4B is amended as follows:
 - (a) in paragraph (a)(i) by deleting "15 seconds;" and inserting instead —

10 seconds, after the fruit has been completely wetted;

(b) in paragraph (b)(i) by deleting "1.2mg/Lm² per minute for at least 15 seconds;" and inserting instead —

0.6mg/Lm² per minute for at least 10 seconds, after the fruit has been completely wetted;

- (2) Schedule 1, Part B, item 31 is amended after "fruit" by inserting
 - " (other than banana fruit) ".

5. Schedule 8 amended

Schedule 8, item 15A is amended by deleting "Kimberley Area" and inserting instead —

" Ord River Irrigation Area".

- 18.0 Closure of Meeting
- (b) Clauses 4.1 and 4.2 be deleted and replaced with the following—

Minutes of Council Meetings

4.1 Except as provided for in Clause 2.10 the minutes of any preceding meeting of the Council, whether Ordinary or Special, not previously confirmed, shall be submitted and confirmed at Ordinary Meetings of the Council and no discussion thereon shall be permitted except as to their accuracy as a record of the proceedings, and each page of the minutes shall then, if found to be correct, be initialled and dated by the Chairperson. The Chairperson shall also sign and date a certification statement to the effect that the minutes were confirmed by the Council at the (describe meeting) held on (date), which will be included on the final page of such minutes.

Minutes of Committee Meetings

- 4.2 (1) The minutes of any Committee Meeting shall be submitted to the next meeting of that Committee for confirmation as the their accuracy as a record of the proceedings and each page of those minutes shall then, if found to be correct, be initialled and dated by the Chairperson of that Committee. The Chairperson shall then also sign and date a certification statement to the effect that the minutes were confirmed by the Committee at the (describe meeting) held on (date), which will be included on the final page of such minutes.
 - (2) Reports from Committee Meetings containing a recommendation/ recommendations shall be included within the next Ordinary Council Meeting Agenda for formal consideration by the Council. Any member of the Council may move the adoption of a Committee recommendation.
 - (3) When a recommendation of any Committee is submitted for adoption by the Council, any member of the Council may direct questions directly relating to the recommendation through the Council Meeting Chairperson to any member of the Committee in attendance
 - (4) A recommendation made by a Committee may be adopted by the Council without amendment or modification, failing which, it may be
 - a. Rejected by the Council and replaced by an alternative decision,
 - b. Amended or modified and adopted with such amendment or modification, or
 - c. Referred back to the Committee for further consideration.
- (c) Heading Clause 16.0 and Clause 16.1 be deleted and replaced with the following— $\,$

16.0 Motion—That the Meeting be closed to the Public

- 16.1 All Meetings shall be open to the public except when the Meeting resolves to close the Meeting or part of the Meeting to the public to deal with any matter as listed in Section 5.23(2) of the Act.
- (d) Clause 19.5 be deleted and replaced with the following—

Standing Orders apply to Committees

19.5 These Standing Orders generally apply to the proceedings of Committees.
