- (2) After regulation 608(1) the following subregulation is inserted —

(1a) The Commissioner may delegate, to an officer of the rank of Superintendent or higher, the approval power conferred on the Commissioner under subregulation (1)(b).

RULES OF HARNESS RACING 1999

Notice of Amendment

Notice is hereby given that the Committee of the Western Australian Trotting Association at Gloucester Park, East Perth, on the <u>2nd August 2001</u>, resolved by majority of members of the Committee that the Rules of Harness Racing 1999 be amended as follows:

Local Rule 256AA be inserted as follows-

LR256AA. Penalties—total carbon dioxide

- (1) A person who is convicted of an offence under Rule 190 in respect of the prohibited substance, total carbon dioxide (TCO₂), is liable to a penalty:
 - (a) in the case of a first such offence, of:
 - (i) \$5,000; or
 - (ii) 6 months suspension;
 - (b) in the case of a second such offence, of:
 - (i) \$7,500; or
 - (ii) 8 months suspension;
 - (c) in the case of a third such offence, of:
 - (i) \$15,000 and 3 months suspension; or
 - (ii) 6 months disqualification;
 - (d) in the case of a fourth or subsequent such offence, of not less than 12 months disqualification,

unless the Stewards consider that special circumstances exist which justify the imposition of a higher penalty, in which event, the Stewards may impose a higher penalty.

(2) Where a convicted person referred to in subclause (1) proves that he or she took reasonable and proper precautions to ensure that the horse was presented for a race free of prohibited substances then the Stewards may impose a lesser penalty than those specified in subclause (1).

"

(3) A convicted person referred to in subclause (1) may elect, at the time of conviction, which of the alternative penalties in paragraphs (a), (b) and (c) of subclause (1), as the case may be, is to apply, and if the convicted person fails to so elect then the Stewards shall determine the alternative to apply.

1. Definitions

CITY OF PERTH TOWN PLANNING SCHEME No. 24

1. Title

This Town Planning Scheme may be referred to as the City of Perth Town Planning Scheme No. 24.

2. Commencement

This Scheme shall come into operation on the publication of notice of the Minister's final approval thereof in the *Government Gazette*.

3. Scheme Documents

This Scheme comprises the following documents—

- (a) the Scheme text; and
- (b) the Scheme map.

4. Definitions

In this Scheme, unless the context requires otherwise, the words and expressions used have the meanings set out in Schedule 1.

5. Scheme Area

This Scheme applies to the Scheme area.

6. Responsible Authority

The Authority responsible for administering this Scheme is the Council of the City of Perth ("the Council").

7. Scheme Objects

The objects of this Scheme are to facilitate—

- (a) the development of the Land area indicated on the Scheme Map as a whole in a coordinated manner;
- (b) the adequate provision of landscaped areas and green space offering attractive areas for pedestrians and residents;
- (c) the coordination of vehicular access to the Scheme Area from Terrace Road.

8. Metropolitan Region Scheme

This Scheme is complementary to and is not a substitute for the Metropolitan Region Scheme and the provisions of the Metropolitan Region Scheme shall continue to have effect.

9. City Planning Scheme

- (1) This Scheme is complementary to, and not a substitute for the City of Perth City Planning Scheme.
- (2) Where a provision of this Scheme is inconsistent with a provision of the City Planning Scheme, the provision of this Scheme prevails.
- (3) A reference in clause 48 of the City Planning Scheme to "a standard or requirement prescribed by the Scheme" shall include a standard or requirement prescribed by this Scheme.
- (4) A reference in clause 160(d) of the City Planning Scheme to 'all standards laid down and all requirements prescribed by the Scheme' shall include all standards laid down and all requirements prescribed by this Scheme.

10. Local Laws

Where a provision of this Scheme is inconsistent with a provision of a local law, the provision of this Scheme prevails.

11. Plot Ratio

For the purpose of determining plot ratio under the City Planning Scheme, with respect to land within the Scheme area, the Land area indicated on the Scheme Map shall be treated as one site. Plot ratio allowance shall be calculated on the basis of the shaded area on the Scheme Map and shall be applied to all development within the Scheme Area.

12. Car Parking

For the purpose of determining parking provision under the City Planning Scheme, with respect to land within the Scheme area, the Land area indicated on the Scheme map shall be treated as one site.

13. Application for Town Planning Approval

- (1) Notwithstanding the provisions of the City Planning Scheme but subject to the provisions of sub clause (2) of this clause, an application for town planning approval shall be signed by every owner of land comprising the Scheme area.
- (2) An agent authorised in writing for that purpose by an owner of land within the Scheme area may sign an application for town planning approval on behalf of the owner.
- (3) In addition to any plans and information required by the City Planning Scheme or by the Council pursuant to the City Planning Scheme, where a proposed development may affect parts of the Scheme area other than the land the subject of the application, the Council may require an application for town planning approval to be accompanied by such plans and information with respect to those parts of the Scheme area as will enable the Council to determine the application.

14. Determination of Applications for Town Planning Approval

- (1) When considering an application for town planning approval, the Council may, in addition to any other matter or thing which it may consider, have regard to the objects of this Scheme.
- (2) If the Council grants town planning approval then the Council may do so subject to conditions—
 - (a) which the Council considers necessary or convenient for the implementation of the objects of this Scheme.
 - (b) which may require an owner of land in the Scheme area to enter into an agreement with the Council or other owners of land within the Scheme area, with respect to the general objects of this Scheme.

15. Existing Town Planning Approval

No provision of this Scheme is to limit or restrict the carrying out of any development in respect of which town planning approval has been granted before the commencement of this Scheme.

16. Agreements

The Council may enter into an agreement with any owner of land within the Scheme area which the Council considers necessary or convenient for the implementation of the objects of this Scheme.
