Poisons Act 1964

## Poisons Amendment Regulations (No. 3) 2001

Made by the Governor in Executive Council.

### 1. Citation

These regulations may be cited as the *Poisons Amendment Regulations (No. 3) 2001*.

## 2. The regulations amended

The amendments in these regulations are to the *Poisons Regulations 1965\**.

[\* Reprinted as at 12 May 2000. For amendments to 27 July 2001 see Gazette 29 June 2001.]

## 3. Regulation 2A amended

Regulation 2A(d) is amended as follows:

- (a) by deleting "Appendix P" and inserting instead
  - " Appendix I ";
- (b) in subparagraph (ii) by deleting "Appendix P" and inserting instead
  - " Part 2 ".

## 4. Regulations 3 and 4 replaced and transitional

(1) Regulations 3 and 4 are repealed and the following regulation is inserted instead —

### 3. Wholesaler's licence

- (1) A wholesaler's licence authorises the licensee to procure, manufacture and supply by wholesale dealing specified poisons at or from specified premises.
- (2) A wholesaler's licence is to be in the form of Form 1 in Appendix A.

- (3) A wholesaler's licence is subject to the condition that any manufacture of a poison under the licence be carried out by
  - (a) a specified qualified person or a qualified person authorised under subregulation (4); or
  - (b) an experienced person acting under the personal supervision of a person referred to in paragraph (a).
- (4) A wholesaler's licence is subject to the condition that any supply of a poison under the licence be carried out by
  - (a) a specified qualified person or a qualified person authorised under subregulation (4); or
  - (b) a specified experienced person or an experienced person authorised under subregulation (4).
- (5) If a person specified in a wholesaler's licence for the purposes of subregulation (3)(a) or (4)
  - (a) ceases to work for the licensee; or
  - (b) in the case of a qualified person specified for the purposes of subregulation (3), is unable to exercise the necessary supervision,

the Commissioner of Health may in writing authorise another qualified or experienced person (as the case requires) to act in the specified person's stead.

(6) In this regulation —

"specified" means specified in a wholesaler's licence.

(2) A licence issued under regulation 4 of the *Poisons*Regulations 1965 and in force immediately before the day on which this regulation commences, continues in force on and after that day, as if it were a licence issued under regulation 3 of those regulations as amended by this regulation.

## 5. Regulation 33B amended

Regulation 33B is amended by deleting "Appendix P" in both places where it occurs and inserting instead —

" Appendix I ".

## 6. Regulation 38D amended

- (1) Regulation 38D(1) is amended by deleting "acetretin" in both places where it occurs and inserting instead
  - " acitretin ".

(2) Regulation 38D(1a) is repealed and the following subsection is inserted instead —

(1a) Where etretinate or acitretin or a substance containing etretinate or acitretin is supplied in accordance with a prescription under subregulation (1) the supplier shall ensure that the container in which the etretinate or acitretin or the substance containing etretinate or

acitretin is supplied, is labelled with a statement as follows —

"WARNING — CAUSES BIRTH DEFECTS".

(3) Regulation 38D(2) is amended by deleting "acetretin" in both places where it occurs and inserting instead —

" acitretin ".

## 7. Regulation 38F amended

Regulation 38F(1a) is repealed and the following subsection is inserted instead —

(1a) Where isotretinoin or a substance containing isotretinoin is supplied in accordance with a prescription under subregulation (1) the supplier shall ensure that the container in which the isotretinoin or the substance containing isotretinoin is supplied, is labelled with a statement as follows —

"WARNING — CAUSES BIRTH DEFECTS".

## 8. Regulation 38G amended

Regulation 38G(2) is repealed and the following subsection is inserted instead —

(2) Where thalidomide or a substance containing thalidomide is supplied in accordance with a prescription under subregulation (1) the supplier shall ensure that the container in which the thalidomide or the substance containing thalidomide is supplied, is labelled with a statement as follows —

"WARNING — CAUSES BIRTH DEFECTS

DO NOT USE IF PREGNANT

OR LIKELY TO BECOME PREGNANT".

## 9. Regulation 41A amended

- (1) Regulation 41A(2) is amended as follows:
  - (a) in paragraph (b) by deleting ", occupation";
  - (b) in paragraph (e) by deleting "and purpose".
- (2) Regulation 41A(3) is amended as follows:
  - (a) after paragraph (a) by deleting "or";
  - (b) at the end of paragraph (b) by deleting the full stop and inserting a semicolon instead;
  - (c) after paragraph (b) by inserting —

(c) such other form as the Commissioner of Health approves in writing.

10. Regulation 44 amended

After regulation 44(3) the following subregulation is inserted —

(3a) An authorised person is to record, or cause to be recorded, in the Register the result of each inventory made by the authorised person under regulation 45 on the day on which the inventory is made.

11. Regulation 44B amended

After regulation 44B(1) the following subregulation is inserted —

(1a) If a register is maintained on paper, all entries required to be made in the register are to be made in ink.

## 12. Regulation 45 amended

Regulation 45(1) is amended as follows:

- (a) at the end of paragraph (c) by deleting the full stop and inserting a comma instead;
- (b) by inserting after paragraph (c) —

and the result of that inventory is to be recorded in the Register in accordance with regulation 44(3a).

## Poisons (Specified Drugs) Order 2001

Made by the Governor in Executive Council.

#### 1. Citation

This order may be cited as the *Poisons (Specified Drugs)* Order 2001.

#### 2. Commencement

This order comes into operation on the day on which it is published in the *Gazette*.

## 3. Specified drugs

The following are declared to be specified drugs for the purposes of the Act —

- (a) the substances listed in Schedule 1 to this order;
- (b) the salts, esters and derivatives of those listed substances;
- (c) substances containing
  - (i) any of those listed substances; or
  - (ii) the salts, esters or derivatives of any of those listed substances.

## 4. Revocation

The Poisons (Specified Drugs) Order (No. 2) 1989 is revoked.

SOIL AND LAND CONSERVATION (WEST KIMBERLEY LAND CONSERVATION DISTRICT) AMENDMENT ORDER 2001

Made by the Governor in Executive Council under sections 22 and 23 of the Soil and Land Conservation Act 1945 on the recommendation of the Minister for Agriculture.

#### 1. Citation

This order may be cited as the Soil and Land Conservation (West Kimberley Land Conservation District) Amendment Order 2001.

#### 2. Principal Order

In this order the Soil and Land Conservation (West Kimberley Land Conservation District) Order 1992\* is referred to as the principal order.

#### 3. Clause 2 deleted and replaced

Clause 2 of the principal order is deleted and replaced with the following—

#### 2. Interpretation

Words and phrases used in this order have the same meaning as in the Soil and Land Conservation Act 1945

#### 4. Clause 5 deleted and replaced.

Clause 5 of the principal order is deleted and replaced with the following—

#### 5. Constitution of committee

- (1) It is determined, on the recommendation of the Minister, after consultation with the Shire of Derby/West Kimberley, that the district committee is to comprise 18 members, of whom—
  - (a) one is to be the Commissioner of Soil and Land Conservation or a nominee of the Commissioner; and
  - (b) the others are to be appointed by the Commissioner.
- (2) Of the members appointed under subclause (1)(b)—
  - (a) one is to be appointed on the nomination of the Shire of Derby/West Kimberley;
  - (b) one is to be appointed under subclause (3);
  - (c) two are to be appointed under subclause (4);
  - (d) 13 are to be persons actively engaged in, or affected by or associated with, land use in the district.
- (3) The Western Australian Farmers Federation (Inc.) is to submit to the Commissioner a panel containing the names of persons willing to be appointed as members of the committee and, where such a panel is submitted, two persons whose names appear on the panel are to be appointed by the Commissioner.
- (4) The Pastoralists and Graziers Association is to submit to the Commissioner a panel containing the names of persons willing to be appointed as members of the committee and, where such a panel is submitted, one person whose name appears on the panel is to be appointed by the Commissioner.
- (5) The Commissioner may terminate the appointment of a member appointed under subclause (1)(b).

(6) A member appointed under subclause (1)(b) may resign his or her office by written notice addressed to the Commissioner.

#### 5. Clause 6 deleted and replaced.

Clause 6 of the principal order is deleted and replaced with the following—

#### 6. Proceedings of the committee

To the extent that they are not provided for under the *Soil and Land Conservation Act 1945* or Part VII of the *Interpretation Act 1984*, the committee may determine its own procedures.

#### FIRE BREAK ORDER

Notice to Owners and/or Occupiers of Land within, the City of Swan

Pursuant to Section 33 of the Bushfires Act, 1954 you are hereby required on or before the 2<sup>nd</sup> November, 2001, or within 14 days of the date of you becoming owner or occupier should this occur after 2<sup>nd</sup> November 2001, to remove from the land owned or occupied by you, all inflammable material or to clear firebreaks in accordance with the following requirements, and thereafter to maintain the land or the firebreaks clear of inflammable material up to and including the 31st day of March, 2002.

#### GENERAL

- 1. Where the area of land is less than 100 hectares, clear and maintain firebreaks at least 3 metres wide immediately inside all external boundaries of the land and immediately surrounding all buildings on the land.
- 2. Where the area of land is greater than 100 hectares, clear and maintain firebreaks—
  - (a) at least 3 metres wide immediately inside all external boundaries of the land and immediately surrounding all buildings on the land, and
  - (b) at least 3 metres wide in such a position so as to divide the land into the areas not exceeding 100 hectares, with each area to be enclosed by such a firebreak.

#### FUEL DUMPS

On all land where fuel drum ramps are located and where fuel dumps, whether containing fuel or not, are stored, clear and maintain a firebreak at least four metres wide around any drum, ramp or stack of drums.

#### HAY STACKS

Clear and maintain a firebreak at least 3 metres wide completely surrounding any haystack on the land, within 60 metres of the haystack.

#### PINE PLANTATIONS

- 1. Clear and maintain a firebreak at least 10 metre wide—
  - (a) immediately surrounding any area of land on which pine trees are planted,
  - (b) along the boundary of those portions of pine plantations which adjoin a formed public road; and
  - (c) in such positions so that the area of pine plantation bounded by each firebreak does not exceed 200 hectares.

In addition, to the firebreaks required by this notice, pine plantations traversed by Western Power transmission lines have additional obligations under the State Energy Commission Act.

#### BURNING

The requirements of this notice to provide a firebreak, other than an alternative or strategic firebreak may be carried out by burning. That burning must be in accordance with the relevant provisions of the Bushfires Act, 1954.

## ALTERNATIVE FIREBREAKS

- 1. (a) Should you consider it to be impracticable for any reason to clear firebreaks or remove inflammable material from the land as required by this notice, you may apply to the Council in writing on or before the 15th October, 2001, for permission to provide firebreaks in alternative positions or to take alternative action to abate fire hazards on the land. If permission is not granted in writing by the Council prior to 2nd November 2001, you shall comply with the requirements of this notice
- (b) When written permission to provide alternative firebreaks has been granted, you shall—
  - (i) comply with all conditions endorsed on the permit.
  - (ii) provide firebreaks at least 3 metres wide in the agreed position(s) on the land.
- 2. (a) Where the Council has, in writing, approved a Fire Management Plan and the Fire Management Plan depicts an array of alternative firebreaks, an owner may as an alternative to the construction of a general firebreak, elect to provide the alternative firebreak depicted on the Bushfire Management Plan. However, where the alternative firebreak is not constructed by the date required by this notice, the general firebreak requirements shall apply.
- (b) Any alternative firebreak provided for under (c) above shall be of the same width requirements as that applicable to a general firebreak but shall be limited to the extent and location depicted on the Bushfire Management Plan.

- (a) Where, under an agreement with the Council, or where depicted on an approved Bushfire Management Plan, strategic firebreaks are required to be provided on the land you are required to clear and maintain firebreaks at least 6 metres wide in the agreed position.
- (b) Strategic firebreaks shall be graded to provide a continuous trafficable surface (suitable for 4 wheel drive vehicles) at least 4 metres wide unimpeded by obstructions including boundary or dividing fences unless fitted with approved gates.

#### FIREBREAK CONSTRUCTION

Without affecting the generality of any other provision herein requiring trafficable firebreaks, all firebreaks required by this order on properties greater than 5 hectares in area shall be constructed and maintained in a condition trafficable by 4 wheel drive vehicles. Overhanging trees abutting firebreaks shall be pruned to minimise accumulation of litter and to allow unimpeded access to vehicles up to 4 metres high.
