# Associations Incorporation Amendment Regulations 2001

Made by the Governor in Executive Council.

#### 1. Citation

These regulations may be cited as the *Associations Incorporation Amendment Regulations 2001*.

#### 2. Schedule 1 amended

Schedule 1 of the *Associations Incorporation Regulations 1988\** is amended in Forms 1, 2, 3 and 4 by deleting "Commissioner for Corporate Affairs" and inserting instead —

" Commissioner for Fair Trading ".

#### **LOCAL GOVERNMENT ACT 1995**

LOCAL LAW RELATING TO THE CONDUCT OF PROCEEDINGS AND THE BUSINESS OF COUNCIL (STANDING ORDERS) AMENDMENT

Under the power conferred by the *Local Government Act 1995* and all other powers, the Council of the Shire of Bridgetown-Greenbushes resolved on 27<sup>th</sup> September 2001 to amend the Shire of Bridgetown-Greenbushes Local Law Relating to the Conduct of

Proceedings and the Business of Council (Standing Orders) published in the  $Government\ Gazette$  on  $25^{\rm th}\ July\ 2000$ , in the following manner—

#### 1. Clause 2.11—New Business of an Urgent Nature

1.1 In Clause 2.11—

After the word "circumstances", insert "where this is clearly demonstrated and shall not include where the Item can be dealt with at a subsequent meeting,"

#### 2. Clause 2.12(1)—Ordinary Meetings

2.1 In Clause 2.12(1)(e)—

Delete the words—"The Officers Recommendation will be initially considered and if not accepted, reasons shall be provided. Council may however suspend consideration of the Officers Recommendation until completing debate on any alternatives previously provided (as per this clause) or amendments arising from the debate."

2.2 In Clause 2.12(1)(f)—

After the words "By a member wishing to ask a question regarding any item", insert "(where the question cannot be answered prior to the meeting by an Officer)".

2.3 In Clause 2.12(1)(g)—

Delete clause 2.12(1)(g) and substitute "By the meeting on a motion to that effect being carried and the item, where for some reason it cannot be dealt with at the meeting, will automatically be carried over to the next meeting unless Council resolves to deal with it as late urgent business. Council shall specify the reason(s) and the type/extent of any additional information required."

2.4 Add new Clause 2.12(h)-

"Where a Council Decision is significantly different to an Officers or Committee Recommendation, each Councillor who voted against supporting the Recommendation shall, prior to the next Item of Business, provide a brief written statement (on the form provided) detailing the specific reason(s) for not supporting the Recommendation provided."

#### 3. Clause 6.2—Motions to be Considered

3.1 In Clause 6.2—

After the words "shall be considered by the council", insert "irrespective of clause 2.12(1)(e),"

#### 4. Clause 7.1—Deputations

4.1 In Clause 7.1(3) -

Delete clause 7.1(3) and substitute the following "A deputation shall cease speaking within 5 minutes unless pre-arranged prior to the meeting with the permission of the Presiding Member."

#### 5. Clause 10.1—Personal Explanation

In Clause 10.1(2)—

After the words "member's former speech", insert "actions or in-actions"

#### 6. Clause 11.6—Withdrawal of Motions

6.1 In Clause 11.6—

Delete clause 11.6 and substitute -

- "11.6(1) A motion may be withdrawn by the mover with the consent of the meeting which shall be signified without debate and it shall not be competent for any member to speak upon the motion after the mover has asked consent for its withdrawal, unless that consent is refused.
- 11.6(2) A amendment may be withdrawn by the mover with the consent of the meeting which shall be signified without debate and it shall not be competent for any member to speak upon the amendment after the mover has asked consent for its withdrawal, unless that consent is refused."

#### 7. Clause 13.3—Who May Move Motion

7.1 In Clause 13.3(1)—

After the words "before the meeting", insert "(or at a subsequent meeting(s))"

#### 8. Clause 14.1—Motion for Adjournment of Debate

8.1 In Clause 14.1—

After the word "debate", insert "on the issue"

#### 9. Clause 19.2—Attendance by Members as Observers

9.1 In Clause 19.2—

After the words "other committee meetings as an observer" add "other than where restricted by virtue of Part 5, Division 6, Subdivision 1 for the same reasons as applies to members of the public as indicated in Section 5.23(2) of the Local Government Act 1995 and provided their presence does not compromise the functioning of the committee."

#### 10. Clause 22.0—Enforcement

 $10.1\,$  Delete clauses 22.1 (Offence); 22.2 (Penalty) and 22.3 (Enforcement) and substitute—

#### "22.1 Offence

A person who breaches any clause of the standing orders commits an offence. Any person accused of breaching the Standing Orders shall be provided with an opportunity at the time of the complaint to make a personal explanation and apology to the complainant and or the Council or Committee. If the Council or committee does not accept the personal explanation or apology from the person who committed the offence, then it shall be treated by Council as a breach whereupon the CEO is authorised to immediately commence court proceedings.

10.2 22.2 Penalty for Breach of Standing Orders

Any persons found guilty of any breach of the Standing Orders or any of the provisions hereof by a Court of competent jurisdiction shall be liable to a penalty upon conviction not exceeding one thousand dollars (\$1,000).

10.3 22.3 Duty of CEO in Relation to Breach of the Standing Orders

It is the duty and responsibility of the CEO to draw the attention of the Council or any committee, as the case may be, to any apparent breach of the Standing Orders.

10.4 22.4 Enforcement

The provisions of the standing Orders shall be enforced by the presiding member of any Council or committee meeting but only following the specific direction of the Council or committee by resolution by a simple majority."

#### CALL FOR PUBLIC SUBMISSIONS

The Western Australian Planning Commission is considering proposals to amend the Metropolitan Region Scheme for land in the Cities of Canning, Cockburn, Fremantle, Gosnells, and Rockingham and the Town of Kwinana. Public comment is invited.

#### Purpose

The purpose of these proposed Amendments is to give effect to a total of forty one changes to zones and reservations of the Metropolitan Region Scheme. The individual proposals are contained within four Amendments.

Amendment No. 1032/33—will facilitate finalisation of the land requirements for the South West Metropolitan Transit system including land for the passenger rail

between Perth and Mandurah and part of the (Bus) Transitway between Fremantle and Rockingham.

Amendment No. 1038/33—will facilitate the development of a new town centre, which is integrated with the passenger rail, recreation areas, shops and surrounding residential, industrial and mixed business areas in the Jandakot locality.

Amendment No. 1039/33—will facilitate development of a maritime precinct on the western end of Victoria Quay at Fremantle.

**Amendment No. 1040/33**—will facilitate the extension of Tapper Road southwards as part of the local road network in Banjup.



#### OCCUPATIONAL SAFETY AND HEALTH ACT 1984

OCCUPATIONAL SAFETY AND HEALTH REGULATIONS 1996 EXEMPTION CERTIFICATE PURSUANT TO REGULATION 2.13

(No. 7 of 2001)

I, BRIAN THOMAS BRADLEY, WorkSafe Western Australia Commissioner, hereby grant an exemption to Wylie & Skene Pty Ltd from the requirements of Regulation 3.123 of the *Occupational Safety and Health Regulations 1996* in relation to demolition work at Unit 17 Lot 1928 Ridley Street, Karratha.

This exemption is granted from the requirement to demolish in accordance with AS2601, however, is subject to the following conditions:

- (i) All adjacent property owners and occupiers are notified of the proposed demolition and prohibited from entering the boundaries of the site during the work;
- (ii) Adequate public protection is maintained around the site;
- (iii) The local authority environmental health officer also approves the methodology proposed;
- (iv) All persons involved in the demolition work wear the appropriate asbestos related PPE at all times during the demolition work;
- (v) The structure is saturated with water prior to and during the demolition work.
- (vi) The demolition work and clearing of the asbestos cement sheeting is carried out over a one (1) day period;
- (vii) The clearing of the asbestos cement sheeting is carried out in accordance with section 9 of the Code of Practice for the Safe Removal of Asbestos [NOHSC:2002 (1988)];
- (viii) The excavator used for the demolition process does not run over any demolished material and is only used to push over the building; and
  - (ix) All demolished material is treated as asbestos waste material.
