CONSERVATION AND LAND MANAGEMENT (RESERVATION OF STATE FOREST) ORDER (No. 5) 2001

Made by the Governor in Executive Council under section 8(1) of the Conservation and Land Management Act 1984.

1. Citation

This order may be cited as the Conservation and Land Management (Reservation of State Forest) Order (No. 5) 2001.

2. Background to this order

- (i) In 1973 the then Forests Department made the first of several attempts to get about 6,000 hectares of Crown land situated approximately 15 kilometres east of Yanchep added to the adjoining State forest No. 65.
- (ii) Recommendations to this effect were recorded in management plans produced by the Department of Conservation and Land Management in 1987 and 1994.
- (iii) Western Power Corporation became interested in achieving the desired aim when it decided to construct a gas turbine power station on part of the area. The Corporation requires an undeveloped, vegetated buffer for at least a three kilometre radius around the power station (Reserve No. 41494) to ensure that no urbanisation occurs within that buffer zone.
- (iv) All of the necessary clearances have now been obtained to complete the proposed addition.

3. Addition to State forest No. 65

The land described in Schedule 1 is reserved as an addition to State forest No. 65.
