Shire of Coolgardie

HEALTH AMENDMENT LOCAL LAWS 2001

Made by the Council of the Shire of Coolgardie under section 342 of the Health Act 1911 in accordance with subdivision 2 of Part 3 of the Local Government Act 1995.

Citation

1. These local laws may be cited as the Shire of Coolgardie Health Amendment Local Laws 2001.

Principal local laws

2. In these local laws, the Shire of Coolgardie Health Local Laws 1998 made under the Health Act 1911 and passed by the Council of the Shire of Coolgardie on 26 November 1998, by notice published in the *Government Gazette* [No. 51 Special] on 31 March 1999 and amended by the Shire of Coolgardie Health Amendment Local Laws 2000 made under the Health Act 1911 and passed by the Council of the Shire of Coolgardie on 27 July 2000, by notice published in the *Government Gazette* on 27 March 2001, are referred to as the principal local laws.

Subsection 48(1) amended

3. The principal local laws are amended in Part 4, Division 2, by deleting subsection 48(1) and substituting the following—

- '(1) A person shall not remove any rubbish or refuse from premises unless that person is— $\!\!\!$
 - (a) the owner or occupier of the premises;
 - (b) authorised to do so by the owner or occupier of the premises; or
 - (c) authorised in writing to do so by the Council.'

LOCAL GOVERNMENT ACT 1995

Shire of Broome

REPEAL OF OUTDATED LOCAL LAWS LAW 2001

PREAMBLE

Under the powers conferred by the Local Government Act 1995 and by all other powers, the local government of the Shire of Broome resolved to make the following local law on 18th day of December 2001.

PART 1—INTRODUCTORY MATTERS

1.1 This law may be cited as the Shire of Broome Repeal of Local Laws Law 2001.

Commencement

1.2 This Local Law comes into operation on the 14^{th} day after the day on which it is published in the *Gazette*

Content and Intent

1.3 (1) This local law—

- (a) provides for the repeal of outdated local laws;
- (b) identifies the outdated local laws by giving their names and the date they were first printed in the *Gazette*;
- (2) This local law is intended to result in-
 - (a) more efficient and effective local government by removing outdated local laws from the public record.

PART 2—SUBSTANCE OF THIS LAW

2.1 Repeal

The following local laws are hereby repealed-

- (1) Relating to Role for Special Loan Poll published in the *Government Gazette* on 16 April 1920.
- (2) Relating to Discount on Rates published in the *Government Gazettes* on 11 March 1927 and 13 September 1946.
- (3) Caravan Parks and Camping Grounds published in the Government Gazettes of 5 February 1971, 19 March 1992 and 3 March 1994.

LOCAL GOVERNMENT ACT 1995

City of Bayswater

ACTIVITIES ON THOROUGHFARES AND TRADING IN THOROUGHFARES AND PUBLIC PLACES LOCAL LAW

Under the powers conferred by the *Local Government Act 1995* and under all other powers enabling it, the Council of the City of Bayswater resolved on 20th day of November 2001 to amend the following local law.

2.1 General prohibitions

(d) After the words "fruit skins" the following is inserted ", object".

3.4 Conditions on portable sign

If the local government approves an application for a permit for a portable sign, the application is to be taken to be approved subject to the following conditions—

(a) the portable sign shall—

After sub-clause (x) the following is inserted—

"(x) when constructed from a piece of material in the form of a banner be permitted to a maximum height of 1.20m in height, and 3.50m in width securely affixed to poles of sufficient size and strength to support the banner under all conditions."

3.5 Election sign

Delete "3.5 Election Sign" and substituted with "3.5 Conditions of Election Signs"

Delete "The erection or placement of an election sign on a thoroughfare throughout the City of Bayswater shall not be permitted." and substitute "If the local government approves an application for permit for the erection or placement of an election sign on a thoroughfare, the application is to be taken to be approved subject to the sign—

- (a) being erected at least 30m from any intersection;
- (b) being free standing and not being affixed to any existing sign, post, power or light pole, or similar structure;
- (c) being placed so as not to obstruct or impede the reasonable use of a thoroughfare, or access to a place by any person;
- (d) being placed so as not to obstruct or implede the vision of a driver of a vehicle entering or leaving a thoroughfare or crossing;
- (e) being maintained in good condition;
- (f) not being erected until the election to which it relates has been officially announced;
- (g) being removed within 24 hours of the close of polls on voting day;
- (h) not being placed within 100m of any works on the thoroughfare;
- (i) being securely installed;
- (j) not being an illuminated sign;
- (k) not incorporating reflective or fluorescent materials; and

(l) not displaying only part a message which is to be read with other separate signs in order to obtain the whole message."

- 6. declare that you are to report by 31 August 2003;
- 7. declare that, by virtue of this commission, you may in the execution of this commission do all the acts, matters and things and exercise all the powers that a Royal Commission may lawfully do and exercise, whether under the *Royal Commissions Act 1968* or otherwise;
- 8. declare that section 18 of the Royal Commissions Act 1968 applies to the Royal Commission;
- 9. declare that in conducting the inquiry you may
 - (a) do anything that you consider appropriate in order to avoid prejudice to pending or prospective criminal proceedings, including taking evidence or otherwise proceeding in private, precluding the publication of evidence or deferring the taking of evidence; and

- (b) during the course of the inquiry refer any matter to an appropriate authority, where you consider that delaying that action until the completion of your report would be undesirable;
- 10. declare that in your report you may make any recommendations you consider appropriate.

RULES OF HARNESS RACING 1999

Notice of Amendment

Notice is hereby given that the Committee of the Western Australian Trotting Association at Gloucester Park, East Perth, on the 13th December 2001 resolved by majority of members of the Committee that the Rules of Harness Racing 1999 be amended as follows—

- 1. Amend Rule 75(2(d) by adding the words "and once made cannot be withdrawn;" after the existing word "race;".
- 2. Replace the existing wording of Rule 91(3) with "Notwithstanding sub-rule 1(b), unless otherwise determined by the Stewards a driver suspended for a period not exceeding 3 months is eligible to drive in a trial other than a time trial."
- 3. Insert Rule 96A part (1) and (2) as follows—
 - (1) The Controlling Body may on application made by the owner of a horse withdraw the registration certificate of the horse.
 - (2) A horse which has its registration certificate withdrawn shall not be issued with another registration certificate without the written consent of the owner who applied for the withdrawal of the original registration certificate.
- 4. Insert Rule 103B as follows-

103B. Pregnant mares

A mare or filly shall not race or perform track work after day 120 of its pregnancy.

- 5. Insert Rule 162(1)(ww) as follows—
 - (ww) allow his or her horse to shift from its running line unless it is commencing a forward move or improving its position.
- 6. Insert Rule 162(1)(z) as follows—
 - (z) fail to fully drive his or her horse out to the end of the race.

The boundary parts of Forest Lakes Drive (both sides), Murdoch Road (south side), Yale Road (both sides), Garden Street (north east side) and Warton Road (north side) are included within the local-intake area of Forest Crescent Primary School.

The following is an optional area between Forest Crescent and Huntingdale Primary Schools—

From the junction of Ranford Road and Southern River Road, north east along Southern River Road to Gay Street, north west along Gay Street and its extension to Warton Road, south west along Warton Road to the junction of the north west extension of Barrett Street, south east along this extension and Barrett Street to Balfour Street, south west along the proposed Balfour Street to Ranford Road and south east along Ranford Road to Southern River Road.

The boundary parts of Southern River Road (both sides), Gay Street (both sides) and Warton Road (south east side), Barrett Street (north east side) and proposed Balfour Street (south east side) are included within this optional area. The boundary parts of Ranford Road (both sides) are excluded from this optional area.

The following is an optional area between East Canning Vale Primary School and Forest Crescent Primary School—

From the junction of Nicholson Road and Garden Street, south west along Nicholson Road to Hughes Street, south east along Hughes Street to Fraser Road North, south west along Fraser Road North to Shreeve Road, south east along Shreeve Road to Warton Road, north east along Warton Road to Garden Street and north west and north along Garden Street to Nicholson Road. The boundary parts of Nicholson Road (south side), Hughes Street (east side), Fraser Road North (south side), Shreeve Road (east side), Warton Road (north side) and Garden Street (west side) are included within this optional area.

HUNTINGDALE PRIMARY SCHOOL

The following defines the local-intake area of this school-

From the junction of Warton Road and Gay Street, north east along Warton Road to Corfield Street, south east along Corfield Street to the Southern River, generally south along the Southern River to Southern River Road, south west along Southern River Road to Gay Street and north west along Gay Street to Warton Road.

The boundary parts of Warton Road (south east side) and Corfield Street (south side), Southern River Road (north east side) are included within the local-intake area of this school. The boundary street, Gay Street (both sides), is excluded from this area.

The following is an optional area between Forest Crescent and Huntingdale Primary Schools-

From the junction of Ranford Road and Southern River Road, north east along Southern River Road to Gay Street, north west along Gay Street and its extension to Warton Road, south west along Warton Road to the junction of the north west extension of Barrett Street, south east along this extension and Barrett Street to Balfour Street, south west along the proposed Balfour Street to Ranford Road and south east along Ranford Road to Southern River Road.

The boundary parts of Southern River Road (both sides), Gay Street (both sides) and Warton Road (south east side), Barrett Street (north east side) and proposed Balfour Street (south east side) are included within this optional area. The boundary parts of Ranford Road (both sides) are excluded from this optional area.

KINLOCK PRIMARY SCHOOL

The following defines the local-intake area of this school-

From the junction of Metcalfe Road and Ferndale Crescent, north west along Ferndale Crescent and its extension to the Canning River, generally east and south east along the Canning River to Nicholson Road, south west along Nicholson Road to Fleetwood Road, north west along Fleetwood Road to Kenton Street, south west along Kenton Street to Edgeware Street, north west along Edgeware Street and its extension to Metcalfe Road and north east along Metcalfe Road to the junction with Ferndale Crescent.

The boundary parts of Ferndale Crescent (both sides), Nicholson Road (west side) and Metcalfe Road (south side) are included within the local-intake area of this school. The boundary parts of Fleetwood Road (both sides), Kenton Street (both sides) and Edgeware Street (both sides) are excluded from the local-intake area of this school.

KINROSS COLLEGE

The following defines the local-intake area for students in Years 6 and 7 at this school—

From the intersection of Marmion Avenue and Burns Beach Road, in a generally easterly direction along Burns Beach Road to the proposed extension of the Mitchell Freeway, north along the Mitchell Freeway extension to the locality boundary to the locality boundary between Kinross and Tamala Park, west along this boundary to Marmion Avenue and in a generally southerly direction along Marmion Avenue to Burns Beach Road. The boundary parts of Burns Beach Road (north side), the Mitchell Freeway (west side) and Marmion Avenue (east side) are included within the local-intake area for students in Years 6 and 7 at Kinross College.

The following is an optional area between Kinross College (Years 6 and 7) and Beaumaris Primary School— $\,$

From the Indian Ocean at a point coinciding with the westerly extension of Ocean Parade, east to and along Ocean Parade and Burns Beach Road to Marmion Avenue, in a generally northerly direction along Marmion Avenue to the locality boundary between Burns and Tamala Park and west along this boundary to the Indian Ocean. The boundary parts of Marmion Avenue (west side), Burns Beach Road (both sides) and the boundary street of Ocean Parade (both sides) are included within this optional area.

KOORANA PRIMARY SCHOOL

The following defines the local-intake area of this school-

From the junction of Warnbro Sound Avenue and Halliburton Avenue, north along Warnbro Sound Avenue to a point coinciding with the westerly extension of Oslo Place, east from this point between Moreton Crescent, Dress Circle and Ryde Close to the north and Manly Crescent, Darwin Place and Rhyl Close to the south, to Ennis Avenue, south along Ennis Avenue to Royal Palm Drive, west and north west along Royal Palm Drive to Halliburton Avenue and south and south west along Halliburton Avenue to Warnbro Sound Avenue. The boundary parts of Warnbro Sound Avenue (east side) and Ennis Avenue (west side) are included within the local intake area of Koorana Primary School. The boundary parts of Royal Palm Drive (both sides) and Halliburton Avenue (both sides) are excluded from the local-intake area of this school.

The following is an optional area for Koorana and Warnbro Primary Schools-

From the intersection of Safety Bay Road and Warnbro Sound Avenue, south along Warnbro Sound Avenue to a point coinciding with the westerly extension of Oslo Place, east from this point between Moreton Crescent, Dress Circle and Ryde Close to the north and Manly Crescent, Darwin Place and Rhyl Close to the south, to Ennis Avenue, north along Ennis Avenue to Safety Bay Road, and west along Safety Bay Road to Warnbro Sound Avenue. The boundary parts of Warnbro Sound Avenue (east side), Ennis Avenue (west side) and Safety Bay Road (south side) are included within this optional area.

MOUNT HAWTHORN JUNIOR PRIMARY AND PRIMARY SCHOOLS

The following defines the local-intake area of these two schools—

From the intersection of the Mitchell Freeway and Scarborough Beach Road, east along Scarborough Beach Road to the junction with Green Street, east along Green Street to London Street, south along London Street to Scarborough Beach Road and continuing south along Loftus Street to Salisbury Street, west along Salisbury Street to Oxford Street, south along Oxford Street to Wylie Place, west along Wylie Place and its extension through parkland to Brentham Street, and continuing west through parkland to the Mitchell Freeway, north west along the Mitchell Freeway to a point on the southern extension of Brady Street, north along this extension and north along Brady Street to Purslowe Street, west along Purslowe Street to the Mitchell Freeway, north along the Mitchell Freeway to Scarborough Beach Road. The boundary parts of Scarborough Beach Road (south side), Green Street (south side), London Street (west side), Loftus Street (west side), Salisbury Street (both sides), Oxford Street (west side), Wylie Place (both sides), Mitchell Freeway (both north and south sections, east side), Brady Street (both sides) and Purslowe Street (both sides) are included within the local-intake area of this school.

NEERABUP PRIMARY SCHOOL

The following defines the local-intake area of this school—

From the junction of Pinjar Road and Neaves Road, and with Harbour Elbow to the south, west to the locality boundary between Banksia Grove and Carramar (as shown in the Perth, 2002, StreetSmart street directory), south along the locality boundary between Banksia Grove and Carramar to the intersection with the proposed Joondalup Drive, east from this intersection to Pinjar Road and north east along Pinjar Road to Neaves Road. The boundary parts of Pinjar Road (both sides) are included within the local-intake area of this school.

RANFORD PRIMARY SCHOOL

The following defines the local-intake area of this school—

From the intersection of Nicholson Road and Ranford Road, south east along Ranford Road to Campbell Road, south west along Campbell Road and its south westerly extension to Nicholson Road, south along Nicholson Road to Accourt Road, north west along Acourt to Fraser Road, south west along Fraser Road to a point where the south east extension of the north west/south east runway of Jandakot airport intersects with Fraser Road, north west along this extension to the runway and north east along the south west extension of Johnston Road, and Johnston Road itself to the junction with Acourt Road, and continuing north along Johnston Road to Leeming Road, west along Leeming Road to the proposed Roe Highway, north east along the south Street, south east along South Street and continuing south east along Ranford Road to the intersection with Nicholson Road.

The boundary parts of Ranford Road (south west side), Campbell Road (north west side), Nicholson Road (west side), Acourt Road (both sides), Fraser Road (west side), Johnston Road (both sides), Leeming Road (both sides) and South Street (south side) are included within the local-intake area of Ranford Primary School.

The following is an optional area for Ranford and Forrestdale Primary Schools-

From the intersection of Nicholson Road and Warton Road, north along Nicholson Road to Acourt Road, north west along Acourt Road to Fraser Road, south west along Fraser Road to Jandakot Road, south east along Jandakot Road to Warton Road and north east along Warton Road to Nicholson Road.

The boundary parts of Fraser Road (east side) and Jandakot Road (north side) are included within this optional area, while the boundary parts of Nicholson Road (both sides), Acourt Road (both sides) and Warton Road (both sides) are excluded from this optional area.

ROCKINGHAM LAKES PRIMARY SCHOOL

The following defines the local-intake area of this school-

From the junction of Warnbro Sound Avenue and Halliburton Avenue, east and north east along Halliburton Avenue to Royal Palm Drive, south east and east along Royal Palm Drive to Ennis Avenue, generally south along Ennis Avenue to Port Kennedy Drive, south west along Port Kennedy Drive to Warnbro Sound Avenue, and north along Warnbro Sound Avenue to Halliburton Drive. The boundary parts of Halliburton Avenue (both sides), Royal Palm Drive (both sides), Ennis Avenue (west side), Port Kennedy Drive (north side) and Warnbro Sound Avenue (east side) are included within the local-intake area for this school.

VASSE PRIMARY SCHOOL

The following defines a partial boundary between this school, and Geographe and West Busselton Primary Schools—

From the coastline of Geographe Bay, south along Holgate Road and its extension to Lot 219 on the Busselton Bypass, east along the Busselton Bypass to Queen Elizabeth Avenue and south along Queen Elizabeth Avenue to the waste water treatment works. The boundary parts of the Busselton Bypass (south side) and Queen Elizabeth Avenue (west side), and Lot 219 on the Busselton Bypass, are included within the local-intake area of Vasse Primary School. The boundary street of Holgate Road (both sides), is excluded from the local-intake area of this school.

WAIKIKI PRIMARY SCHOOL

The following defines the local-intake area of this school—

From the junction of Read Street and Gnangara Drive, north east along Gnangara Drive to Willmott Drive, south east along Willmott Drive to Ennis Avenue, south along Ennis Avenue to Safety Bay Road, west along Safety Bay Road to Read Street and north along Read Street to Gnangara Drive. The boundary parts of Gnangara Drive (south side), Willmott Drive (south side), Ennis Avenue (west side) Safety Bay Road (north side) and Read Street (east side) are included within the local-intake area of this school.

WARNBRO PRIMARY SCHOOL

The following defines the local-intake area of this school-

From the Indian Ocean at the locality boundary between Port Kennedy and Warnbro, due east along this boundary with Cardiff Place and Galway Gardens (both on the north) and Dieppe Lane and Nazaire Lane (both on the south), to and across Fendam Street and continuing east along the locality boundary with Teraglin Way (on the north) and Montpellier Mews (on the south) to Currie Street, south along Currie Street to Grand Ocean Boulevard, east along Grand Ocean Boulevard to Warnbro Sound Avenue, north along Warnbro Sound Avenue to Safety Bay Road, west along Safety Bay Road to Hokin Street, south west and west along Hokin Street and its westerly extension to the Indian Ocean. The boundary parts of Warnbro Sound Avenue (west side) and Safety Bay Road (south side) are included within the local-intake area for Warnbro Primary School. The boundary parts of Currie Street (both sides), Grand Ocean Boulevard (both sides) and Hokin Street (both sides) are excluded from the local-intake area of this school.

The following is an optional area for Koorana and Warnbro Primary Schools-

From the intersection of Safety Bay Road and Warnbro Sound Avenue, south along Warnbro Sound Avenue to a point coinciding with the westerly extension of Oslo Place, east from this point between Moreton Crescent, Dress Circle and Ryde Close to the north and Manly Crescent, Darwin Place and Rhyl Close to the south, to Ennis Avenue, north along Ennis Avenue to Safety Bay Road, and west along Safety Bay Road to Warnbro Sound Avenue. The boundary parts of Warnbro Sound Avenue (east side), Ennis Avenue (west side) and Safety Bay Road (south side) are included within this optional area.

WEMBLEY PRIMARY SCHOOL

The following defines the local-intake area of this school—

From the intersection of Cambridge Street and Selby Street, east along Cambridge Street to Gregory Street, north along Gregory Street to Scaddan Street, west along Scaddan Street to Daglish Street, north along Daglish Street to Collier Street, west along Collier Street to Herdsman Parade, south west along Herdsman Parade to Telopea Lane, north west along Telopea Lane to the shoreline of Herdsman Lake, west along the shoreline of Herdsman Lake to the northern extension of Heron Place, south along this extension and Heron Place to Flynn Street, east along Flynn Street to Selby Street and south along Selby Street to Cambridge Street. The boundary parts of Cambridge Street (north side), Gregory Street (both sides), Scaddan Street (both sides), Daglish Street (both sides), Collier Street (both sides), Herdsman Parade (both sides), Telopea Lane (both sides), Flynn Street (north side) and Selby Street (east side) are included within the local-intake area of this school. The boundary street of Heron Place (both sides) is excluded from the local-intake area of this school.

WEST BUSSELTON PRIMARY SCHOOL

The following defines the local-intake area of this school-

From the coastline of Geographe Bay, south along Holgate Road and its extension to Lot 219 on the Busselton Bypass, east along the Busselton Bypass to Fairway Drive, north along Fairway Drive to Bussell Highway, east along Bussell Highway to the drainage channel next to junction of Bussell Highway and Queen Elizabeth Avenue, north along the drainage channel to Geographe Bay, and west along the coastline of Geographe Bay to the northern extension of Holgate Road. The boundary parts of Holgate Road (both sides), the Busselton Bypass (north side), Fairway Drive (west side), Bussell Highway (north side) and drainage channel (west side) are included within the local-intake area of this school. Lot 219 on the Busselton Bypass is excluded from the local-intake area of this school.

SCHOOL EDUCATION ACT 1999

DECLARATION OF LOCAL-INTAKE AREAS FOR SCHOOLS WITH SECONDARY STUDENTS

(Pursuant to Sections 60, 78, 79 and 80)

The Hon. Minister for Education has declared that the local-intake areas for the secondary schools listed hereunder shall be as stated in this notice. Children of compulsory school age who reside within the local-intake areas of the following secondary schools shall be entitled to attend the schools to which such local-intake areas apply if there is an appropriate educational program for them at that school. The local-intake area of a secondary school may be defined in this notice by listing the names of the contributory primary schools, the local-intake areas and the traditional catchment areas of which, when amalgamated, constitute the local-intake area of that secondary school. Children who reside outside these local-intake areas may apply to attend the schools to which such local-intake areas apply.

CLARKSON COMMUNITY HIGH SCHOOL

The local-intake area for this school contains the local-intake areas of the following primary schools: Clarkson, Kinross, Merriwa, Mindarie, Quinns Beach and Quinns Rocks.

The following defines the local-intake area of Clarkson Community High School-

From the coastline, east along Burns Beach Road to the proposed extension of the Mitchell Freeway, north along the proposed Mitchell Freeway to the boundary between the localities of Alkimos and Eglinton, west along this locality boundary to the coastline, south along the coastline to Burns Beach Road. The boundary part of Burns Beach Road (north side only) is included within the area for Clarkson Community High School.

The following defines an optional area between Clarkson Community High School and Wanneroo Senior High School—

From 476 Old Yanchep Road (as shown on Map 8 in the 1998 Streetsmart street directory), in a south westerly direction towards the intersection of the locality boundaries of Alkimos, Carabooda and Eglinton, south east along the locality boundary between Alkimos and Carabooda to the proposed Mitchell Freeway, south east along the proposed Mitchell Freeway to the locality boundary between Clarkson and Tamala Park, east north east from this point to the intersection of Wanneroo Road and Flynn Drive and north, north east and east along Flynn Drive to Pinjar Road. The boundary parts of Flynn Drive (north side) are included within this optional area.

HALLS HEAD COMMUNITY COLLEGE

The following primary schools are contained within the local-intake area of Halls Head Community College: Falcon, Glencoe, Halls Head and Ocean Road.

The following defines the local-intake area for Halls Head Community College—

From a point on the coast of the Indian Ocean on the western extension of Tims Thicket Road, north along the coastline to and across the Dawesville Channel, continuing north east along the ocean shoreline to the Mandurah Estuary, south along the Mandurah Estuary to the Peel Inlet, generally south and south west along the western shoreline of the Peel Inlet to and across the Dawesville Channel, and continuing south along the western shoreline of the Harvey Estuary to a point on the eastern extension of Tims Thicket Road.

HAMPTON SENIOR HIGH SCHOOL

The local-intake area for this school is defined by the local-intake areas of the following primary schools— $\!\!\!$

Coolamon, Eden Hill, Ellenbrook, Hampton Park, Morley, Noranda and Weld Square; the traditional catchment areas of Anzac Terrace and Embleton Primary Schools, and the following exceptions.

The following defines a partial boundary between Hampton Senior High School and Lockridge Senior High School—

From the junction of Benara Road and Beechboro Road, south along Beechboro Road to Devonshire Street, east between Eugene Court and Redgum Way to the north, and Seacom Court and Elettra Close to the south, to Cassia Way, south along Cassia Way to Challenger Avenue, east and north along Challenger Avenue to Bottlebrush Drive and south along Bottlebrush Drive to Morley Drive East. The boundary parts of Beechboro Road (east side), Eugene Court (both sides), Redgum Way (both sides) and Bottlebrush Drive (east side) are included within the area for Lockridge Senior High School. The boundary parts of Beechboro Road (west side), Seacom Court (both sides), Elettra Close (both sides), Cassia Way (both sides), Challenger Avenue (both sides) and Bottlebrush Drive (west side) are included within the area for Hampton Senior High School.

Children from Eden Hill Primary School living in Walter Road (south side) and south thereof and in May Road and Iolanthe Street north of Walter Road (west side in each case) and west thereof are entitled to attend Hampton Senior High School. Children from Eden Hill Primary School living in Walter Road (north side), east of Iolanthe Street, and north thereof and in May Road and Iolanthe Street north of Walter Road (east side in each case) and east thereof are entitled to attend Lockridge Senior High School.

Children from Embleton Primary School living in Collier Road (both sides) and east and north thereof are entitled to attend Hampton Senior High School. Children from Embleton Primary School living in the area west and south of Collier Road are entitled to attend John Forrest Senior High School.

Children from Morley Primary School living in Old Collier Road (both sides) and that part of Collier Road (both sides) with a south easterly orientation, and east thereof south of Walter Road, are entitled to attend Hampton Senior High School. Children from Morley Primary School living in the area west of Old Collier Road and that part of Collier Road with a south easterly orientation, south of Walter Road, are entitled to attend John Forrest Senior High School. Children from Morley Primary School living in Walter Road (both sides) and north and west thereof are entitled to attend Morley Senior High School.

Children from Noranda Primary School living in Crimea Street (east side) and east thereof are entitled to attend Hampton Senior High School. Children from Noranda Primary School living in Crimea Street (west side) and west thereof are entitled to attend Morley Senior High School.

The following defines an optional area between Hampton Senior High School and Lockridge Senior High School— $\,$

From the confluence of the Swan River and Ellen Brook, in a general northerly direction along Ellen Brook to the locality boundary of Belhus and Ellenbrook, in a general north westerly direction along this boundary to its westernmost point, in a north westerly direction from this point to the proposed Perth to Darwin Highway, south along the Perth to Darwin Highway to a point nearest the intersection of Lord Street and Youle-Dean Road, east from this point to the intersection of Lord Street and Youle-Dean Road, and continuing east along Youle-Dean Road, and north east along the unmade portion of Youle-Dean Road to the intersection with Woollcott Avenue, south east along Woollcott Avenue to West Swan Road, north along West Swan Road to Douglas Road, east and south east along Douglas Road to the Swan River and north along the Swan River to the confluence with Ellen Brook.

The boundary parts of Douglas Road (both sides) are included within the optional area. The boundary parts of Youle-Dean Road (both sides), Woollcott Avenue (both sides) and West Swan Road (both sides) are excluded from the optional area.

LOCKRIDGE SENIOR HIGH SCHOOL

The local-intake area for this school is defined by the local-intake areas of the following primary schools — $\,$

Beechboro, Coolamon, East Beechboro, Eden Hill, Ellenbrook, Lockridge and West Beechboro; the traditional catchment area of Caversham Primary School and the following exceptions.

The following defines a partial boundary between Hampton Senior High School and Lockridge Senior High School—

From the junction of Benara Road and Beechboro Road, south along Beechboro Road to Devonshire Street, east between Eugene Court and Redgum Way to the north, and Seacom Court and Elettra Close to the south, to Cassia Way, south along Cassia Way to Challenger Avenue, east and north along Challenger Avenue to Bottlebrush Drive and south along Bottlebrush Drive to Morley Drive East. The boundary parts of Beechboro Road (east side), Eugene Court (both sides), Redgum Way (both sides) and Bottlebrush Drive (east side) are included within the area for Lockridge Senior High School. The boundary parts of Beechboro Road (west side), Seacom Court (both sides), Elettra Close (both sides), Cassia Way (both sides), Challenger Avenue (both sides) and Bottlebrush Drive (west side) are included within the area for Hampton Senior High School.

Children from Eden Hill Primary School living in Walter Road (north side) east of Iolanthe Street and north thereof and in May Road and Iolanthe Street north of Walter Road (east side in each case) and east thereof are entitled to attend Lockridge Senior High School. Children from Eden Hill Primary School living in Walter Road (south side) and south thereof and in May Road and Iolanthe Street north of Walter Road (west side in each case) and west thereof are entitled to attend Hampton Senior High School.

The following defines an optional area between Hampton Senior High School and Lockridge Senior High School—

From the confluence of the Swan River and Ellen Brook, in a general northerly direction along Ellen Brook to the locality boundary of Belhus and Ellenbrook, in a general north westerly direction along this boundary to its westernmost point, in a north westerly direction from this point to the proposed Perth to Darwin Highway, south along the Perth to Darwin Highway to a point nearest the intersection of Lord Street and Youle-Dean Road, east from this point to the intersection of Lord Street and Youle-Dean Road, and continuing east along Youle-Dean Road, and north east along the unmade portion of Youle-Dean Road to the intersection with Woollcott Avenue, south east along Woollcott Avenue to West Swan Road, north along West Swan Road to Douglas Road, east and south east along Douglas Road to the Swan River and north along the Swan River to the confluence with Ellen Brook.

The boundary parts of Douglas Road (both sides) are included within the optional area. The boundary parts of Youle-Dean Road (both sides), Woollcott Avenue (both sides) and West Swan Road (both sides) are excluded from the optional area.

NEWTON MOORE SENIOR HIGH SCHOOL

The local-intake area for this school is defined by the local-intake areas of the following primary schools— $\!\!\!$

Adam Road, Carey Park, South Bunbury and Withers; and the traditional catchment area of Capel Primary School, and the following—

The following defines a boundary between Bunbury Senior High School and Newton Moore Senior High School—

From the confluence of the Preston River with the Ferguson River, north west and west along the Preston River to the railway bridge, west and north west along the railway line to the intersection of the railway line and Forrest Avenue, west and north west along Forrest Avenue to Wisbey Street, south west along Wisbey Street to Yorla Road, north west along Yorla Road to Clarke Street East, west along Clarke Street East to Clarke Street, west along Clarke Street to Hoylake Avenue and north west along Hoylake Avenue and its extension to the Indian Ocean.

Children from Carey Park Primary School living in the area north of (but not including) the above boundary are entitled to attend either Bunbury Senior High School or Newton Moore Senior High School. Children from Carey Park Primary School living in Hoylake Avenue, Clarke Street and Clarke Street East (both sides in all cases) and the boundary parts of Yorla Road, Wisbey Street and Forrest Avenue (both sides in all cases), and south of the boundary are entitled to attend Newton Moore Senior High School. Children from South Bunbury Primary School living in the area north of (but not including) the above boundary are entitled to attend Bunbury Senior High School. NORTHAM SENIOR HIGH SCHOOL

From the junction of Leach Highway and Murdoch Drive, east along Leach Highway to the junction with Bull Creek Drive, north from this junction through Bateman Park to the foreshore of Bull Creek, east and north along the eastern foreshore of Bull Creek, and continuing north east and east along the foreshore of the Canning River to the northern extension of Duff Road, south along this extension and Duff Road to High Road, west along High Road to Augusta Street, south along Augusta Street to Acanthus Road, west along Acanthus Road to Darvell Road, south along Darvell Road to Rhonda Avenue, west along Rhonda Avenue to the northern extension of Donald Street, south along this extension and Donald Street to Apsley Road, west along Apsley Road to Eagles Walk, south along the north-south alignment of Eagles Walk and its extension to Flamingo Way, south along Albatross Pass and its extension between Wren Close and Cormorant Cross, and continuing north east between Brolga Promenade and both The Taffrail and The Quarterdeck to the junction of The Quarterdeck and The Escarpment, west from this junction to Karel Avenue, south along Murdoch Drive to Leach Highway.

The boundary parts of Leach Highway (south side), Duff Road (both sides), High Road (north side), Augusta Street (both sides), Acanthus Road (both sides), Darvell Road (both sides), Donald Street (both sides), Eagles Walk (both sides), Flamingo Way (both sides), Wren Close (both sides), Brolga Promenade (both sides), Karel Avenue (west side), Parry Avenue (north side) and Murdoch Drive (east side) are included in the above local-intake area. Albatross Pass (both sides), Cormorant Cross (both sides), The Taffrail (both sides) and The Quarterdeck (both sides) are excluded from this area.

Students resident within the following area have the entitlement of attending either Rossmoyne Senior High School or Leeming Senior High School—

From the junction of Murdoch Drive and Parry Avenue, east along Parry Avenue to the Kwinana Freeway, south along the Kwinana Freeway to the northern arm of the loop forming Scandrett Way, west along the northern arm of Scandrett Way to Broadhurst Crescent, north along Broadhurst Crescent to Marsengo Road, west along Marsengo Road to Murdoch Drive and north along Murdoch Drive to Parry Avenue. The boundary parts of Parry Avenue (south side), Kwinana Freeway (west side), northern arm of Scandrett Way (north side), Broadhurst Crescent (east side), Marsengo Road (north side) and Murdoch (east side) are included within this optional area.

Students resident within the following area have the entitlement of attending either Applecross Senior High School or Rossmoyne Senior High School—

- From the junction of Leach Highway and Riseley Street, north along Riseley Street to Karoonda Road, east along Karoonda Road to Canning Avenue, north east along Canning Avenue and its extension to the Canning River foreshore, south along the Canning River and Bull Creek foreshores to Bateman Park, south through Bateman Park to the junction of Leach Highway and Bull Creek Drive, west along Leach Highway to the junction with Riseley Street.
- The boundary parts of Riseley Street (east side) and Leach Highway (north side) are included within this optional area. The boundary parts of Karoonda Road (both sides) and Canning Avenue (both sides) are excluded from this optional area.

Secondary students who reside south of High Road in the local-intake area of Riverton Primary School, and who were enrolled at Riverton Primary School for the whole of the year whilst in Year 7 at that school, are entitled to attend Rossmoyne Senior High School.

Students resident within the former local-intake area for Kewdale Senior High School are entitled to attend Rossmoyne Senior High School. This area is described in the Belmont City College local-intake area notice.

SOUTH COAST SALMON FISHERY MANAGEMENT PLAN AMENDMENT 2001

FD 1698/98 [457]

Made by the Minister under section 54.

Citation

1. This amendment may be cited as the South Coast Salmon Fishery Management Plan Amendment 2001.

Principal Plan

2. In this amendment the South Coast Salmon Management Plan 1982* is referred to as the principal Plan.

Clause 2 amended

3. Clause 2 of the principal Plan is amended by-

- (a) deleting paragraphs (a), (b) and (c);
- (b) inserting after paragraph (f) the following paragraph—
 - " (fa) "regulations" means the Fish Resources Management Regulations 1995; ";
- (c) deleting the full stop at the end of paragraph (i) and inserting the following— "; "; and
- (d) inserting after paragraph (i) the following paragraph—
 - " (j) "total fee" means the fee as specified in item 3(21) of Part 3 of Schedule 1 of the regulations. ".

Clause 5 deleted and another inserted

4. Clause 5 of the principal Plan is deleted and the following clause inserted-

" Payment by instalments

5. (1) For the purposes of regulation 137(2) of the regulations, the total fee may be paid by instalments as specified in the Schedule if—

- (a) an election to pay by instalments is made by the holder of a licence in accordance with subclause (2); and
- (b) there is no other fee, charge or levy in respect of the licence which has not been paid at the time the election is received at the head office of the Department.

(2) An election for the purposes of subclause (1) must be-

- (a) made in writing;
- (b) received at the head office of the Department prior to the commencement of the licensing period to which the election relates; and
- (c) accompanied by the first instalment plus the surcharge.

(3) For the purposes of regulation 137(3) of the regulations, the surcharge shall be 3.13% of the total fee.

(4) The holder of a licence, or a person acting on that persons behalf, must not fish in the Fishery at any time when any fee or surcharge payable in respect of the licence is outstanding. ".

Schedule inserted

5. The principal Plan is amended by inserting after clause 13 the following Schedule-

"Schedule

Payments by Instalments

- (a) The first instalment is 25% of the total fee and is due for payment on or before 1 January of the year for which the licence is to be granted or renewed.
- (b) The second instalment is 25% of the total fee and is due for payment on or before 1 April immediately following the period specified in paragraph (a).
- (c) The third instalment is the total fee less the instalments provided for in paragraphs (a) and (b) and is due for payment on or before 1 July immediately following the period specified in paragraph (a). ".


