## Community Services (Child Care Services) Exemption Order 2002

Made by the Minister under section 17D of the Act.

#### 1. Citation

This order may be cited as the *Community Services (Child Care Services) Exemption Order 2002*.

## 2. Exemption from section 17A — early childhood services for Aboriginal children

A child care service provided during a school year by the Department of Education is exempted from the application of section 17A of the Act if that service is provided —

- (a) at a school listed in Schedule 1; and
- (b) for Aboriginal children who have reached the age of 3 years but who will not reach the age of 4 years before 30 June of that year.

### 3. Cancellation of order

The Community Services (Child Care Services) Exemption Order 2001 is cancelled.

# Community Services (Out of School Hours Care) Exemption Order 2002

Made by the Minister under section 17D of the Act.

### 1. Citation

This order may be cited as the *Community Services (Out of School Hours Care) Exemption Order 2002.* 

#### 2. Definitions

In this order —

- "home education", in relation to a child, means instruction provided by a parent who is registered under the *School Education Act 1999* as the child's home educator;
- "out of school hours", in relation to a child, means any time outside the hours during which the child is required to
  - (a) attend school or otherwise participate in an educational programme of a school; or
  - (b) receive home education;

"school" has the same meaning as it has in the School Education Act 1999.

## 3. Exemption from section 17A — out of school hours child care service

- (1) A child care service is exempted from the application of section 17A of the Act if that service is provided at non-residential premises and operated for the sole purpose of providing out of school hours care for children who
  - (a) attend school or receive home education; and
  - (b) reach the age of 5 years during the year that ends on 31 December 2002.
- (2) In subclause (1) —

"non-residential premises" means premises that are not used as a residence.

#### 4. Cancellation of order

The Community Services (Child Care Services) Exemption Order 1996 is cancelled.
