# 1. Citation

These regulations may be cited as the *Spent Convictions (Act Amendment) Regulations (No. 3) 2001.* 

# 2. Schedule 3 to the Act amended

Schedule 3 to the *Spent Convictions Act 1988\** is amended in the Table to clause 1 by deleting item 10 and inserting instead —

10. A person employed in the Community and Juvenile Justice Division or the Prisons Division of the Department of Justice when (in the course of the person's duties) assessing, reporting about or classifying persons charged with or convicted of offences.

#### **DOG ACT 1976**

Town of Kwinana DOGS LOCAL LAW

Under the powers conferred by the  $Dog\ Act\ 1976$  and under all other powers enabling it, the Council of the Town of Kwinana resolved on 23 January 2002 to make the following local law—

The Shire of Moora Dogs Local Law as published in the *Government Gazette* of 29 November 1999, is adopted as a local law of the Town of Kwinana with the modifications which follow—

#### 1. Preliminary

Wherever the Shire of Moora is mentioned in the local law substitute "Town of Kwinana".

#### 2. Clause 1.2—Repeal

Delete Clause 1.2 and substitute—

"1.2 The Town of Kwinana Local Law Relating to Dogs published in the *Government Gazette* of 1 November 1991 as amended by publication in the *Government Gazettes* of 19 March 1993 and 3 March 1995, are repealed."

#### 3. Clause 3.2

Delete paragraph (2) and substitute—

"(2) The limit on the number of dogs which may be kept on any premises is, for the purpose of section 26(4) of the Act, 2 dogs over the age of 3 months and the young of those dogs under that age."

## 4. Clause 5.1—Places where dogs are prohibited absolutely

In Clause 5.1(1)—

- (a) delete paragraph (a) and substitute—"(a) a public building, unless permitted by a sign;";
- (b) renumber paragraphs (b) and (c) to (c) and (d) respectively;
- (c) insert the following paragraph—"(b) a theatre or picture gardens;".
- (d) insert the following paragraph—"(e) Kwinana Golf Course Reserve No 25309;"
- (e) insert the following paragraph—"(f) Kwinana Beach Foreshore Reserve No 24575."

# 5. Clause 5.2—Places which are dog exercise areas

In Clause 5.2(1) delete paragraphs (a), (b) and (c) and substitute—

- "(a) Harry McGuigan Park, Medina—Reserve 24172
- (b) Littlemore Park, Orelia—Reserve 30086
- (c) Lot 268 Skottowe Parkway, Parmelia—Reserve 40922
- (d) 288 De Haer Road, Wandi—Reserve 36759
- (e) Lot 1876 Wellard Road, Sloans Reserve—Reserve 25132
- (f) Lot 335 Wellard Road, Wellard Park, Wellard—Reserve 40218
- (g) Lot E20 Parmelia Avenue, Peace Park, Parmelia—Reserve 33949

In Clause 5.2(2)—

- (a) renumber paragraphs (a) through to (c) to (b) through to (d)
- (b) insert "(a) an area which is defined as a building;"
