#### STAMP ACT 1921

#### PROCLAMATION

WESTERN AUSTRALIA John Sanderson, Governor. By His Excellency Lieutenant General John Murray Sanderson, Companion of the Order of Australia, Governor of the State of Western Australia.

I, the Governor, acting under item 3 of the Second Schedule to the *Stamp Act 1921* and with the advice and consent of the Executive Council, declare as follows:

- 1. This proclamation commences on the day on which it is published in the *Government Gazette*.
- 2. The proclamation made under item 3 of the Second Schedule to the *Stamp Act 1921* and published in the *Government Gazette* of 24 April 1980 is revoked.
- 3. The duty payable under item 3(1)(a) or (b) of the Second Schedule to the *Stamp Act 1921* is 2/12 of a cent for every dollar and part of a dollar of the purchase price referred to in the respective subitem.
- 4. Despite clause 3, the duty payable in respect of the amount of the purchase money of any one animal, or any one carcass, whether sold singly or as part of a lot, must not exceed the sum of 20 cents.

3. General retail shops to which this order applies are exempted from section 12(1)(a) of the Act on 24 April 2002 provided that those shops shall be closed on that day until 8.00am and from and after 9.00pm.

# **Application**

  - (a) applies to general retail shops in the metropolitan area other than general retail shops in the Perth area as defined in the *Retail Trading Hours (Tourism Precincts) Order 1996*;
  - (b) applies to general retail shops in the Fremantle area as defined in the Retail Trading Hours (Tourism Precincts) Order 1996;
  - (c) applies to general retail shops within the municipal boundaries of the Local Government Authorities specified in the Schedule;
  - (d) does not affect the operation of-
    - (i) any order made under section 12(1a) of the Act; or
    - (ii) the Retail Trading Hours Exemption Order (No. 12) 1994.
