LOCAL GOVERNMENT ACT 1995

Shire of Kalamunda

AMENDMENT TO LOCAL LAWS RELATING TO DOGS

In pursuance of the powers conferred upon it by the *Local Government Act 1995* and all other powers enabling it, the Council of the Shire of Kalamunda hereby records having resolved on 18th February 2002, amend the following Local Law.

CLAUSE 1 PRELIMINARY

1.1 Amendment of Local Laws

The Shire of Kalamunda Local Law Relating To Dogs published in the *Government Gazette* on 19th September 2001 are hereby amended.

1.2 Title

This Local Law may be cited as the "Shire of Kalamunda, Local Laws Relating to Dogs", and shall come into operation on the fourteenth day after the day that it is published in the *Government Gazette*.

1.3 Application of Local Law

These Local Laws shall apply to the whole of the Local Government Municipality of the Shire of Kalamunda together with any place to which the Governor has given approval for the Local Laws or any part of them to apply, as provided in Section 3.6 of the Act

PART 5-DOGS IN PUBLIC PLACES

5.1 Places where dogs are prohibited absolutely

- 1. Dogs are prohibited from entering or being in any of the following places- add the following— $\,$
 - (e) (ii) Public reserve known as Scott Reserve being Reserve No. 34946 in Wycombe Road, High Wycombe.
 - (iii) Hartfield Park, Reserve No. 17098, Dogs to be excluded from all turf grassed areas excluding the area known as the Botanical Gardens which is bounded by Morrison Road to the west, Hartfield Park Golf Course to the south, Forrestfield Tennis Club and Hartfield Road to the north and the Darling Range Horse and Pony Club to the east.
 - (iv) Kostera Oval, Reserve No. 2935 and portion of the Reserve no 37639 held under licence by the Shire of Kalamunda.
 - Dogs to be excluded from the turf grassed area which forms the playing area of 2.2 hectares contained within a steel post and rail, chain mesh fence. That post and rail fence is an internal fence of the reserve.
 - (v) Pioneer Park, Reserve No. 41156.
 - Dogs to be excluded from the rectangular turf grassed area of 7 hectares which is on the northern aspect of the reserve.
 - (vi) Maida Vale Reserve, Reserve No. 14088.
 - Dogs to be excluded from turf grassed areas which form two rectangular playing fields of 11 hectares in size.
 - (f) An application for temporary dispensation to allow dogs on the aforementioned reserves for a special event may be made for consideration and approval on a case by case basis.

5.2 Places which are dog exercise areas

- The following dog exercise areas are rescinded—
 - (k) "Pioneer Park", Forrestfield—Reserve 41156, the designated area is the unfenced area in the South Eastern corner bordering Hicks Street and Dawson Avenue. Commencement point is the corner of Dawson Avenue

and Hicks Street then proceed in a south west direction parallel to Hicks Street for a distance of 360 metres, then proceed in a north west direction 150 metres, then in a north east direction of 370 metres to Dawson Avenue then in a south east direction for 120 metres to the point of commencement.

- (u) Reserve 33977 and 36287 Swan Road, High Wycombe.
- The following dog exercise areas are added-
 - (k) "Progress Park" Reserve 31571 bounded by Cyril Road and Bandalong Way, High Wycombe
 - (u) "MacKenzie Park" Reserve No. 29104 bounded by Netherwood Road and Albermarle Way, High Wycombe
 - (v) Reserve 42866, adjoining and running parallel to Tonkin Highway west of Hale Road intersection.

LOCAL GOVERNMENT ACT 1995

Shire of Derby-West Kimberley EXTRACTIVE INDUSTRIES (AMENDMENT) LOCAL LAW

Under the power conferred by the *Local Government Act 1995* and by other powers, the Council of the Shire of Derby-West Kimberley resolved on the 27th March 2002 to amend the Shire of Derby-West Kimberley Extractive Industries Local Law published in the Special Edition No 178 of the *Government Gazette* on 28 August

2001, as set out below.

Subclause (3) of clause 2.3 is deleted and the following is substituted—

- "(3) Where in relation to a proposed excavation—
 - (a) the surface area is not to exceed 2000m2; and
 - (b) the extracted material is not to exceed 2000m³;

the local government may exempt a person making application for a licence under subclause (1) from supplying any of the data specified in paragraphs (b), (d), (e) and (i) of subclause (1)".

Local Government (Miscellaneous Provisions) Act 1960

Building Amendment Regulations 2002

Made under section 433A of the Act and section 9.60 of the *Local Government Act 1995* by the Lieutenant-Governor and deputy of the Governor in Executive Council.

1. Citation

These regulations may be cited as the *Building Amendment Regulations 2002*.

2. The regulations amended

The amendments in these regulations are to the *Building Regulations 1989**.

3. Regulation 38B amended

Regulation 38B(3) is repealed and the following subregulation is inserted instead —

"

(3) Despite subregulation (2), an enclosure is not suitable for the purposes of subregulation (1) if a building other than a Class 10a building under the Building Code is included within the area enclosed unless all external doors and windows in that building satisfy the requirements of Australian Standard AS 1926.1, but a Class 10a building may be included within the area enclosed even though any external door or window in it does not satisfy those requirements.

"

5. Transitional

(1) In this regulation —

"pre-July 1992 pool" means a swimming pool that —

- (a) was installed before 1 July 1992; or
- (b) was installed on or after 1 July 1992 in accordance with plans, drawings and specifications that were submitted to the local government for approval before that day;

"transitional period" means the period beginning on the day on which these regulations come into operation and —

- (a) unless paragraph (b) applies, ending on 17 December 2006; or
- (b) if the swimming pool is on premises sold within the period referred to in paragraph (a), ending on the day 3 months after the settlement day for that sale.
- (2) During the transitional period, despite regulation 38B(3) of the *Building Regulations 1989* a building may be included within the area enclosed for a pre-July 1992 pool even though
 - (a) the building is not a Class 10a building under the Building Code; and
 - (b) any external door or window in the building does not satisfy the requirements of Australian Standard AS 1926.1.

Public Sector Management Act 1994

Public Sector Management (General) Amendment Regulations 2002

Made by the Governor in Executive Council.

1. Citation

These regulations may be cited as the *Public Sector Management (General) Amendment Regulations 2002*.

2. The regulations amended

The amendments in these regulations are to the *Public Sector Management (General) Regulations 1994**.

[* Reprinted as at 18 December 1997. For amendments to 18 December 2001 see 2000 Index to Legislation of Western Australia, Table 4, p. 286.]

3. Regulation 8A amended

- (1) Regulation 8A(1) is amended in the definition of "non-SAT CEO" by deleting "section 6(1) office" and inserting instead
 - " SAT office ".
- (2) Regulation 8A(3) is amended by deleting "The remuneration" and inserting instead
 - "Subject to subregulations (8) and (9), the remuneration "...
- (3) After regulation 8A(6) the following subregulations are inserted —

"

- (7) Subregulations (8) and (9) apply to a person who was employed in a SAT office as a chief executive officer under a contract of employment but before the contract of employment expired, was transferred under section 50(1)(a)(ii) of the Act to the performance of other functions in the Senior Executive Service.
- (8) If a person is a person to whom this subregulation applies, for the purpose of section 57(1)(b) of the Act, the remuneration to be accorded the person under a

contract of employment entered into between the person and an employing authority must not exceed the remuneration determined by the Tribunal to be paid to a SAT office-holder at the salary point equivalent to the salary point at which the person was remunerated immediately before he or she ceased to hold the SAT office.

(9) If the remuneration to be paid to the SAT office-holder referred to in subregulation (8) consists of more than one component, then each component of the remuneration to be accorded a person to whom this subregulation applies must not exceed the corresponding component of the remuneration to be paid to the holder of the SAT office.
