Repeal

3. (1) The Health Local Laws adopted by the Shire of Wyalkatchem and published in the *Government Gazette* on 17 June 1921 and amended from time to time, are repealed; and
 (2) The Health Local Laws adopted by the Shire of Wyalkatchem on 21 July 1952 and published in the *Government Gazette* on 17 October 1952 and amended from time to time, are repealed, and
 (3) The Health Local Laws adopted by the Shire of Wyalkatchem on 15 October 1956 and published in the *Government Gazette* on 13 February 1957 and amended from time to time, are repealed, and
 (4) The Health Local Laws adopted by the Shire of Wyalkatchem on 17 April 1969 and published in the *Government Gazette* on 11 June 1969 and amended from time to time, are repealed.

Prior to the issue of planning and building approval, the proponent will be required to demonstrate to Council's satisfaction that the following matters have been addressed— <ol style="list-style-type: none"> (i) All effluent disposal systems shall be located 100m from the tope of the riverbank of Ellensbrook and outside the 1:100 year flood level. (ii) Potable water supplies to be provided. (iii) Fire protection requirements to the satisfaction of Council. (iv) A detailed landscaping plan to be submitted utilising indigenous species to satisfactorily screen the development from Caves Road and to be to the ratio of two trees to that cleared for all aspects of the development. (v) A detailed building management plan to be developed to minimise the risk of erosion, compaction and vegetation removal. (vi) Non chemical termite protection to buildings to be used on the flood plain. 4. Council may approval applications that are at variance with the development plan providing such variations are not contrary to the principles outlined on the plan and in the opinion of Council do not lead a significant variation in the accommodation capacity of the site. In respect of such applications Council may resolve to advertise any such variation for public comment in accordance with the “SA” procedures of the Scheme. <p>Subdivision shall be generally in accordance with the development plan.</p> <ol style="list-style-type: none"> 5. Effluent disposal systems to avoid nutrient enrichment of Ellensbrook, to the satisfaction of Council, the Health Department of Western Australia in consultation with the Department of Conservation and Land Management. 6. Single dwellings shall not be permitted on any proposed lots upon subdivision unless it is for a manager's residence and planning approval and a building license has been sought for the gallery and chalet developments on separate titles. 7. Notwithstanding any other provisions in this Schedule relating to the land, the following provisions shall also apply to Proposed Lot 4 (being Lot 12 of Sussex Location 943 Caves Road and Ellen Brook Road)—

Objective

Subdivision and development of the site is to maintain and enhance the conservation and landscape values of the Leeuwin-Naturaliste Ridge Statement of Planning Policy's Ridge Landscape Amenity Area.

7.1 Subdivision will be generally in accordance with the subdivision guide plan (Plan No. 10628s02) forming part of Amendment No. 114.

Vegetation Protection

7.2 No vegetation shall be cleared within any allotment except for the purposes of—

- compliance with requirements of the Bush Fire Act 1954 (as amended);
- compliance with an approved Fire Management Plan;
- constructing vehicular access way(s), the location of which is to be approved by Council;
- clearing within an approved building envelope;
- compliance with the approved Remnant Vegetation and Rehabilitation Plan.

Building Envelopes

7.3 No Development, including earthworks shall occur outside of the approved building envelope, illustrated on the subdivision guide plan (Plan No. 10628s02), or an alternative location, which has been approved by Council.

7.4 No vehicle shall be driven outside the building envelope in a manner as to cause damage to vegetation and soil erosion.

7.5 No fences shall be erected on the proposed lots except as a boundary to the building envelope.

Land Management

7.6 At the time of subdivision the subdivider shall prepare and implement a Fire Management Plan.

7.7 At the time of subdivision the subdivider shall prepare and implement a Remnant Vegetation Protection and Rehabilitation Plan.

7.8 At the time of subdivision Council shall recommend to the Western Australian Planning Commission that prospective purchasers be made aware of their responsibility for the ongoing Fire Management Plan and the Remnant Vegetation Protection and Rehabilitation Plan.

7.9 No grazing of animals on the proposed lots shall occur other than is necessary for fuel reduction purposes for fire fighting prevention purposes in a manner approved by Council.

Future Subdivision and Development

7.10 Development shall be limited to a single dwelling house and ancillary outbuildings on each lot.

7.11 No tourist development is permitted on the site.

7.12 At the time of subdivision Council shall recommend to the Western Australian Planning Commission that a Section 70A notification under the Transfer of Land Act be imposed to advise prospective purchasers that no further subdivision of the lots will be supported and that development is restricted to one dwelling and ancillary outbuildings in accordance with the provisions of the Scheme and the objectives and policies of the Leeuwin Naturaliste Ridge Statement of Planning Policy.

7.13 No building or structure shall be erected on the proposed lots without the approval of Council, including colours and materials


