### LOCAL GOVERNMENT ACT 1995 TOWN OF KWINANA

BEE KEEPING LOCAL LAW

Under the powers conferred by the *Local Government Act 1995* and under all other powers enabling it, the Council of the Town of Kwinana resolved on 24 April 2002 to make the following local law—

The City of Gosnells Bee Keeping Local Law 1999 as published in the *Government Gazette* of 24 September 1999, is adopted as a local law of the Town of Kwinana with the modifications which follow—

#### 1. Preliminary

Wherever the City of Gosnells is mentioned in the local law substitute "Town of Kwinana".

#### 2. Clause 2-Repeal

Delete Clause 2 and substitute—

"The Town of Kwinana Local Law Relating to the Keeping of Bees published in the *Government Gazette* of 25 January 1985 is repealed."

#### 3. Clause 3—Interpretation

In Clause 3—

- (a) In the appropriate alphabetical positions insert—
  - " "bees" means an insect belonging to any of the various hymenopterous insects of the super family *Apoidea* and commonly known as a bee;"
  - ""good and sufficient water supply" access to an adequate supply of water to prevent bees seeking an alternative supply;"
  - " "hive" means a moveable or fixed structure, container or object in which a colony of bees is kept;"
  - " "nuisance" causing or inflicting injury or harm on persons or animals;"
- (b) Delete paragraphs (a) and (b)

#### 4. Clause 5—Application for a permit

- In Clause 5 insert the following paragraph—
  - "(e) where the applicant is not the owner of the property, provide written consent of the owner of the property."

#### 5. Clause 7–Conditions of approval

- In Clause 7(1)-
  - (a) delete paragraph (b) and substitute-
    - "(b) each bee hive shall be-
      - (i) kept at a distance specified by the local government from any thoroughfare, public place or boundary of the land; or
      - (ii) located near a screen or other barrier so as to prevent the bees flying low over a thoroughfare, public place or adjoining land;"
  - (b) delete paragraph (c)
  - (c) renumber paragraphs (d) and (e) to (c) and (d) respectively
  - (d) insert paragraph as follows-
    - "(e) the local government shall specify how many bee hives are to be allowed to be kept on land in excess of 20,000 square metres in area."

#### 6. Clause 11—Nuisance

Delete Clause 11and substitute—

- "(1) A person shall not keep or allow to be kept, bees, or bee hives, or both, on land so as to create a nuisance.
- (2) A person shall not allow feral bees to occupy land so as to create a nuisance."

## **3. Partial exemptions**

- (1) The Commission must receive from a public authority a written request for the authority to be granted a partial exemption before the Commission grants the authority a partial exemption.
- (2) When deciding whether to grant a partial exemption, the extent of a prospective partial exemption, or the conditions on which or the period of time for which a partial exemption will be granted, the Commission shall have regard to —
  - (a) the public authority's level of competence in relation to arranging and coordinating the supply of goods and services necessary for the operation of the authority; and
  - (b) the public authority's risk management practices.
- (3) A public authority that is granted a partial exemption shall manage the supply of goods and services in accordance with the terms and conditions of the exemption.

**<sup>&</sup>quot;partial exemption"** means a partial exemption from section 19(1) of the Act.

## 4. Review of partial exemptions

- Subject to subregulation (2), the Commission shall review a partial exemption granted to a public authority as provided in the terms and conditions of the exemption.
- (2) The Commission may, at any time, review a partial exemption granted to a public authority if the Commission is of the opinion that a review is required.
- (3) When reviewing a partial exemption granted to a public authority, the Commission shall have regard to the level of the authority's compliance with
  - (a) supply policies;
  - (b) directions supplementing supply policies; and
  - (c) the terms and conditions of the exemption.

ADVERTISEMENT OF APPROVED TOWN PLANNING SCHEME AMENDMENT

SHIRE OF AUGUSTA-MARGARET RIVER

TOWN PLANNING SCHEME No. 11-AMENDMENT No. 117

It is hereby notified for public information, in accordance with Section 7 of the Town Planning and Development Act 1928 (as amended) that the Hon Minister for Planning and Infrastructure approved the Shire of Augusta-Margaret River Town Planning Scheme Amendment on 17 April 2002 for the purpose of—

- 1. Deleting from Schedule 3, in relation to Location 2707 Sebbes Road, Forest Grove, Points 1-17 inclusive and replace them with the following—
  - 1. The objective of this Special Use Zone is to provide for the use of the property for an organic vineyard, mixed forestry and orchard consistent with the requirements of the

Leeuwin-Naturaliste Ridge Statement of Planning Policy No. 7 for the Regional Environmental Corridor. The Regional Environmental Corridor links the Boranup Forest to State Forest east of the property.

- 2. Development of the property shall be generally in accordance with the-
  - Land Use Plan dated 20 September, 2000;
  - Environment Management Plan dated 20 September, 2000; and
  - environmental management commitments contained in the Environmental Management Report, referred to in provision 3; and
  - · conditions of any Council Planning Approval.
- 3. The landowner is to prepare and implement an Environmental Management Report, prior to any development occurring on site, and in consultation with the Department of Conservation and Land Management. The Environmental Management Report is to identify the land management practices and provide for—
  - the monitoring of water flows and quality into and out of Location 2707 to maintain the White Bellied Frog's habitat;
  - timing and implementation requirements for the establishment of indigenous vegetation buffers along watercourses and around the periphery of the proposed dam.
  - weed management program to prevent weeds from spreading down stream.
- 4. Any change to the agricultural use of the land or changes to planting locations shall—
  - not affect remnant and replanted indigenous vegetation;
    - not affect the firebreaks around the property;
    - not result in adverse environmental impacts.
- 5. The landowner will consult with the Department of Conservation and Land Management to manage the property to avoid any adverse impact on the habitat of the White Bellied Frog, Geocrinia alba which is known to exist adjacent to the property down stream on the banks of McLeod Creek.
- 6. The landowner shall agree to monitor aspects of water flow and quality in co-operation with the Department of Conservation and Land Management and to provide all data to CALM to assist in research and management of the Geocrinia alba habitat.
- 7. The fringing vegetation, to be planted around the watercourses, the thickening of parkland vegetation, and establishment of the island wildlife refuges, shall be established and maintained in accordance with the Environmental Management Plan dated 20 September, 2000. This planting must use locally indigenous vegetation.
- 8. A Fire Management Plan shall be prepared by the landowner to the satisfaction of the Department of Conservation and the Shire of Augusta-Margaret River.
- 9. A trafficable firebreak shall be maintained around the inner property boundary within a 10 metre wide clear area and adjacent to a further 10 metre low fuel zone.

The landowner shall—

- establish, in consultation with CALM, hardstand and water standpipe, fed with water from the dam, on the down stream side of the dam accessible to CALM;
- establish at least one other hardstand site adjacent to the dam to the satisfaction of CALM and the local government accessible for bushfire emergencies and fire management;
- maintain a fire trailer or fire tender;
- · comply with all Bush Fire Service requirements and standards; and
- maintain a minimum 30 metre fuel free zone around buildings.
- 10. All development shall be consistent with Council's Visual Management Guidelines.
- 11. No trees to be removed with the exception of those trees which need to be removed for the purposes of fire protection, access and safety or, unless agreed by Council.
