#### FISH RESOURCES MANAGEMENT ACT 1994

##### SOUTH WEST TRAWL FISHERY MANAGEMENT PLAN AMENDMENT 2002

FD 344/02 [478]

Made by the Minister under section 54.

#### Citation

1. This amendment may be cited as the *South West Trawl Fishery Management Plan Amendment 2002*.

#### Management plan amended

2. The amendments in this instrument are to the *South West Trawl Management Plan 1989\**.

#### Arrangement amended

3. The arrangement is amended by—
- (a) deleting item 12 and inserting instead—  
“12. Certain boats not to be used in the Fishery”; and
  - (b) deleting items 13, 14, 15, 16 and 17.

#### Clause 3 amended

4. Clause 3 is amended by—
- (a) inserting in alphabetical order the following—  
“  
“authorised boat” means—
    - (a) a licensed fishing boat, the name, licensed fishing boat number and length of which are specified in a licence; or
    - (b) a boat specified in a written authority under regulation 132 where that boat is to be used in place of a boat described in (a); ”; and
  - (b) deleting the item commencing “approved form”.

#### Clause 5 amended

5. Clause 5 is amended by—
- (a) deleting “and” at the end of paragraph (a);
  - (b) deleting the full stop at the end of paragraph (b) and inserting instead—  
“; and ”; and

- (c) inserting after paragraph (b) the following—
  - “ (c) from an authorised boat. ”.

**Clause 9 amended**

6. Clause 9 is amended by—

- (a) deleting paragraph (b) and inserting instead—
  - “ (b) the name and business address of the holder of the licence; ”;
- (b) deleting paragraph (f).

**Clause 10 amended**

7. Clause 10 is amended by deleting “, other than a person to whom section 32 of the Act applies, ”.

**Clause 10A replaced**

8. Clause 10A is repealed and the following clause inserted instead—

**“ Stowage of otter boards and otter trawl nets**

10A. (1) The master of an authorised boat must not permit that boat to be in any unauthorised area of the Fishery unless—

- (a) all otter boards and warp wires carried on or attached to that boat are kept clear of the water; and
  - (b) the cod end of any otter trawl net is untied, inboard of the gunwale and secured to the boat.
- (2) For the purposes of this clause an “unauthorised area of the Fishery” means—
- (a) a Zone of the Fishery which is not specified on the same licence as the authorised boat;
  - (b) any area of the Fishery in which fishing is prohibited. ”.

**Clause 11 amended**

9. Clause 11 is amended in subclause (1) by—

- (a) deleting “ from a licensed boat”;
- (b) inserting after “person” the following—
  - “ fishing under the authority of a licence ”; and
- (c) deleting paragraph (b) and inserting the following paragraph instead—
  - “ (b) Zone D other than by a maximum of two otter trawl nets having a combined headrope length not exceeding 11 metres. ”.

**Clause 12 replaced**

10. Clause 12 is repealed and the following clause inserted instead—

**“ Certain boats not to be used in the Fishery**

12. A person must not use, or allow or permit another person to use, a boat to fish in the Fishery if that boat is—

- (a) greater than 375 boat units; or
  - (b) greater than 60 hull units,
- as calculated in accordance with the formulae in Schedule 3. ”.

**Clauses 13, 14, 15, 16 and 17 deleted**

11. Clauses 13, 14, 15, 16 and 17 are repealed.

**Clause 19 replaced**

12. Clause 19 is repealed and the following clause inserted instead -

**“ Offences**

19. A person who contravenes a provision of—

- (a) clause 5, 6, 10, 11 or 12; or
- (b) clause 10A,

commits an offence and for the purposes of section 75 of the Act the provisions described in paragraph (a) are major provisions. ”.

**Schedule 2 amended**

13. Schedule 2 is amended in clause 1 by deleting paragraph (f) and inserting the following paragraph instead—

- “ (f) Becher Point to Robert Point

All waters of the Fishery bounded by a line commencing at the high water mark on the western most point of Becher Point and extending due west to a point 800 metres from that high water mark; thence extending in a generally southerly direction parallel to the high water mark 800 metres from the mainland to 32°28' south latitude; thence westerly along the parallel to its intersection with 115°40' east longitude; thence due south along that longitude to a point due west of the northern most point of Robert Point; thence due east to the high water mark at the northern most point of Robert Point; thence in a northerly direction along the high water mark to the commencement point. ”.

**Schedule 3 amended**

14. Schedule 3 is amended by deleting—

“ Formulae for determining fishing capacity.

Formulae for determining the fishing capacity of a boat licensed to operate in the Fishery shall be as follows - “ and inserting instead—

“ Formulae for determining – ”.

**FI402\*****FISH RESOURCES MANAGEMENT ACT 1994****SOUTH WEST TRAWL FISHERY MANAGEMENT PLAN AMENDMENT (No. 2) 2002**

FD 344/02 [479]

Made by the Minister under section 54.

**Citation**

1. This amendment may be cited as the *South West Trawl Fishery Management Plan Amendment (No. 2) 2002*.

**Commencement**

2. This amendment will commence operation on 1 October 2002.

**Management plan amended**

3. The amendments in this instrument are to the *South West Trawl Management Plan 1989\**.

**Arrangement amended**

4. The arrangement is amended by inserting after item 12 the following items—

“ 13. Capacity of the Fishery

14. Licence entitlements to equal capacity

15. Entitlements to be expressed in terms of units

16. Unit value

17. Licence of no effect when the entitlement is less than the minimum

17A. Grounds to refuse to transfer entitlement

17B. Prohibition on operating in excess of entitlement ”.

**Clause 3 amended**

5. Clause 3 is amended by inserting in alphabetical order the following—

“

“unit value” means the value of a unit as specified in clause 16; ”.

**Clause 11 amended**

6. Clause 11 is amended in paragraph (1)(b) by deleting “11 metres” and inserting instead—

“ 21.96 metres ”.

**Clauses 13, 14, 15, 16, 17, 17A and 17B inserted**

7. After clause 11 the following clauses are inserted—

“ **Capacity of the Fishery**

13. (1) The capacity of—

(a) Zone A of the Fishery is 87.84 metres of headrope;

(b) Zone B of the Fishery is 351.36 metres of headrope;

(c) Zone C of the Fishery is 117.12 metres of headrope; and

(d) Zone D of the Fishery is 32.94 metres of headrope.

(2) The capacity of a Zone of the Fishery shall be reduced upon the making of an order under section 76(2) of the Act in respect of that Zone, such reduction being equal to the length of head rope by which the entitlement was exceeded for the purposes of section 76(2) of the Act.

(3) The capacity of a Zone shall be reduced on—

(a) the surrender of a licence that relates to that Zone;



- (b) the cancellation or non renewal of a licence that relates to that Zone;
- (c) the expiry of the 60 day period provided for in section 139 of the Act without an application for renewal of a licence for that Zone having been made, with such reduction being equal to the length of headrope that could have been operated under the authority of that licence.

#### **Licence entitlements to equal capacity**

14. The aggregate of the entitlements conferred by all the licences relating to a Zone of the Fishery shall be equal to the capacity of that Zone as specified in clause 13.

#### **Entitlements to be expressed in terms of units**

15. (1) The entitlement under a licence to use a specified length of headrope on an otter trawl net shall be expressed in terms of units of entitlement.

(2) The entitlement of a licence when renewed for a period ending 30 September 2003 shall, on renewal be—

- (a) 16 units for a licence relating to Zone A;
- (b) 16 units for a licence relating to Zone B;
- (c) 16 units for a licence relating to Zone C;
- (d) 6 units for a licence relating to Zone D.

#### **Unit value**

16. The value of a unit is 1.83 metres of headrope.

#### **Licence of no effect when the entitlement is less than the minimum**

17. The authority conferred by a licence which authorizes fishing in Zone D is of no effect when the entitlement of that licence is less than 6 units of entitlement.

#### **Grounds to refuse to transfer entitlement**

17A. The Executive Director may refuse to transfer part of an entitlement under one licence to another licence on the grounds that -

- (a) the proposed transfer is not for a whole unit or whole number of units; or
- (b) the proposed transfer is for the transfer of units, which if effected, would result in those units applying to a Zone that is a different Zone than that which is specified on the licence from which the units were transferred.

#### **Prohibition on operating in excess of entitlement**

17B. A person fishing under the authority of a licence must not use a greater length of headrope in a Zone than the product of the entitlement of that licence for that Zone and the value of a unit. ”.

#### **Clause 19 amended**

8. Clause 19 of the principal Plan is amended in paragraph (a) by deleting “ or 12” and inserting the following instead—

“ , 12 or 17B ”.
