#### Citation

1. This amendment may be cited as the Joint Authority Southern Demersal Gillnet and Demersal Longline Fishery Management Plan Amendment 2002.

## Management plan amended

    - 4. For the purposes of section 65(1) of the Act the Western Australian Demersal Net and Hook Fishery Management Advisory Committee is the advisory committee to be consulted before this plan is amended or revoked. ".
