#### LOCAL GOVERNMENT ACT 1995

SHIRE OF EAST PILBARA

LOCAL LAW (SIGNS, HOARDINGS AND BILL POSTING)

Under the powers conferred by the Local Government Act 1995 and under all other powers enabling it, the Council of the Shire of East Pilbara resolved on 26 July 2002 to make the following local law.

The Town of Port Hedland Local Law (Signs, Hoardings and Bill Posting) published in the *Government Gazette* of 3 August 2000, is adopted as a local law of the Shire of East Pilbara with the modifications which follow:

#### 1. Preliminary

Wherever the "Town of Port Hedland" is mentioned in the local law substitute "Shire of East Pilbara"

# Mining Amendment Regulations (No. 3) 2002

Made by the Governor in Executive Council.

#### 1. Citation

These regulations may be cited as the *Mining Amendment Regulations (No. 3) 2002*.

#### 2. Commencement

These regulations come into operation on 1 January 2003.

#### 4. Regulation 86 amended

The Table to regulation 86 is amended, in column 3, in the item relating to tantalum by deleting "2½% of the royalty value when sold as concentrate; or 2½% of the value in concentrate form if processed further before sale." and inserting instead —

The rate is —

- (a) in the period beginning on 1 January 2003 and ending on 30 June 2003
  - (i) 3.3% of the royalty value if sold as concentrate;

- (ii) 3.3% of the value in concentrate form if processed further before sale;
- (b) in the period beginning on 1 July 2003 and ending on 30 June 2004
  - (i) 4.1% of the royalty value if sold as concentrate:
  - (ii) 4.1% of the value in concentrate form if processed further before sale;

and

- (c) on or after 1 July 2004 ---
  - (i) 5% of the royalty value if sold as concentrate:
  - (ii) 5% of the value in concentrate form if processed further before sale.

# **Town Planning Amendment Regulations 2002**

Made by the Minister under sections 8 and 9 of the Act.

#### 1. Citation

These regulations may be cited as the *Town Planning Amendment Regulations 2002*.

#### 2. The regulations amended

The amendments in these regulations are to the *Town Planning Regulations 1967\**.

#### 3. Regulation 3 amended

Regulation 3 is amended by inserting in the appropriate alphabetical positions —

"authorised person" means a person or body appointed under regulation 3A as an authorised

person for the purposes of the regulation in which the expression is used;

"Department" means the department of the Public Service principally assisting the Minister in the administration of this Act;

#### 4. Regulation 3A inserted

After regulation 3 the following regulation is inserted —

"

#### 3A. Authorised persons

- (1) Subject to subregulation (3), the Minister may by instrument in writing appoint any person or body to whom this regulation applies to be an authorised person for the purposes of any one or more of these regulations.
- (2) This regulation applies to
  - (a) any officer employed in the office of the Minister;
  - (b) the chief executive officer of the Department;
  - (c) any officer of the Department nominated in writing for the purposes of this section by the chief executive officer of the Department;
  - (d) the Commission and any member of the Commission;
  - (e) the secretary of the Commission; and
  - (f) any committee established under the Western Australian Planning Commission Act 1985.
- (3) The Minister shall not appoint a person or body referred to in subregulation (2)(d), (e) or (f) as an authorised person for the purposes of regulation 13, 14, 19, 20 or 25AA.
- (4) The appointment of a person or body as an authorised person for the purposes of a regulation does not preclude the Minister from exercising or performing a function under that regulation.
- (5) The appointment may be made subject to such conditions, qualifications, limitations or exceptions as the Minister may specify.
- (6) The appointment may be amended or revoked by the Minister by instrument in writing.

"
