Community Services Act 1972

Community Services (Child Care Services) Exemption Order (No. 2) 2002

Made by the Minister under section 17D of the Act.

1. Citation

This order may be cited as the *Community Services (Child Care Services) Exemption Order (No. 2) 2002.*

2. Definition

In this order —

"school" has the same meaning as in the School Education Act 1999.

3. Exemption from section 17A – early child care services

A child care service provided at a school during a school year is exempted from the application of section 17A of the Act to the extent that the service is provided for children who have reached 3 years of age, but will not reach 4 years of age on or before 30 June in that year.

4. Cancellation of order

The Community Services (Child Care Services) Exemption Order 2002 is cancelled.

ONSLOW PRAWN FISHERY MANAGEMENT PLAN AMENDMENT 2002

FD 31/02 [492]

Made by the Minister under section 54.

Citation

1. This instrument may be cited as the Onslow Prawn Fishery Management Plan Amendment 2002.

Commencement

2. This instrument will commence operation on 1 November 2002.

Management plan amended

3. The amendments in this instrument are to the Onslow Prawn Management Plan 1991*.

Arrangement amended

- 4. The arrangement is amended by-
 - (a) inserting the following items immediately after the item numbered 11—
 "11A. Requirements relating to the installation of an ALC
 - 11B. Requirements relating to nominations to be given by an ALC"; and
 - (b) deleting "Schedule (clauses 2, 3, 10, and 12)" and inserting instead—
 - "Schedule 1
 - Schedule 2

Schedule 3

- Schedule 4
- Schedule 5
- Schedule 6".

Clause 2 amended

- 5. Clause 2 is amended—
 - (a) by inserting in the appropriate alphabetical order—
 - " "ALC" means an Automatic Location Communicator as defined in regulation 55A of the regulations;

"approved directions for use" means the directions for use of an ALC given by the Executive Director in a notice in writing to the master of an authorised boat or a licence holder;

"calendar year" means a year commencing on 1 January;

"prawn" means the fish of that common name described by the scientific classification opposite that name in Column 2 of Schedule 7 of the regulations;

"regulations" means the Fish Resources Management Regulations 1995;

"underway" means that a boat is not at anchor, or made fast to the shore or aground.";

(b) by deleting the following items—

" "approved form" means in a form approved by the Director;

"Regulations" means the Fish Resources Management Regulations 1995;"; and

(c) in the item commencing "try net" by deleting "5 metres." and inserting instead— "5 metres; and".

Clause 7 deleted

6. Clause 7 is deleted.

Clause 10 amended

- 7. Clause 10 is amended—
 - (a) in subclause (1) by deleting "permit," and inserting instead— "licence,"; and
 - (b) in subclause (2) by deleting "permit holders," and inserting instead—"licence holders,".

Clauses 11A and 11B inserted

8. After clause 11 the following clauses are inserted-

"Requirements relating to the installation of an ALC

11A. (1) For the purposes of this clause "approved" and "approved person" have the same meaning as provided for in regulation 55A of the regulations.

(2) A person must not use an authorised boat in the Fishery unless an ALC has been installed in that boat in accordance with the approved directions for use and by an approved person.

- (3) A person must not use an authorised boat in the Fishery unless-
 - (a) the ALC installed in that boat has been serviced in accordance with the approved directions for use, by an approved person and at intervals specified by the Executive Director in the approved directions for use;
 - (b) the person has with them a legible copy of the approved directions for use; and
 - (c) the ALC is used in the manner specified in the approved directions for use.

(4) It is a condition of a licence that the authorised boat must not be used in the Fishery unless—

- (a) an ALC is installed in the boat;
- (b) the ALC is serviced in accordance with the approved directions for use, by an approved person and at intervals specified by the Executive Director in the approved directions for use; and
- (c) when the ALC is used it is used in the manner specified in the approved directions for use.

(5) It is a condition of a licence that regulation 55C of the regulations is complied with at all times.

Requirements relating to nominations to be given by an ALC

11B. (1) The master of an authorised boat must not, when intending to fish within the Fishery, use that boat—

- (a) to enter the waters of the Fishery; or
- (b) outside a Port Area (as specified in Schedule 4) within the waters of the Fishery,
- at any time when any part of the Fishery is open to fishing unless-
 - (c) a nomination of intention to enter the Fishery has been given to and received by the Department in respect of the boat; and
 - (d) the nomination referred to in (c) has not been revoked.
- (2) For the purposes of subclause (1) a nomination is revoked—
 - (a) by a revocation of the nomination given by the master of the boat and received by the Department;
 - (b) if the boat leaves the waters of the Fishery;
 - (c) if the boat is used in accordance with the *Pilbara Fish Trawl Interim Managed Fishery Management Plan 1997*** to fish in that part of the waters of the Fishery that coincides with the waters of the Pilbara Fish Trawl Interim Managed Fishery; or
 - (d) at the end of the calendar year in which it is given,

whichever is the earlier.

(3) At any time when fishing may be carried out in any part of the Fishery the master of an authorised boat must not permit or allow the boat to enter or be underway in any closed waters unless—

- (a) a nomination to enter or be underway, as the case may be, has been given to and received by the Department; and
- (b) the nomination in (a) was given and received within the hour before the boat entered or commenced being underway in those waters.
- (4) For the purposes of this clause "closed waters" means-
 - (a) waters that are not within an area of the Fishery in which fishing may be carried out under the relevant licence;
 - (b) waters in which fishing is prohibited by reason of a notice made under clause 10.

(5) For the purposes of this clause any nomination or revocation must be made using an ALC in accordance with the approved directions for use. ".

Clause 18 deleted

9. Clause 18 is deleted.

Clause 19A amended

- 10. Clause 19A is amended—
 - (a) in paragraph (a) by inserting immediately after "11,"— "11A(2), 11B(3),"; and
 - (b) in paragraph (b) by deleting "clause 16," and inserting instead— "clauses 11A(3), 11B(1), or 16,".

All waters of the Indian Ocean bounded by a line commencing at the high water mark on the coastline of North-Western Australia at the intersection of $21^{\circ}47.78$ ' south latitude and $114^{\circ}46.00$ ' east longitude; thence extending north along the meridian to the intersection of 21°43.20' south latitude and 114°46.00' east longitude (southern extremity of Locker Island); thence north west along the geodesic to the intersection of 21°37.89' south latitude and 114°40.92' east longitude (southern extremity of Serrurier Island); thence generally northerly along the high water mark on the western side of Serrurier Island to the intersection of 21°35.53' south latitude and 114°39.82' east longitude (being the northern extremity of Serrurier Island); thence north along the meridian to the intersection of 21°02.58' south latitude and 114°39.82' east longitude; thence north easterly along the geodesic to the intersection of 21°00.00' south latitude and 114°43.00' east longitude; thence north along the meridian to the intersection of 20°53.00' south latitude and 114°43.00' east longitude; thence north by east along the geodesic to the intersection of 20°35.00' south latitude and 114°47.00' east longitude; thence north north east along the geodesic to the intersection of 20°15.00' south latitude and 114°55.00' east longitude; thence north east by north along the geodesic to the intersection of 20°03.00' south latitude and 115°03.00' east longitude; thence north east by east along the geodesic to the intersection of 19°55.00' south latitude and 115°14.00' east longitude; thence north east by north along the geodesic to the intersection of 19°40.00' south latitude and 115°25.00' east longitude; thence east north east along the geodesic to the intersection of 19°30.00' south latitude and 115°50.00' east longitude; thence north east by east along the geodesic to the intersection of 19°17.00' south latitude and 116°05.00' east longitude; thence east by north east along the geodesic to the intersection of 19°11.00' south latitude and 116°28.00' east longitude; thence easterly along the geodesic to the intersection of $19^{\circ}09.45'$ south latitude and $116^{\circ}45.00'$ east longitude; thence south along the meridian to the high water mark at the intersection of $20^{\circ}36.98'$ south latitude and $116^{\circ}45.00'$ east longitude; thence generally in a south westerly direction along the high water mark on the coastline to the commencement point.

Schedule 2

The waters within the Fishery shall be divided into areas as follows—

Area 1

All the waters of the Fishery bounded by a line commencing at the high water mark at the intersection of $21^{\circ}37.96'$ south latitude and $115^{\circ}06.47'$ east longitude (Beadon Point); thence extending north by east along the geodesic to the intersection of $21^{\circ}32.25'$ south latitude and $115^{\circ}07.80'$ east longitude (southern extremity of Direction Island); thence northerly along the high water mark on the eastern shore of Direction Island to the intersection of $21^{\circ}31.98'$ south latitude and $115^{\circ}07.80'$ east longitude (northern extremity of Direction island); thence west by south along the geodesic to the intersection of $21^{\circ}35.53'$ south latitude and $114^{\circ}39.82'$ east longitude (northern extremity of $21^{\circ}37.89'$ south latitude and $114^{\circ}40.92'$ east longitude (southern extremity of Serrurier Island); thence south east along the geodesic to the intersection of $21^{\circ}37.89'$ south latitude and $114^{\circ}40.92'$ east longitude (southern extremity of Serrurier Island); thence south east along the geodesic to the intersection of $21^{\circ}43.20'$ south latitude and $114^{\circ}46.00'$ east longitude (southern extremity of Locker Island); thence south along the meridian to the high water mark at the intersection of $21^{\circ}47.78'$ south latitude and $114^{\circ}46.00'$ east longitude (southern extremity of locker Island); thence south along the meridian to the high water mark at the intersection of $21^{\circ}47.78'$ south latitude and $114^{\circ}46.00'$ east longitude (southern extremity of locker Island); thence south along the meridian to the high water mark at the intersection of $21^{\circ}47.78'$ south latitude and $114^{\circ}46.00'$ east longitude (southern extremity direction along the high water mark to the commencement point.

Area 2

All the waters of the Fishery west of a line commencing at the high water mark at the intersection of $21^{\circ}16.69'$ south latitude and $115^{\circ}42.38'$ east longitude (Robe Point); thence extending north west along the geodesic to the intersection of $21^{\circ}12.07'$ south latitude and $115^{\circ}38.09'$ east longitude (lighthouse on Great Sandy Island); thence north by north west along the geodesic to the intersection of $20^{\circ}49.80'$ south latitude and $115^{\circ}26.80'$ east longitude (Town Point, Barrow Island); thence generally northerly along the eastern shore of Barrow Island to the intersection of $20^{\circ}40.00'$ south latitude and $115^{\circ}26.08'$ east longitude (Cape Dupuy); thence north along the meridian to the intersection of $19^{\circ}40.00'$ south latitude and $115^{\circ}26.08'$ east longitude, being the end point of the line, but not including the waters of Area 1.

Area 3

All the waters of the Fishery east of a line commencing at the high water mark at the intersection of 21°16.69' south latitude and 115°42.38' east longitude (Robe Point); thence extending north west along the geodesic to the intersection of 21°12.07' south latitude and 115°38.09' east longitude (lighthouse on Great Sandy Island); thence north north west along the geodesic to the intersection of 20°49.80' south latitude and 115°26.80' east longitude (Town Point, Barrow Island); thence generally northerly along the eastern shore of Barrow Island to the intersection of 20°40.00' south latitude and 115°26.08' east longitude (Cape Dupuy); thence north along the meridian to the intersection of 19°40.00' south latitude and 115°26.08' east longitude, being the end point of the line.

Shire of Lake Grace FIREBREAK NOTICE

Notice to all Owners and Occupiers of Land in the Shire of Lake Grace

Pursuant to the powers contained in section 33 of the above Act, you are hereby required on or before the first day of November up to and including the 31^{st} day of March the following year, to have a firebreak clear of all inflammable material in accordance with the following—

- (i) RURAL LAND
 - 1. a) Immediately inside all external boundaries of the property or as is practicable, firebreaks of not less than 3 metres wide and
 - b) Where buildings, haystacks, fuel ramps, fuel tanks and stored fuel drums are situated on land, firebreaks of not less than 2.5 metres wide within 33.5 metres of the perimeter of such buildings, haystacks, fuel ramps, fuel tanks and stored fuel drums in such manner as to completely encircle the buildings, haystacks, fuel ramps, fuel tanks and stored fuel drums and;
 - 2. Where land is in crop and adjoins the railway line reserve a firebreak of not less than 3 metres wide encircling the crop and;
 - 3. a) Immediately surrounding an aerial landing ground situated on the land a firebreak of not less than 6 metres wide and;
 - b) Any aerial landing ground used as the motor start up, refuelling and maintenance area to be completely cleared of all flammable materials for a radius of 18 metres and;
 - 4. Maintain clear of all flammable materials all townsite blocks and;
 - 5. Where bush or land has been bulldozed, chained or prepared in any similar manner for clearing by burning (whether intended to burn the bush or not), provide a firebreak of NOT LESS THAN 13 METRES WIDE inside the external boundaries of the land so prepared. If you become owner or occupier of land after the first day of November, 2001, the requirements of this notice are varied so as to require you to comply with the terms of this notice within fourteen days of the date of your becoming owner or occupier of such land, instead of on or before the first day of November, 2001. The firebreaks required by this notice are to be maintained clear of flammable materials up to and including the 31st day of March, 2002.
 - 6. A readily mobile operational fire fighting unit containing a minimum of 400 litres of water on standby and available for inspection is required during the period 1st November to 31st March.
- (ii) TOWN LAND
 - 1. Where the area of the land is 0.202 hectares (half an acre) or less all inflammable material on the land shall be removed from the whole of the land; and
 - 2. Where the land exceeds 0.202 hectares (half an acre) in area, firebreaks at least 2 metres wide shall be cleared of all inflammable material immediately inside all external boundaries of the land and also immediately surrounding all buildings situated on the land.

GENERAL

If it is considered to be impracticable for any reason to clear firebreaks or to remove inflammable material from land or any other provisions required by this notice you may apply to the Council or its' duly authorised officer not later than 30th October, for permission to provide firebreaks in alternative positions or to take alternative action to abate fire hazards on the land. If permission is granted by Council or its' duly authorised officer, you shall comply with the requirements of this notice.

"Inflammable Material" is defined for the purpose of this Order to include bush (as defined in the Bush Fires Act), timber, boxes, cartons, paper and like inflammable materials, rubbish and also any combustible matter, but does not include green standing trees or growing bushes and plants in gardens, or lawns.

The penalty for failing to comply with this notice is a fine of not more than \$1,000 or a penalty of \$100 may be incurred by issue of an infringement notice, and a person in default is also liable, whether prosecuted or not, to pay the cost of performing the work directed in this notice if it is not carried out by the owner or occupier before the date required by this notice.

If the requirements of this notice are carried out by burning, such burning must be in accordance with the relevant provision of the Bush Fires Act. A permit to burn is required during the restricted burning period from an authorised officer. Permits are not valid on Sundays or public holidays. By Order of the Council,

HARVEST BANS AND MACHINERY MOVEMENT BANS

The following is a set of definitions and guidelines developed to permit the delivery and removal of farm produce when harvest and vehicle movement bans are imposed by the Shire of Lake Grace.

1. DEFINITIONS

The following definitions shall apply to the guidelines on the ban of vehicle and machinery movement and the operation of internal combustion engines under Regulation 38A and 38B of the Bush Fires Act—

Laneway/Roadway (non gazetted)

A laneway/roadway is defined as having a trafficable surface, free of all inflammable material, a minimum of four metres wide. Overhanging vegetation has to be pruned back as to not come into contact with parts of a vehicle.

Registered On and Off Loading Area

A registered On and Off Loading area is defined as an area free of inflammable material, save live standing trees to a radius of 50 metres from the centre of the area—application forms are available from the Shire Office.

Mobile Fire Fighting Unit

A mobile fire fighting unit is defined as having a minimum water carrying capacity of four hundred (400) litres, fitted with a minimum of twenty (20) metres of nineteen (19) millimetre diameter fire fighting hoses and pump capacity of delivering water through an adjustable nozzle in the spray and jet configurations.

Harvest Ban

A ban on the operation of all grain harvesting machines within the Shire of part of the Shire and during a time, as specified in a notice or broadcast (Reg 38A).

<u>A Ban on the Movement of all Vehicles and Machinery and the Operation of Internal Combustion</u> <u>Engines</u>

A ban on the movement of all vehicles and machinery and the operation of internal combustion engines within the Shire or part of the Shire and during a time as specified in a notice or broadcast (Reg 38A & 38B) with the exception of the movement of vehicles and machinery on constructed and gazetted roads and laneways.

2. PERMITTED ACTIVITIES

The following activities are permitted provided these comply with specified conditions—

- 1. Loading and off-loading of grain, fertilizer and feed is only permitted on sites which are approved and registered by Council on an annual basis and which are clear of all inflammable material save live standing trees to a radius of at least 50 metres. A mobile fire-fighting unit shall be in attendance at all time the site is in use during the ban period.
- 2. Water carting for stock and domestic purposes provided it is accompanied by a mobile fire-fighting unit or, alternatively, the water carting vehicle acts as the mobile fire-fighting unit and meets minimum specifications (this also requires the retention of 400 litres of water at all times).

- 3. All necessary travel to and from and within piggeries, sheep or cattle feed lots, provided this is undertaken with a mobile fire-fighting unit in attendance.
- 4. All necessary carting of livestock, provided that such a vehicle is accompanied by a mobile fire-fighting unit.
- 5. Activities which received specific exemptions from Council or a Chief Bush Fire Control Officer.

3. CHRISTMAS DAY

A Harvest Ban and a ban on the movement of all vehicles and machines and the operation of internal and combustion engines is imposed on Christmas Day each year.

All other activities or operations may only be undertaken during Total Vehicle and Machinery Movement Bans and Bans on the Operation of Internal Combustion Engines after approval has been granted by Council. Approval has to be sought on an individual basis. Approval may be subject to specified conditions. It should be noted that approval may not be granted.

FIREBREAK NOTICE

Shire of Manjimup

Notice to all Land Owners and Occupiers within the Shire of Manjimup

Pursuant to the powers contained in Section 33 of the above Act, you are hereby required on or before the 11th December 2002 (Zone 8) and 18th December 2002 (Zone 6) to plough, scarify, cultivate, or otherwise clear and thereafter maintain free from all flammable material until 26th April 2003, firebreaks in accordance with the following—

1. TOWNSITES

- (a) Remove all flammable material from the whole of the property.
- or
- (b) All flammable material mowed and maintained at a level not exceeding 100mm throughout the season.

(c) Clear the whole of the land of inflammable material if fuel storage/haysheds are on land.

2. PLANTATIONS

- (a) Construct a trafficable firebreak no less than 6 metres wide around and inside the boundaries of all plantations: AND
- (b) Construct a trafficable firebreak not less than 6 metres wide within the plantation so as to divide the plantation into compartments not exceeding 28 hectares each: AND
- (c) Maintain all firebreaks in a trafficable condition and trees on both sides of the firebreaks are to be pruned to a minimum height of 5 metres to allow for unrestricted access to all maintenance and fire-fighting vehicles so as to maintain an effective width of firebreak.
- (d) Construct a 3 metre firebreak within 20 metres of any dwelling and / or outbuilding.

(e) Construct a 6 metre firebreak immediately adjacent to any fuel storage and / or haysheds. 3. RURAL

(a) ABUTTING A RESIDENTIAL ZONE

Where rural land, whether bushland or pastured, abuts a residential zone boundary, then a 3 metre firebreak shall be constructed along the common boundary of the residential zone.

(b) BUSHLAND

Where bushland exceeds more than 1 hectare and abuts a boundary a trafficable firebreak not less than 3 metres must be constructed along the boundary and within 15 metres of that boundary.

- (c) COURSE GRAIN CROPS
 - (1) Shall have a 3 metre firebreak around the perimeter of the crop and are to remain in place until the crop is harvested: AND
 - (2) During the harvesting of the crop, shall have an operational fire-fighting unit of not less than 600 litres located within the paddock being harvested.
- (d) Construct a 3 metre firebreak within 20 metres of any dwelling and / or out building.
- (e) Construct a 6 metre firebreak immediately adjacent to any fuel storage and / or haysheds.
- 4. SPECIAL RURAL BUSHLAND
 - (a) Trafficable firebreaks clear of all inflammable material and not less than 3 metres wide shall be constructed immediately inside the external boundary of all land and maintained throughout the season.
 - (b) Litter on your property must not exceed the depths as shown below. Depths are averaged over entire forested area—

(Karri) Litter depths not to exceed 30mm.

(Jarrah) Litter depth not to exceed 20mm.

(Jarrah, Marri and Karri) Litter depth not to exceed 30mm.

(Litter sampling and fuel calculation should be as approved by FESA procedures).

- (c) Removal of all flammable material within 20 metres of any dwelling and / or out building.
- (d) Construct a 6 metre firebreak immediately adjacent to any fuel storage and / or haysheds.

5. SPECIAL RURAL / PASTURED / GRASSED

- (a) All flammable material mowed and maintained at a level not exceeding 100mm throughout the season.
- (b) Removal of all flammable material within 20 metres of any dwelling and / or outbuilding.
- (c) Construct a 6 metre firebreak immediately adjacent to any fuel storage and / or haysheds.6. SPECIAL RESIDENTIAL BUSHLAND
 - (a) Where strategic firebreaks are located on your land, they must be maintained in accordance with this notice.
 - (b) In accordance with any conditions relating to "Special Residential" within the current Town Planning Scheme, for the Shire of Manjimup and any amendments. OR
 - (c) If no conditions are listed in the Town Planning Scheme, then the provisions for categories 4 and 5 apply.
 - (d) Removal of all flammable material within 20 metres of any dwelling and / or outbuilding.
 - (e) Construct a 6 metre firebreak immediately adjacent to any fuel storage and / or haysheds.

For the purpose of this notice FLAMMABLE MATERIAL does not include live standing trees, or shrubs and cultivated plants located in gardens.

DEFINITIONS


