FISH TRAPS PROHIBITION AMENDMENT ORDER 2002

Order No. 10 of 2002

FD 1620/98 [496]

Made by the Minister under section 43.

Citation

1. This order may be cited as the Fish Traps Prohibition Amendment Order 2002.

Prohibition on fishing

2. The amendments in this order are to the Fish Traps Prohibition Notice 1994*.

Clause 2 amended

- 3. Clause 2 is amended as follows:
 - (a) by deleting the item commencing "licensed fishing boat";
 - (b) by inserting the following definitions in the appropriate alphabetical positions—
 - " "licensed fishing boat" has the meaning provided for in the regulations;
 - "regulations" means the Fish Resources Management Regulations 1995;
 - "rock lobster" means the fish of that common name described by the scientific classification opposite that name in Column 2 of Schedule 7 of the regulations;
 - "snow crab" means the fish of that common name described by the scientific classification opposite that name in Column 2 of Schedule 7 of the regulations.".

Clause 3 amended

- 4. Clause 3 is amended as follows:
 - (a) by inserting before "This" the subclause designation (1);
 - (b) by inserting the following subclauses—
 - "(2) The prohibition in clause 4 does not apply to
 - (a) a person who is the holder of a recreational fishing licence that authorises fishing for rock lobster; or
 - (b) a person who is the holder of a rock lobster pot licence granted under the regulations who is fishing in accordance with that licence.
 - (3) Subclauses (1) and (2) do not apply to the taking of snow crabs on or before 30 September 2003 from the waters specified in Schedule 2.".

Schedule deleted and Schedules 1 and 2 inserted

5. The Schedule is deleted and the following Schedules are inserted instead —

Schedule 1

All waters of -

- (a) the Indian and Southern Oceans;
- (b) the Timor Sea; and
- (c) any estuary, inlet, river, brook or stream.

Schedule 2

All waters situated on the south coast of the State bounded by a line commencing at the intersection of the high water mark and 115° 8' east longitude (Cape Leeuwin) extending south to the intersection of 115° 8' east longitude and 34° 24' south latitude, thence west along 34° 24' south latitude to the outer limit of the Australian Fishing Zone, thence generally southerly and easterly along that boundary to its intersection with 129° east longitude, thence due North to the highwater mark on the mainland, thence along the high water mark to the commencing point. ".



It is hereby notified for public information, in accordance with Section 7 of the Town Planning and Development Act, 1928 (as amended) that the Hon Minister for Planning and Infrastructure approved the Shire of Manjimup Town Planning Scheme Amendment on 25 September 2002 for the purpose of:

- 1. Inserting in the list of zones in the Scheme Text under clause 3.1 the following: "14. Cluster Farm"
- 2. Introducing a new column into Table No 1 headed "Cluster Farm" and in that column inserting the words "Permitted Uses and Conditions of Use restricted to those listed in Appendix 6"
- 3. Inserting a new clause 5.2.13 as follows:
 - 5.2.13 Cluster Farm:
 - 1. Objective:

Council's objective is to provide opportunities for limited residential/tourism cluster development in designated rural areas to be integrated with, and directly linked to, intensive agricultural/horticultural land uses. Such "Cluster Farm" development must ensure both the

primacy of intensive agricultural/horticultural land uses and the preservation and protection of existing environmental and landscape values on the subject land.

2 Intent:

It is the intent of Council to:

- Ensure that any proposal for Cluster Farm rezoning facilitates:
 - o intensive agriculture/horticulture being the pre-eminent land use;
 - o residential/tourism component(s) as integrated land uses;
 - o due regard being given to environmental, landscape and community issues and/or concerns;
- Require that the commonly owned or managed portion of any Cluster Farm is of a suitable size and situation to be capable of an intensive agricultural/horticultural enterprise appropriate to the local conditions;
- Ensure that proposals for common ownership or management of properties are adequately supported by appropriate and enforceable contractual obligations.

3. Criteria for site selection:

Council will only support a Cluster Farm proposal where that proposal:

- (i) Promotes intensive agricultural/horticultural land uses, especially on prime agricultural/horticultural land;
- (ii) Demonstrates to the satisfaction of Council that intensive agricultural/horticultural production is to be a primary element of the project on a continuing basis;
- (iii) Is proved to be capable of sustaining the proposed agricultural/horticultural, and residential/tourism, components of the development in terms of land capability and an assured water supply;
- (iv) Is situated within 10 kilometres of the main townsites of Manjimup and Pemberton, so as to provide prospective residents of (and visitors to) the Cluster Farm development convenient local access to public health, education, child minding and other community facilities, shopping precincts, and a reasonable range of other goods and services;
- (v) Demonstrates that the site can be appropriately serviced to meet the requirements of the residential/tourism and agricultural/horticultural components in relation to the provision of access, water, power, wastewater disposal, fire control and communal facilities, whilst ensuring environmental and landscape values are maintained. (Proposals that rely on connection to existing remote services are unlikely to be sustainable or comply with other criteria);
- (vi) Incorporates a Lot area of not less than 60ha in order to:
 - o ensure that the property is of sufficient area to enable an economically viable, and productively sustainable, level of agricultural/horticultural land use being established;
 - o allow adequate capacity within the property for the residential/tourism component(s) being buffered from adjoining or surrounding agricultural/horticultural development;
- (vii) Contains a residential lot component not exceeding a ratio of one residential lot for every 2ha of land developed for perennial intensive agricultural/horticultural purposes;
- (viii) Limits the number of residential lots to a maximum of twenty (20). This maximum number of lots shall only be achieved after demonstrating:
 - o that appropriate levels of land capability and crop sustainability occur (or are likely to occur) on the subject property for the proposed intensive agricultural/horticultural land uses:
 - o compliance with all other criteria;
- (ix) Contains a total residential/tourist lot component not exceeding 10% total property area. Residential lots are to have a minimum area of 2000m²;
- (x) Shows that the property is capable of absorbing changes to its existing rural character and landscape through the sensitive positioning of buildings on the site and appropriate landscaping techniques;
- (xi) Demonstrates that the property is capable of sustaining both residential/tourism and agricultural/horticultural land use components without detrimental impacts on the natural and rural environments;
- (xii) Is capable of accommodating fire protection measures and facilities in accordance with Council's specific requirements.
- (xiii) Promotes a Tourism land use component that will be:
 - o low key in nature and limited in scale;
 - o ancillary to proposed agricultural/horticultural production; and,
 - o consistent with the requirements and opportunities identified in the Shire of Manjimup Rural Strategy;
- (xvi) Shows Strata Title Lots forming an integral part of the overall management of the property;
- (xvii) Shows residential lots as being integrated on Strata Titles with agricultural/horticultural components of the Cluster Farm. Any residential lots separated from the agricultural/horticultural component land uses on the property will not be supported.

4. Rezoning

Prior to rezoning, Council will require the submission and endorsement of an overall Development Guide Plan, and supporting documentation, addressing the following matters to Council's satisfaction:

- Residential lot sizes:
- Community facilities (if relevant);
- Servicing details and anticipated land uses;
- Landform and land capability information for both the intensive agricultural/horticultural and residential/tourism components.

The land capability report shall demonstrate that the land is fit for residential/tourism development and shall include a soil and water assessment to test for contamination from past/present agricultural practices;

- Minimization of any potential landscape and environmental impacts. Proposals will be required to protect or enhance the visual or scenic character of an area, with minimal clearance of existing remnant vegetation or modification of the existing landscape. The use of extensive screen fencing, bunding or tree planting, inconsistent with the existing landscape, will not be supported;
- On-site water catchment management and the maintenance of water quality. Direct discharge of stormwater runoff into waterways will not be permitted;
- Sustainable water supply.

Any cluster farm proposal is to guarantee a sustainable water supply. This will require a local water assessment (hydrology report) demonstrating the protection and enhancement of groundwater quality within the Cluster Farm proposal and detailing any likely impacts on adjoining and downstream users.

Water conservation and water sensitive design approaches will be encouraged. The provision of dams larger than that required for water supply purposes will not be encouraged.

For properties situated in reasonable proximity to existing services, connection of the residential/tourism component(s) of the Cluster Farm to a reticulated water supply will be sought. For other properties, a range of alternative methods of water supply will be considered for approval, including the provision of individual allotment rainwater tanks and/or supplementary supplies from bores or dams;

Sustainable wastewater treatment.

Alternative methods of wastewater disposal, including package treatment, will be preferred. Where this cannot be achieved, on-site disposal may be supported by Council subject to comprehensive land capability assessment.

- Protection and management of soil quality;
- Protection, management and enhancement of biodiversity, natural habitat and remnant vegetation;
- Protection of environmental and landscape features;
- Connection of vegetation and wildlife corridors within, and between, properties;
- Buffer requirements from other agricultural/horticultural uses;
- Underground reticulated power (which will be a standard requirement);
- · Road access.

The Cluster Farm is to be serviced by seated access roads (both to and within the property) to the specification and satisfaction of Council.

Proposals that require substantial upgrading of access to the property, and or are remote from main traffic routes, might not be supported;

· Fire protection and management.

A Fire Management Plan shall address in detail such matters as:

- o emergency water supplies,
- o hydrant provision,
- o strategic fire breaks and buffers,
- $o\,$ long term fire control and management arrangements.

Proposals within high fire risk areas, or remote from emergency fire fighting services, will generally not be supported;

- Proposed property tenure, and overall management, of the Cluster Farm demonstrating the direct and perpetual link between the residential components and the intensive agricultural/horticultural component;
- · Community focus and development.

A community focus and development "theme" will be preferred. Such a focus/"theme" could be promoted through integration between the intensive agricultural/horticultural and tourist development components within the subject Cluster Farm proposal;

• Compliance with the Criteria outlined in clause 5.2.13 (3) of this Scheme.

5. Subdivision and Development

Prior to any subdivision or development of land within the Cluster Farm zone being permitted, Council will first require the submission and approval of such legal and/or other documentation as may be necessary to provide for:

- A mechanism whereby Council will be a party to (and therefore whose consent will be necessary for) any decision involving a change in either the structure or management of the Cluster Farm project or any major change in land use;
- A commitment to a continuing direct linkage between the ownership of residential lots and the balance of the Cluster Farm property;
- The satisfactory management and maintenance of the non-residential components of the Cluster Farm project;
- A suitable methodology for the resolution of any conflict arising in respect to the management of the Cluster Farm project as a whole, or because of any activity affecting the residential/tourism component(s);
- The continuing intensive agricultural/horticultural use of the subject land.
- · The ownership and management of those community facilities provided;
- The prohibition of the sale of commonly owned or managed land unless accompanied by the express consent of Council and the approval of the Western Australian Planning Commission;
- The regulation and implementation of reasonable controls over standards of residential/tourist housing in terms of both appearance and associated (ongoing) maintenance:
- The implementation of Management Plans, prepared by the proponent and endorsed by Council, to satisfactorily address existing and ongoing fire and environmental protection concerns:
- The construction and maintenance of access, drainage and all other services, along with buffer areas, and proposed landscape and environmental protection measures;
- The fact that Council and the Western Australian Planning Commission will not support the establishment of residential Strata Title allotments until such time as the proponent has fully established a minimum of 10 ha of perennial, intensive agriculture/horticulture on the subject land;
- The fact that, notwithstanding any other provision of the Scheme, Council shall not grant Development Approval for a residential dwelling on any Cluster Farm Strata Title allotment until such time as a minimum 2 ha of land (to be incorporated within each residential Strata Title allotment) has been established with perennial and intensive agriculture/horticulture.
- 4. Introducing a new Appendix 6 to the Scheme Text, together with various provisions as follows:

Appendix 6

(Clause 5.2.13 refers)

Location

Nelson Locations 10935 and 4204 Vasse Highway,

Pemberton

Special Provisions

- $1. \ The \ subject \ land \ shall \ be \ developed \ for \ an integrated \ agricultural/horticultural \ and \ residential \ cluster \ (and \ tourist \ development) \ based \ on \ a \ Survey \ Strata \ subdivision.$
- 2. Subdivision and development of the land shall generally accord with the Development Guide Plan attached to the Scheme Amendment Report (Amendment No. 85) and signed by the Chief Executive Officer.
- 3. Prior to the approval of a Survey Strata subdivision plan, the proponent shall first satisfy Council and the Western Australian Planning Commission that the following matters have been properly addressed (consistent with the need to provide for services, land use activities and management controls for the land):
- (a) Supplementary water supply details for the purposes of garden and stock watering including storage requirements, anticipated delivery systems and volume of supply per household.
- (b) Effluent disposal details particularly with respect to the type of system(s) to be used, the necessary setbacks from watercourses and water storage dams.
- (c) Road construction, and associated drainage, standards.
- (d) Building materials and design guidelines/selections for all buildings proposed.
- (e) Property management arrangements required by Council and the Western Australian Planning Commission. These management arrangements are to address the following issues (and any other issues determined to be necessary for inclusion by Council):

The establishment of:

- A "theme":
- The Strata Company;
- Input by public authorities;
- · Appropriate strata title by-laws;

- Architectural guidelines;
- · Exclusive use by-laws;
- Services to be provided by the Strata Company;
- · Dispute resolution guidelines and appropriate penalties;
- A programme of Staged Development; and
- · A Vineyard Management Plan
- 4. Proposed Lots 1 to 20 shall be developed for the purposes of viticulture (or any other agricultural/horticultural land use approved by the Council) and residential development. Residential development shall be confined to those portions of each lot designated for such purpose on the Development Guide Plan referred to in Clause No. 2.
- 5. Development of the proposed dwellings shall comply with Council's Local Planning and other Policies as Adopted from time to time in relation to building (including outbuilding) heights and areas, water supply and effluent disposal criteria etc.
- 6. Setbacks for residential development shall comply with the "R 5" density code in the Residential Planning Codes.
- 7. Each dwelling shall incorporate a roof catchment of at least $200~\text{m}^2$, and be connected to a water storage tank with a minimum capacity of 92,000~litres, to the satisfaction of the Health Department of Western Australia.
- 8. All dwellings, ancillary buildings and water tanks shall be constructed of non-reflective material.
- 9. All dwellings shall comply with AS 3959 - 1991 — "Construction of Houses in Bushfire Prone Areas".
- 10. Proposed Lot 21 shall be developed as a tourist accommodation facility, comprising a lodge, chalets and associated facilities. This development shall be subject to Council approval as an "AA" Use under the Scheme. Matters to be satisfactorily addressed by the proponent for Lot 21, prior to Council issuing any development approval, shall include:
- Effluent disposal and water supply;
- · Building design and materials;
- · Visual impact and any remedial action proposed in this regard;
- Fire management plans;
- · Access and servicing details;
- Landscaping

Council shall not approve any development application unless the required on-site effluent disposal capacity has been proven to the satisfaction of Council and the Health Department of Western Australia.

11. Proposed Lot 22 shall be developed for a Café/Gallery, and for Recreational Fishing, with ancillary facilities. Such development shall be subject to prior approval as an "AA" Use under the Scheme. Matters to be considered by Council shall be the same as those outlined in preceding Clause No. 10.

Council shall not approve any development application unless the required on-site effluent disposal capacity has been proven to the satisfaction of Council and the Health Department of Western Australia.

- 12. Lot 23 on the Development Guide Plan shall be developed for access, water supply and winery purposes subject to Council approval.
- 13. All buildings shall be setback a minimum of 100 metres from the adjoining State Forest and 50 metres from any existing water bodies (unless it can be demonstrated by the proponent that a lesser distance will not compromise fire protection requirements or water quality).
- 14. Dams shall only be permitted on common property.
- 15. A Fire Management Plan (FMP) shall be prepared by the proponent in consultation with Council, the Department of Conservation and Land Management and the Western Australian Bushfires Board. This FMP shall require endorsement by Council prior to the lodgement of any application for Survey Strata subdivision or development. Full implementation of the FMP shall be required prior to any development commencing.
- 16. Perimeter fencing of the Strata Title allotments will not be permitted. Any fencing to be installed shall be limited to the immediate curtilages of the proposed residences.
- 17. A detailed site revegetation programme shall be submitted to Council and require endorsement prior to the lodgement of any application for Survey Strata subdivision or development. The revegetation programme shall document planting locations, species, and the ongoing management of the revegetation, so as to minimise any undesirable visual impacts of proposed dwellings from Vasse Highway.

18. The proponent implementing a statutory mechanism to the satisfaction of the Council limiting or restricting domestic animals to prevent impact on the adjacent State Forest.
