CITY OF COCKBURN (LOCAL GOVERNMENT ACT) LOCAL LAWS 2000

Pursuant to its power under the *Local Government Act 1995* the City of Cockburn hereby records having resolved on the 15th October 2002 to make the following amendments to the *City of Cockburn (Local Government Act) Local Laws 2000.*

Part II—ANIMALS

- 1. In section 2.50 add the following subsection after subsection (2)-
 - "(3) The Principal Environmental Health Officer may permit the keeping of more than 150 pigeons on land in a rural zone or resource zone provided—
 - (a) The keeping of pigeons is for a special event.
 - (b) Any one approval shall be for a period not exceeding 12 months.
 - (c) Adjoining land owners shall be consulted in accordance with section 2.47 prior to approval being granted.
 - (d) The Principal Environmental Health Officer may set any conditions he/she deems necessary."

PROPOSAL

The Metropolitan Region Scheme text is proposed to be amended pursuant to Section 33A of the Metropolitan Region Town Planning Scheme Act, to enable approval to be granted after a development has been completed and may avoid the need for enforcement action to be taken. This will be consistent with provisions in the Model Scheme Text.

DESCRIPTION

Amendment to the Metropolitan Region Scheme text by inserting the following additional clauses after clause 30(4)—

- (5) The Commission may grant its approval under subclause (1) for development already commenced or carried out.
- (6) Subclause (5) does not affect the operation of—
 - (a) clauses 10, 13 and 18 in respect of development for which approval has not been granted or in respect of development carried out prior to the grant of approval; or
 - (b) sections 42, 43 and 43A of the Scheme Act in respect of development for which approval has not been granted.

- (7) Development which was unlawfully commenced is not rendered lawful by the occurrence of any subsequent event except the granting of approval under the subclause (1) for the development.
- (8) The continuation of development unlawfully commenced is taken to be lawful upon the grant of approval for development."

It is hereby notified for public information, in accordance with Section 7 of the Town Planning and Development Act, 1928 (as amended) that the Hon Minister for Planning and Infrastructure approved the City of Belmont Town Planning Scheme Amendment on 30 October 2002 for the purpose of—

- 1. Adding to the end of the first sentence of subclause 10.6.1 the words "and the Redcliffe Industrial area".
- 2. Adding a new subclause 10.6.7 as follows-

10.6.7 Subdivision of land in the Kewdale Industrial Estate

When considering applications for the subdivision of land in the Kewdale Industrial Estate the Council shall have regard to the provisions of any Local Planning Policy and the objectives which the policy is designed to achieve. Where reticulated sewerage is available the Council will support the creation of lots less than 4000sqm in area provided—

- (a) no lot is less than 2000sqm in area with a minimum frontage of 25 metres;
- (b) an overall plan of subdivision is prepared in order to demonstrate the subdivision potential of the superlot in which the subdivision is to take place;
- (c) no lot is permitted direct access to a regional road;
- (d) vehicular cross easements are granted in appropriate circumstances as determined by the Council; and


