PILBARA FISH TRAWL FISHERY (INTERIM) MANAGEMENT PLAN AMENDMENT 2002 FD 2234/99[510]

Citation

1. This instrument may be cited as the Pilbara Fish Trawl Fishery (Interim) Management Plan Amendment 2002.

Commencement

2. This instrument will commence operation on 31 December 2002.

Management plan amended

3. The amendments in this instrument are to the Pilbara Fish Trawl Interim Managed Fishery Management Plan 1997*.

Clause 3 amended

- 4. Clause 3 is amended by deleting "31 December 2002" and substituting the following

 - (b) in the definition of "unauthorised area of the Fishery" by deleting "that" where it first appears.

- 6. Clause 16 is deleted and the following clause is inserted instead
 - " Duration of permits
 - 16. A permit expires at the end of the licensing period for which it was issued. ".

Clause 18 amended

- 7. Clause 18 is amended by deleting "(h) any conditions imposed on the permit." and inserting instead $\,$
 - " (l) any conditions imposed on the permit. ".

Clause 19 amended

8. Clause 19 is amended in subclause (8) by deleting "subclause (5)" and inserting instead — " subclause (7)".

Clause 20 amended

- 9. Clause 20 is amended by deleting subclause (1) and inserting instead
 - " (1) During the period 1 January 2003 to 30 June 2003 the extent of the entitlement arising from a fish trawl unit in
 - (a) Area 1 is 0.28 fish trawl hours, which entitles the holder of a permit that specifies Area 1 fish trawl units to use a fish trawl net for 0.28 hours in that Area for each one of those Area 1 units:
 - (b) Area 2 is 0.57 fish trawl hours, which entitles the holder of a permit that specifies Area 2 fish trawl units to use a fish trawl net for 0.57 hours in that Area for each one of those Area 2 units;
 - (c) Area 4 is 0.53 fish trawl hours, which entitles the holder of a permit that specifies Area 4 fish trawl units to use a fish trawl net for 0.53 hours in that Area for each one of those Area 4 units;
 - (d) Area 5 is 0.41 fish trawl hours, which entitles the holder of a permit that specifies Area 5 fish trawl units to use a fish trawl net for 0.41 hours in that Area for each one of those Area 5 units:
 - (e) Area 6 is 0.50 fish trawl hours, which entitles the holder of a permit that specifies Area 6 fish trawl units to use a fish trawl net for 0.50 hours in that Area for each one of those Area 6 units
 - (1a) At any time other than during the period referred to in (1) the extent of the entitlement arising from a fish trawl unit in -
 - (a) Area 1 is 0.56 fish trawl hours, which entitles the holder of a permit that specifies Area 1 fish trawl units to use a fish trawl net for 0.56 hours in that Area for each one of those Area 1 units:
 - (b) Area 2 is 1.13 fish trawl hours, which entitles the holder of a permit that specifies Area 2 fish trawl units to use a fish trawl net for 1.13 hours in that Area for each one of those Area 2 units;
 - (c) Area 4 is 1.05 fish trawl hours, which entitles the holder of a permit that specifies Area 4 fish trawl units to use a fish trawl net for 1.05 hours in that Area for each one of those Area 4 units;
 - (d) Area 5 is 0.81 fish trawl hours, which entitles the holder of a permit that specifies Area 5 fish trawl units to use a fish trawl net for 0.81 hours in that Area for each one of those Area 5 units:
 - (e) Area 6 is 1.00 fish trawl hour, which entitles the holder of a permit that specifies Area 6 fish trawl units to use a fish trawl net for 1.00 hour in that Area for each one of those Area 6 units. ".

 - (a) deleting "1(c) in any calendar year" and inserting instead
 - " (1)(c) in any licensing period"; and

Payment by Instalments

From 1 July 2003 —

- (a) the first instalment is 25% of the total fee and is due for payment on or before 1 July of the year for which the permit is to be granted or renewed;
- (b) the second instalment is 25% of the total fee and is due for payment on or before 1 October immediately following the period specified in paragraph (a);
- (c) the third instalment is the total fee less the instalments provided for in paragraphs (a) and (b) and is due for payment on or before 1 January immediately following the period specified in paragraph (a). ".
