 ${\it Districts~of~Bayswater~and~Stirling} \\ ({\it Change~of~District~Boundaries})~{\it Order~2003}$

Made by the Governor in Executive Council.

1 Citation

This Order may be cited as the Districts of Bayswater and Stirling (Change of District Boundaries) Order 2003.

2. Commencement

This Order shall take effect from the date of publication in the Government Gazette.

3. Boundary changes—district of Stirling (s. 2.1 (1) (b) of the Act)

- (1) The boundaries of the district of Stirling are changed by including within the district the portions of land described in Schedule 1.
- (2) The boundaries of the Inglewood Ward in the district of Stirling are changed by including within the area of the ward the portions of land described in Schedule 1.

4. Boundary changes—district of Bayswater (s. 2.1 (1) (b) of the Act)

- (1) The boundaries of the district of Bayswater are changed by excluding from the district the portions of land described in Schedule 1.
- (2) The boundaries of the West Ward of the district of Bayswater are changed by excluding from the area of the ward the portions of land described in Schedule 1.

District of Dowerin

(CHANGE OF WARD BOUNDARIES AND REPRESENTATION) ORDER 2003

Made by the Governor in Executive Council.

1. Citation

This Order may be cited as the District of Dowerin (Change of Ward Boundaries and Representation) Order 2003.

2. Abolition of existing wards (s. 2.2 (1) (d) of the Act)

On the first ordinary elections day after the commencement of this order, the Daren Ward, Hindmarsh Ward, Koombekine Ward, Manmanning Ward, Minnivale Ward and Ucarty Ward in the district of Dowerin are abolished.

3. New wards created (s. 2.2 (1) (c) of the Act)

- (1) On and after the first ordinary elections day after the commencement of this order, the Rural North Ward in the district of Dowerin consists of the land described in Schedule 1.
- (2) On and after the first ordinary elections day after the commencement of this order, the Rural South Ward in the district of Dowerin consists of the land described in Schedule 2.

4. Number of councillors for new wards (s. 2.18 (3) of the Act)

On and after the first ordinary elections day after the commencement of this order—

- (1) the number of offices of councillor for the Rural North Ward in the district of Dowerin is two (2); and
- (2) the number of offices of councillor for the Rural South Ward in the district of Dowerin is two (2).

5. Number of councillors changed (s. 2.18 (3) of the Act)

On and after the first ordinary elections day after the commencement of this order the number of offices of councillor for the Town Ward in the district of Dowerin is four (4) instead of two (2).

6. Declaration of vacant offices (s 2.35 and 9.62 of the Act)

All offices of member of the council for the Daren Ward, Hindmarsh Ward, Koombekine Ward, Manmanning Ward, Minnivale Ward and Ucarty Ward of the Shire of Dowerin become vacant immediately before the first ordinary elections day after the commencement of this order.

7. Election to fill vacancies (s. 4.11 and 9.62 of the Act)

- (1) An election is to be held to fill the offices that become vacant under clauses 4 and 5.
- (2) Any poll needed for an election to fill the offices is to be held on the first ordinary elections day after the commencement of this order.
- (3) Part 4 of the Act applies to preparing for and conducting the election as if the amendments effected by clauses 2, 3, 4 and 5 had taken effect on the day on which this order commenced.
- (4) For the purposes of subclause (3)—
 - (a) Part 4 of the Act is modified to the extent necessary to give effect to subclauses (1), (2) and (3); and
 - (b) without limiting paragraph (a), a reference in Part 4 of the Act to a ward, in relation to the district of Dowerin, is to be read as a reference to the Rural North Ward, Rural South Ward and Town Ward of the district as the respective ward is or will be, as a result of the operation of clauses 3, 4 and 5, on and after the first ordinary elections day after the commencement of this order.

Rural North Ward

All that land which has previously comprised the Manmanning, Koombekine and Minnivale Wards in the district of Dowerin.

Made by the Governor in Executive Council.

1. Citation

This Order may be cited as the District of Katanning (Change of Number of Councillors) Order 2003.

2. Number of councillors changed (s. 2.18(3) of the Act)

On and after the first ordinary elections day after the commencement of this order the number of offices of councillor on the council of the Shire of Katanning is nine (9) instead of eleven (11).

3. Transitional directions (s. 9.62 of the Act)

(1) The directions in this clause are made in order to give effect to clause 2.

- (2) Of the six (6) offices of councillor on the council of the Shire of Katanning that become vacant on the day of the ordinary elections held in 2003, two (2) cease to exist on so becoming vacant.
- (3) The remaining four (4) offices of councillor on the council of the Shire of Katanning continue in existence on and after the day of the ordinary elections held in 2003.
- (4) Part 4 of the Act, with any necessary changes, applies to preparing for and conducting the ordinary elections in 2003 as if the changes effected by clauses 2 and 3 had taken effect on the day this order commenced.

LOCAL GOVERNMENT ACT 1995

District of Manjimup

(CHANGE OF WARD BOUNDARIES AND NUMBER OF COUNCILLORS) ORDER 2003

Made by the Governor in Executive Council.

1. Citation

This Order may be cited as the District of Manjimup (Change of Ward Boundaries and Number of Councillors) Order 2003.

2. Abolition of existing ward (s. 2.2 (1) (d) of the Act)

On the first ordinary elections day after the commencement of this order, the Warren Ward in the district of Manjimup is abolished.

3. Change of ward names (s. 2.3 (3) of the Act)

- (1) On and after the first ordinary elections day after the commencement of this order, the name of the Manjimup Ward in the district of Manjimup is changed so that on and after that day the ward is called Central Ward.
- (2) On and after the first ordinary elections day after the commencement of this order, the name of the Pemberton Ward in the district of Manjimup is changed so that on and after that day the ward is called West Ward
- (3) On and after the first ordinary elections day after the commencement of this order, the name of the Northcliffe Ward in the district of Manjimup is changed so that on and after that day the ward is called Coastal Ward.
- (4) On and after the first ordinary elections day after the commencement of this order, the name of the Perup Ward in the district of Manjimup is changed so that on and after that day the ward is called East Ward.
- (5) On and after the first ordinary elections day after the commencement of this order, the name of the Walpole Ward in the district of Manjimup is changed so that on and after that day the ward is called South Ward.

4. Redescription of ward boundaries (s. 2.2 (1) (c) of the Act)

- (1) On and after the first ordinary elections day after the commencement of this order, the Central Ward in the district of Manjimup consists of the land described in Schedule 1.
- (2) On and after the first ordinary elections day after the commencement of this order, the North Ward in the district of Manjimup consists of the land described in Schedule 2.
- (3) On and after the first ordinary elections day after the commencement of this order, the Coastal Ward in the district of Manjimup consists of the land described in Schedule 3.
- (4) On and after the first ordinary elections day after the commencement of this order, the West Ward in the district of Manjimup consists of the land described in Schedule 4.
- (5) On and after the first ordinary elections day after the commencement of this order, the East Ward in the district of Manjimup consists of the land described in Schedule 5.
- (6) On and after the first ordinary elections day after the commencement of this order, the South Ward in the district of Manjimup consists of the land described in Schedule 6.

5. Number of councillors changed (s. 2.18 (3) of the Act)

On and after the first ordinary elections day after the commencement of this order—

- (1) The number of offices of councillor for the Council in the district of Manjimup is eleven (11) instead of thirteen (13).
- (2) The number of offices of councillor for the Coastal Ward in the district of Manjimup is one (1) instead of two (2).

6. Election to fill vacancies (s. 4.11 and 9.62 of the Act)

(1) Any poll needed for an election to fill the offices is to be held on the first ordinary elections day after the commencement of this order.

- (2) Part 4 of the Act applies to preparing for and conducting the election as if the amendments effected by clauses 2, 3, 4 and 5 had taken effect on the day on which this order commenced.
- (3) For the purposes of subclause (2)—
 - (a) Part 4 of the Act is modified to the extent necessary to give effect to subclauses (2) and (3); and
 - (b) without limiting paragraph (a), a reference in Part 4 of the Act to a ward, in relation to the district of Manjimup, is to be read as a reference to the Central Ward, North Ward, Coastal Ward, West Ward, East Ward and South Ward of the district as the respective ward is or will be, as a result of the operation of clauses 2 and 3 on and after the first ordinary elections day after the commencement of this order.

All that portion of land bounded by lines starting from the intersection of the centreline of Balbarrup Road with the centreline of Perup Road and extending generally southwesterly along the centreline of Perup Road to the prolongation southerly of the centreline of Golf Links Road; thence northerly along that centreline to the prolongation easterly of the southern boundary of Lot 433, as shown on Deposited Plan 125789; thence westerly to and westerly and northerly along boundaries of that lot to the southeastern corner of Lot 10, as shown on Office of Titles Diagram 61215; thence westerly to and westerly and southerly along boundaries of that lot to the northwestern corner of the northwestern severance of Nelson Location 7367 (Reserve 16355); thence southerly along the western boundary of that severance and onwards to the northwestern corner of a western severance of Location 7367 (Reserve 16355); thence southerly along the western boundary of that severance and onwards to the northern corner of a western severance of Location 7367 (Reserve 16355); thence southerly along the western boundary of that severance and onwards to the northwestern corner of Location 12821 (Reserve 31254); thence southerly along the western boundary of that location to the northwestern corner of the southwestern severance of Location 7367 (Reserve 16355); thence southerly and easterly along boundaries of that severance and onwards to the centreline of Bottomley Road; thence southerly, southeasterly and again southerly along that centreline and onwards to the centreline of Seven Day Road; thence generally northeasterly along that centreline to the prolongation northerly of the western boundary of Lot 23, as shown on Office of Titles Plan 20785; thence southerly to and along that boundary and southerly along the western boundary of Lot 22 and onwards to the northwestern corner of Lot 21; thence southerly along the western boundary of that lot and southerly and easterly along boundaries of Lot 20 to the southwestern corner of lot 19; thence easterly along the southern boundaries of that lot and Lot 18 and onwards to the centreline of Bella Vista Road; thence southerly along that centreline to the prolongation westerly of the northern boundary of the northwestern severance of Lot 5211, as shown on Deposited Plan 136269; thence easterly to and along that boundary and onwards to the northernmost northwestern corner of the eastern severance of Lot 5211; thence easterly along the northernmost northern boundary of that severance to the western boundary of Lot 2, as shown on Office of Titles Diagram 24818; thence northerly along that boundary and the western boundary of Manjimup Lot 699 and onwards to the centreline of Starkies Road; thence generally southeasterly along that centreline and onwards to a northwestern boundary of Lot 2377, as shown on Deposited Plan 125834; thence northeasterly along that boundary and generally northeasterly and generally northerly along boundaries of Lot 2373, as shown on Deposited Plan 125833, and onwards to a southwestern boundary of Lot 2034, as shown on Deposited Plan 123991; thence generally easterly and northerly along boundaries of that lot and northerly along the eastern boundary of Lot 1921, as shown on Deposited Plan 123990, and onwards to the centreline of Muirs Highway; thence easterly along that centreline to the prolongation northerly of the western boundary of Lot 6775, as shown on Deposited Plan 82473; thence southerly to and southerly, easterly and northerly along boundaries of that lot and onwards to the centreline of Muirs Highway; thence easterly and generally southeasterly along that centreline to the prolongation northeasterly of the northwestern boundary of Lot 6777, as shown on Deposited Plan 82475; thence southwesterly to and southwesterly and southeasterly along boundaries of that lot and onwards to the centreline of Muirs Highway; thence generally southeasterly and generally easterly along that centreline to the prolongation southerly of the centreline of Balbarrup Road and thence northerly to and generally northerly along that centreline to the starting point.

thence westerly to and westerly along that boundary and again westerly along the southern boundaries of Lot 1, as shown on Office of Titles Diagram 17593, Lot 5, as shown on Office of Titles Diagram 53203 and Lot 3, as shown on Office of Titles Diagram 20499 and onwards to the centreline of Graphite Road; thence generally northwesterly and generally southwesterly along that centreline to the prolongation northeasterly of the centreline Hind Road; thence southwesterly to and generally southwesterly along that centreline to the prolongation easterly of the northern boundary of the western severance of Lot 5840 (Reserve 16919), as shown on Deposited Plan 225714; thence westerly to and westerly and southerly along boundaries of that lot to the northwestern corner of the northwestern severance of Location 7367 (Reserve 16355); thence southerly along the western boundary of that severance and again onwards to the northwestern corner of a western severance of Location 7367 (Reserve 16355); thence southerly along the western boundary of that severance and again onwards to the northern corner of a western severance of Location 7367 (Reserve 16355); thence southerly along the western boundary of that severance and onwards to the northwestern corner of Location 12821 (Reserve 31254); thence southerly along the western boundary of that location to the northwestern corner of the southwestern severance of Location 7367 (Reserve 16355); thence southerly and easterly along boundaries of that severance and onwards to the centreline of Bottomley Road; thence southerly, southeasterly and again southerly along that centreline and onwards to the centreline of Seven Day Road; thence generally northeasterly along that centreline to the prolongation northerly of the western boundary of Lot 23, as shown on Office of Titles Plan 20785; thence southerly to and along that boundary and southerly along the western boundary of Lot 22 and onwards to the northwestern corner of Lot 21; thence southerly along the western boundary of that lot and southerly and easterly along boundaries of Lot 20 to the southwestern corner of lot 19; thence easterly along the southern boundaries of that lot and Lot 18 and onwards to the centreline of Bella Vista Road; thence southerly along that centreline and onwards to the centreline of South Western Highway: thence generally southwesterly and generally southeasterly along that centreline to the prolongation northeasterly of centreline of Eastbourne Road; thence southwesterly to and generally southwesterly along that centreline to the prolongation northeasterly of centreline of Farrs Road; thence southwesterly to and generally southwesterly along that centreline and onwards to the centreline of Smiths Road; thence generally westerly and generally northwesterly along that centreline and onwards to the centreline of Channybearup Road; thence generally westerly and generally southwesterly along that centreline to the prolongation southeasterly of the northeastern boundary of Lot 11958, as shown on Deposited Plan 205560; thence northwesterly to and along that boundary and northwesterly along the northeastern boundary of Lot 10108, as shown on Deposited Plan 203880, and onwards to the southern boundary of Lot 452, as shown on Deposited Plan 138085; thence westerly along that boundary to the southernmost southeastern corner of Lot 5283; thence westerly, northerly and generally northeasterly along boundaries of that lot to the southern boundary of Location 5282 (State Forest Number 36); thence westerly, generally northerly and generally northeasterly along boundaries of that location to the prolongation southerly of the eastern boundary of Location 6283 (State Forest Number 36); thence northerly to and northerly and westerly along boundaries of that location and onwards to an eastern boundary of Location 6281 (State Forest Number 36); thence northerly, northeasterly, generally northwesterly and generally westerly along boundaries of that location and onwards to the right bank of the Donnelly River: thence generally southwesterly, generally northwesterly and again generally southwesterly downwards along that bank to the prolongation southerly of the western boundary of Location 6165, a point on a present western boundary of the Shire of Manjimup, and thence generally northerly, generally northeasterly, generally easterly and generally southeasterly along boundaries of that Shire to the starting point.

SCHEDULE 3

Coastal Ward

All that portion of land bounded by lines starting from the intersection of the Low Water Mark of the Southern Ocean with a line extending west from the southernmost corner of Nelson Location 7680 (Reserve 36996), a point on a present southwestern boundary of the Shire of Manjimup, and extending east along that line to the southernmost corner of Location 7680; thence northeasterly along the southeastern boundary of that location and onwards to a southern boundary of Lot 1, as shown on Office of Titles Diagram 69587; thence westerly, northerly, easterly, again northerly, again westerly, again northerly, again generally northwesterly, again northerly, again westerly, again northerly, again westerly along boundaries of Location

District of Merredin
(ABOLITION OF WARDS) ORDER 2003

Made by the Governor in Executive Council.

1. Citation

This Order may be cited as the District of Merredin (Abolition of Wards) Order 2003.

2. Abolition of wards (s. 2.2 (1) (d) of the Act)

All the wards in the district of Merredin are abolished immediately before the first ordinary elections day held after the commencement of this order.

3. Declaration of vacant offices (s. 2.35 and 9.62 of the Act)

All the offices of member of the council of the Shire of Merredin become vacant immediately before the first ordinary elections day after the commencement of this order.

4. Election to fill vacancies (s. 4.11 and 9.62 of the Act)

- (1) An election is to be held to fill the offices that become vacant under clause 3.
- (2) Any poll needed for an election to fill the offices is to be held on the first ordinary elections day after the commencement of this order.
- (3) Part 4 of the Act applies to preparing for and conducting the election as if the clauses 2 and 3 had taken effect on the day on which this order commenced.
- (4) For the purposes of subclause (3), Part 4 of the Act is modified to the extent necessary to give effect to subclauses (1), (2) and (3).

District of Northampton

(Change of Ward Boundaries and Number of Councillors) Order $2003\,$

Made by the Governor in Executive Council.

1. Citation

This order may be cited as the District of Northampton (Change of Ward Boundaries and Number of Councillors) Order 2003.

2. Abolition of existing ward (s. 2.2 (1) (d) of the Act)

On the first ordinary elections day after the commencement of this order, the Horrocks Ward in the district of Northampton is abolished.

3. New ward created (s. 2.2 (1) (b) of the Act)

On and after the first ordinary elections day after the commencement of this order, the Coastal Ward in the district of Northampton consists of the land described in Schedule 1.

4. Redescription of ward boundaries (s. 2.2 (1) (c) of the Act)

- (1) On and after the first ordinary elections day after the commencement of this order, the Central Ward in the district of Northampton consists of the land described in Schedule 2.
- (2) On and after the first ordinary elections day after the commencement of this order, the Kalbarri Ward in the district of Northampton consists of the land described in Schedule 3.
- (3) On and after the first ordinary elections day after the commencement of this order, the North East Ward in the district of Northampton consists of the land described in Schedule 4.
- (4) On and after the first ordinary elections day after the commencement of this order, the West Ward in the district of Northampton consists of the land described in Schedule 5.
- (5) On and after the first ordinary elections day after the commencement of this order, the South East Ward in the district of Northampton consists of the land described in Schedule 6.

5. Number of councillors for new ward (s. 2.18 (3) of the Act)

On and after the first ordinary elections day after the commencement of this order, the number of offices of councillor for the Coastal Ward in the district of Northampton is one (1).

6. Number of councillors changed (s. 2.18 (3) of the Act)

On and after the first ordinary elections day after the commencement of this order—

- (1) The number of offices of councillor for the Council in the district of Northampton is 11 instead of 12
- (2) The number of offices of councillor for the South East Ward in the district of Northampton is one (1) instead of two (2).
- (3) The number of offices of councillor for the North East Ward in the district of Northampton is one (1) instead of two (2).
- (4) The number of offices of councillor for the West Ward in the district of Northampton is one (1) instead of two (2).
- (5) The number of offices of councillor for the Central Ward in the district of Northampton is three (3) instead of two (2).
- (6) The number of offices of councillor for the Kalbarri Ward in the district of Northampton is four (4) instead of three (3).

7. Election to fill vacancies (s. 4.11 and 9.62 of the Act)

- (1) Any poll needed for an election to fill the offices is to be held on the first ordinary elections day after the commencement of this order.
- (2) Part 4 of the Act applies to preparing for and conducting the election as if the amendments effected by clauses 2, 3, 4, 5 and 6 had taken effect on the day on which this order commenced.
- (3) For the purposes of subclause (2)—
 - (a) Part 4 of the Act is modified to the extent necessary to give effect to subclauses (2) and (3); and
 - (b) without limiting paragraph (a), a reference in Part 4 of the Act to a ward, in relation to the district of Northampton, is to be read as a reference to the Coastal Ward, Central Ward, Kalbarri Ward, North East Ward, West Ward and South East Ward of the district as the respective ward is or will be, as a result of the operation of clauses 2, 3, 4, 5 and 6 on and after the first ordinary elections day after the commencement of this order.
