Singh, Counsel for Dr Subramaniam the Board declares that it is satisfied that Dr Subramaniam is guilty of incompetency in respect of the performance of his duties and responsibilities as resident medical officer including—

- (a) an inability to properly and consistently record admission details and daily progress in the medical record, writing drug charts and discharge summaries; and
- (b) an inability to recognise that a clinical situation required assistance from a more senior medical staff

between February and July 2002 whilst employed at King Edward Memorial Hospital and whilst employed at the Holywood Hospital in or about October 2002.

1. The Board reprimands Dr Subramaniam.

2. The Board orders that Dr Subramaniam pay 50% of the Board's reasonable costs of the Inquiry to be paid within 30 days of receipt of an account for those costs."

The Western Australian Planning Commission and the City of Fremantle have called for submissions to amend their town planning schemes for land in the City of Fremantle.

The purpose of both amendments relate to the proposed removal of the regional road reservation for that section of the Fremantle Eastern Bypass between High Street, Fremantle and Healy Road, Hamilton Hill, and what the land should be used for if the bypass is removed.

#### Assessment of Alternatives Reports

Studies providing an assessment of the impact of the removal of the bypass were commissioned by the Western Australian Planning Commission. Technical analyses will be provided in the following documents—

- Traffic Impact Assessment
- Environmental Impact Assessment
- Social Impact Assessment
- Economic Evaluation

A Summary Report detailing the key findings of the four separate studies will also be made available.




