LOCAL LAWS RELATING TO THE PINJARRA PUBLIC CEMETERY

Under the powers conferred by the Cemeteries Act 1986 and all other powers enabling it the Shire of Murray resolved on February 27, 2003 to amend its Local Laws relating to the Pinjarra Public Cemetery that was published in the *Government Gazette* on December 30, 1999 (pages 6937–6944) by –

Repealing "clause 7.13 including subclauses (i), (ii), (iii) and (iv)" and then inserting instead —

7.13 (1) All monuments in the lawn section of the Pinjarra Cemetery shall:

- (a) be contained wholly on the concrete beam established;
- (b) be made of natural stone, unless otherwise approved by Council;
- (c) comply with the following specifications:
 - (i) the overall height of the monument above the original surface of the grave shall not exceed 300mm;

- (ii) the length of the base of the monument shall not exceed a distance of 500mm either side of the centre of grave ie. a maximum of 1m in length;
- (iii) the width of the base of the monument shall not exceed 280mm;

2) The monument shall include lead lettering or alternatively an admiralty bronze memorial plaque may be attached to the monument.

3) An admiralty bronze memorial plaque (400mm x 280mm) may be placed on each plot as an alternative to the monument.

4) A person shall not display any trade names or marks upon any monument within the lawn section of a Cemetery.

Citation

1. This order may be cited as the North West and Kimberley Recreational Netting Restrictions Amendment Order 2003.

Order amended

2. The amendments in this order are to the North West and Kimberley Recreational Netting Restrictions Notice 1995*.

Clause 3 amended

- 3. Clause 3 is amended
 - (a) by deleting the definition of "licensed fishing boat" and "set net"; and
 - (b) by inserting, in the appropriate alphabetical positions, the following definitions
 - " "haul" when describing the use of a haul net means to encircle or ring or attempt to encircle or ring a fish or school of fish with a fishing net and the operator of the net is in continual contact with the net which is continually moving so that at no time is the net stationary before being hauled onto the shore or a boat; ";

 - " "licensed fishing boat" has the same meaning as provided for in regulation 3 of the Fish Resources Management Regulations 1995; ";
 - " "set" when describing the use of a set net means to fix, anchor, stake or secure a fishing net in the water or to make a fishing net in any way stationary in the water below high water mark.".

Clause 5 amended

4. Clause 5 is amended —

- (a) in subclause (1) by inserting before "net" the following —
 " fishing "; and
- (b) by inserting after subclause (1) the following
 - (2) A person must not fish
 - (a) for a commercial purpose by means of a set net or a haul net -
 - (b) for a recreational purpose by means of a fishing net other than a haul net, in the waters described in Schedule 2. ".

Clause 6 deleted

5. Clause 6 is deleted.

Schedule 1 deleted and Schedules 1 and 2 inserted

6. Schedule 1 is deleted and the following schedules inserted instead —

Schedule 1

- All WA waters off the north west and north coast of Western Australia
 - (a) east of 123° 08.2' east longitude at all times;
 - (b) west of 123° 08.2' east longitude and north of 19° south latitude commencing on 1 December and ending on the next 31 January.

Schedule 2

All WA waters off the north west and north coast of Western Australia east of a line drawn due north from the intersection of 21° 38.36568' south latitude and 115° 07.89198' east longitude (Beadon Creek, Onslow).
