AMENDMENTS TO

ACTIVITIES ON THOROUGHFARES AND PUBLIC PLACES LOCAL LAW

That under the powers conferred by the *Local Government Act 1995* (the Act) and under all the powers enabling it, the Council of the Town of Claremont resolves on 20 May 2003 to amend the Activities on Thoroughfares and Public Places Local Law which was published in the Government Gazette on  $27^{\text{th}}$  May 2003 and to proceed with amending the Local Law in accordance with Section 3.12 of the Act as follows:

1. Delete the current clause number 3.1 (3) and replace it as set out below

"(3) A person will not contravene subclause (1) where the vehicle is left for a period not exceeding 24 hours unless that vehicle causes undue obstruction or is parked within 10 metres of a Town of Claremont "Tow Away" sign."
